Dear Col Singh,

I hope you are well.

I am writing regarding concerns raised by FEI Officials following recent Events in Jaipur (15-18 December 2024) and, more recently, in Delhi (17-19 January 2025). Officials have noted that on-site and post-event FEI feedback provided to Organising Committees is not being implemented from one Event to the next. The lack of preparation and compliance with FEI standards is compromising the safety of both Athletes and Horses on the Cross Country course.

To improve future Events in India, we strongly recommend the following measures:

- Ensure that the Course Designer and Technical Delegate arrive in India well in advance of the Event.
- Implement all recommendations outlined in the Officials' Reports received after each FEI Event.
- Maintain consistency by using the same Course Designer and Technical Delegate at each venue for three consecutive Events.

Additionally, please note that the Eventing Schedule for Meerut (planned for 24-28 February 2025) will only be approved and published once we receive confirmation that Officials having officiated in both Delhi (January 2025) and Meerut (February 2025) have been reimbursed for all costs associated with their appointments.

This is a matter of utmost importance. While the development of Eventing in India is highly encouraging, it must be conducted under the same conditions and standards required for all FEI Events.

We look forward to your response and confirmation of how your National Federation intends to comply with these requirements.

Subject: Cancellation of the FEI Eventing Event in Meerut (IND) 24-28 February 2025

Dear Col. Singh,

Further to our previous email communications dated 30 January, 4 February, and 5 February 2025 regarding the outstanding payments for FEI Officials at FEI Eventing Events, we regret to inform you that the required payments, specifically for Per Diems and VISA application costs, have not been received within the stipulated deadline of 7 February 2025. As previously communicated, the approval and execution of the upcoming FEI Eventing CCI1*-Intro, CCI2*-S, and CCI3*-S in Meerut (IND), scheduled for 24-28 February 2025, were contingent upon the timely settlement of these payments.

As the deadline has now passed without receipt of the necessary funds, we must proceed with the cancellation of the Event and its removal from the FEI Calendar. Officials will be notified accordingly, and we kindly request that you inform all relevant stakeholders at your earliest convenience.

Additionally, for future Events to be approved, we require that costs incurred by Officials who officiated at the January 2025 Event in Delhi, as well as any expenses already incurred by the Officials appointed in Meerut, such as VISA application fees or other related costs, be paid by end of March 2025, as previously discussed. Furthermore, for all other upcoming FEI Eventing Events, costs related to Per Diems, VISAs, and Flights must be fully settled at the latest 30 days before the start of the Event. Failure to comply with these requirements will result in the cancellation of the respective Events.

We sincerely regret the necessity of this decision and understand the impact on athletes and the broader equestrian community in India. However, adherence to FEI financial and regulatory obligations is essential to maintaining the integrity and sustainability of international equestrian Events.

Should you require any further clarification, please do not hesitate to contact us. We remain committed to the development of Eventing in India and look forward to resolving these issues to facilitate future successful Events under FEI regulations.
