TECH & ADM INSTRS

1. **General-** NATIONAL ENDURANCE CHAMPIONSHIP -2018 ,Pre novic 40,and, JNEC 40 km will be held with effective from 26 to 28 oct 2018 at the, Gajadharpur, Jaipur, Under the aegis of technical guidelines & rules/regulations of the equestrian federation of India. All participants are advised to go through the EFI technical guidelines, rules, regulations and specification, before the event, irrespective of the extract reproduced in this prospectus.
2. **Tentative Programme** – Refer Appendix ‘A’
3. **Entries-**
 - a) All entries must be of the prescribed Entry form given in Appendix ‘C’ and should be completed in all respects. Entries not in the prescribed entry form and not accompanied by the entry fee will not be considered. All entries for NATIONAL ENDURANCE CHAMPIONSHIP -2018 Pre novice 40,and , JNEC 40 must be accompanied by proof of age (birth certificate). All entries must be EFI horse passport number description, EFI registration number & name of the horse concerned& Rider’s EFI I.D.
 - b) Entries must be sent to the Show office, Sagar Equestrian Sports Academy Gajadharpur, Jaipur. To facilitate processing of the data please also email a copy of the entries to sagarequestrianacademy@gmail.com
 - c) Refer to article 12 of EFI Technical Guidelines for Horse Concourse entries.
 - d) **Entry Fee-** the entry fee will be as under:-
 - i. Individual Events- Rs500/- per entry. Team Events Rs. 1000/- Per Team.
 - e) No Entry will be accepted without the prescribed fee.
 - f) **Closing Date for Entries**– Entries will close by 12:00 hours on 022 oct 2018 Entries received thereafter will be regarded as POST ENTRIES. However, post entries will be accepted up to one hour before the draw of lots for each event. No entries will be accepted thereafter. Post entry fee will be:-
 - i. Individual Events Rs. 1000/- per exhibit.
 - ii. Team events Rs. 2000/- Per Team
 - g) **Payment-** All entries must be paid in DD or by local Cheque or RTGS/NEFT in favor of “Sagar Equestrian Sports Academy” Account No. 29570200001186, IFSC – BARB0JHOTWA Jaipur (Payable at Jaipur) BANK OF BARODA.

h) EFI Horses Passport –

- i.** As per EFI rules all horses participating in the NATIONAL ENDURANCE CHAMPIONSHIP - 2018 pre novice 40 Km ,and, JNEC 40 Km have to be in possession of EFI passport.
- ii.** No entry will be accepted without EFI Registration number. For further information pertaining to registration, contact EFI. Please register the horses participating in the event with the EFI prior to the slow.
- iii.** All the riders of 18years age and above, participating in the EFI recognized events should be obtain EFI identity number.

4. Withdrawal, Change, Transfer or Substitutions of Entry –

- a) Withdrawal**- The entry fee of a horse entered for any category will not be refunded if the horse does not participate in the class.
- b) Transfer and Substitutions** – A horse cannot be transferred from one class to another without paying an additional entry fee for the class to which it is transferred. A horse once entered in any category cannot be substituted by another horse for any reason whatsoever.
- c) Change of Riders** – Riders cannot be changed unless the jury accepts that there are sufficient reasons for change of riders. Once a class has started being judged, no change in rider will be accepted.
- d)** All changes will be treated as post entries.

- 5. Cancellation**- The organizing Committee may cancel any class which has less than four entries or for any reason at their discretion. In that case, the entry fee will be refunded. However, the events where upgradation of horses is involved , those events will be held irrespective of number of entries.

- 6.** The class will start once the draw of lots for the order of start has been held.

- 7. Show Number** – All horses will display the EFI registration number on the bridle during competition and veterinary inspection and whenever taken out from the stable.

- 8. Rosette**- No rosette will be worn by a horse during judging.

- 9. Elimination/Disqualification** – the judges are empowered to disqualify the competitors at any stage of the competition for rough handling, excessive brutality or any form of cruelty to animal. Rapping will be severely penalized.

- 10. Whips/Spurs** – As per EFI rules on the subject.

11. **Dress Code**- Article 308 - As per EFI Technical Guideline 2016.
- (1) Protective headgear, of a recognized equestrian/endurance standard and securely fastened, is compulsory for all persons at all Endurance events whilst mounted.
 - (2) Safe riding footwear with heels 12 mm or more, or alternatively caged/Boxed stirrups/equestrian safety stirrups are compulsory for all persons at all endurance events whilst mounted.
 - (3) Dress, that is appropriate and not detrimental to the image of Endurance Riding is required.
 - (4) Athlete :- Smart Pressed Team or Individual Riding uniforms.
 - (5) Team Officials, Grooms, Crews :- Smart Pressed Team or Individual uniforms.
 - (6) FEI Officials :- Smart Clothing to include jacket and tie where applicable, Shorts or sandals are unacceptable standards of dress and will not be allowed.
 - (7) During the actual ride
 - (a) Athlete :- Appropriate riding attire, shirt/polo shirt to include a collar.
 - (b) Team officials, Grooms, Crews : Smart Team or Individual attire. No Shorts within the Vet Inspection area, or sandals allowed within the "Field of Play" (Safety).
 - (c) Officials :- Smart working attire, no shorts or Sandals.
12. **Appeal** – Appeal can be lodged by competitors with two hours before the commencement of any class and within an hour announcement of the result. A fee of Rs. 2000/- (Rupees Two Thousands only) should be deposited with the show secretary. SESA along with the objection. Money will be refunded if the objection is upheld. The class has commenced once the draw of lots has been held.
13. **Medical Cover**-SESA will provide medical cover for riders at the venue. SESA will not accept any liability for medical treatment given to a rider on the venue or the consequences hospital where necessary, through every possible means available. Each rider participating in the NATIONAL ENDURANCE CHAMPIONSHIP -2018 will fill the indemnity Bond attached at Appendix E and submit the same along with entry form.
14. **Insurance** – The Organizer recommends that units/clubs/associations/schools to take Insurance policies for competitors, personnel, grooms and horses for their transportation to Jaipur during the events. The Organizer will not assume responsibility for any accident or illness due to fail of any horse, competitors, groom/ any other member of the team.
15. **Responsibility** – The Organizer accepts no responsibility for any loss, damage or injury any animal of any other property or the exhibitors themselves. Neither the Organizer nor the Doctor will be held responsible for any aid or other medical treatment provided.
16. **Eligibility of Rider** – Please ref Article 302 (EFI Technical Guidelines 2016)
17. **Restriction on Horse** - Please ref. Article 303 EFI Tech. Guideline .
18. **Saddlery and Equipment** – Please ref Article 307 EFI Tech. Guideline.
19. **Technical conduct** :- Please Ref Article 309 EFI Tech. Guideline as per FEI Rules.

20. **Accommodation** – All Participants are required to make arrangement for their accommodation. In Case any assistance is required you may contact show secretary SESA, Jaipur.
21. **Inspection Decorum** :- Please Ref. Article 314 & Per EFI Tech. Guideline.
22. **Abuse/cruelty to horses** – Refer to Article 311 of EFI Technical Guidelines 2016.
23. **Camp-** The SESA has permitted stabling of horses for all participants in NATIONAL ENDURANCE CHAMPIONSHIP -2018 for the duration of the event. Permission to stable horses during the above period is subject to certain conditions as laid down in Annexure 1 of Appendix 'F' to this prospectus. Security aspects as mentioned in Para 6 to 8 in Annexure 2 of Appendix 'F' Pertaining to civilian employees of all contingents including Club members entering the SESA Jaipur for temporary stabling will be strictly adhered to. No civilian employee of any contingent will be allowed to enter will be SESA ,Jaipur without civil police verification. Camp will open on 23oct 2018.
24. The Camp puchorg will earmark the site for each contingent. The rep of the contingent will take over the site allotted to them from the Camp puchorg on arrival & Landover the same before departure in the same condition, any damage to camp, accommodation or property will be the responsibility of the contingent. The teams should come self contained in all respects for camping in respect of their personnel and animals. All teams will intimate the total strength of contingent in terms of men and horses positively by 20 oct 2018 and intimate Extended Time of Arrival well in advance SESA, Jaipur to org Administrative Arrangements.
25. **Self – Containment** – All teams coming to participate in the NATIONAL ENDURANCE CHAMPIONSHIP -2018 camping, cooks and transport, ration , Horses stables well not be provide by SESA, Jaipur.
26. **Ration/Fodder-** Army contingents are advised to bring maximum quantity of grain/ fodder to sustain their horses during their Stay in Jaipur or, they can ask for attachment both the local Supply Depot. Other contingents are advised to make their own arrangements for animal rations.
27. **Coggin and Glander Test** – All rules and instructions issued from the EFI and Remount veterinary Directorate, army Headquarters on the subject will be strictly adhered to by concerned. All horses must produce a valid negative EIA and Glander Status (CFT) certificate on arrival to Jaipur as per directions given at Para 5 (a) of Appendix 'F' to this prospectus. Coggins and glanders negative certificate with a validity of a minimum of 14 days arrival and exit of horses from the camp is mandatory.
28. **Trotting Parade** – All participants are requested to present their horses for veterinary inspection (Trotting parade) at 1000 Hrs 26 oct.2018.

29. **Ground jury, Veterinary / technical delegate, Appeal Committee and insurance-** These are as per Equestrian Federation of India under governing competitions.
30. **Spectators** – The Spectators or the supporters of the participants are not to interfere with the judges. The Arena Steward has the right to eliminate any participant who has outside help. Once the event has commenced, all spectators and helpers are to clear the arena. The Judges decision will be final. Parents must not enter the arena or dispute the decision or directly confront the judges.
31. **Prize Distribution** – Tentatively prizes will be distributed after each event on the same day.
32. **Fire Fighting Arrangement** – All contingents are requested to carry adequate fire fighting equipment.
33. **Veterinary Commission** – The Veterinary Commission detailed by the Equestrian Federation of India will have full right to examine all the horses participating.
34. **Veterinary Assistance** – the following is available for vet assistance in case of an emergency.

35. **Clearance Certificate** – All horse owners/riders are required to obtain a clearance certificate from the Show office during working hours. All accounts concerned needed to be cleared before they can obtain the same. No horses will be allowed to leave unless they obtain the clearance certificate.
36. **Correspondence-** All correspondence in respect of the NATIONAL ENDURANCE CHAMPIONSHIP -2018 will be addressed to.

Note- NATIONAL ENDURANCE CHAMPIONSHIP -2018 The Organizing committee may at any time alter/amend any of the above conditions, owing to unforeseen circumstances. In cases of any doubts, queries or clarification, regarding anything related to the Championship , it may be sought well before the event.
