

**MINUTES OF 59<sup>TH</sup> ANNUAL GENERAL BODY 2020 MEETING OF EQUESTRIAN  
FEDERATION OF INDIA HELD ON 21<sup>ST</sup> MAR 2021 AT DEFENCE SERVICES OFFICERS'  
INSTITUTE, DHAULA KUAN, NEW DELHI**

1. The 59<sup>th</sup> Annual General Body Meeting 2020 of Equestrian Federation of India was held on 21<sup>st</sup> Mar 2021 at Defence Services Officers' Institute, Dhaula Kuan, New Delhi. The meeting was attended by 78 members.
2. Dr SY Quraishi, learned Observer appointed by the Hon'ble High Court, Delhi was also present at the AGM 2020.
3. In terms of provisions as contained in Para 7 of Article 017, Chapter VI, EFI Statutes, the Secretary General proposed to the house to nominate Lt Gen PR Venkatesh, PVSM, SM, Vice President (Vet) to chair the meeting. The house approved the proposal. The Secy Gen requested the nominated chair to address the house.

4. **Opening address by the nominated Chair**

4.1 Lt Gen PR Venkatesh, PVSM, SM the nominated chair of the meeting greeted and welcomed all members present at the 59<sup>th</sup> Annual General Body Meeting of Equestrian Federation of India. He also welcomed Maj Gen R K R Balasubramanian, AVSM (Retd), Lt Gen Balbir Singh Sandhu, VSM (Retd), Lt Gen AJ Singh, AVSM, VSM (Retd), the present DGST Lt Gen MKS Yadav, SM, Dr SY Quraishi, learned Observer appointed by Hon'ble High Court of Delhi and all other distinguished members who have contributed in a rich manner to the noble sport.

4.2 "As we all know we have had a pretty challenging time during the previous year because of COVID pandemic and court cases that swayed our NF due to which we had three main important issues. First was restraining of the President as well as the Vice President (Adm) of EFI from performing their respective charter of duties, the second was the Observer who was placed by the Hon'ble High Court of Delhi and third was one State Association representing against the NF stating that the EFI was not following NSDCI 2011 inspite of the fact that they themselves were not following the code. Since the matter was sub judice and within the domain of the Hon'ble High Court of Delhi we will not discuss the matter further and rather rely on the narrative of the proceedings. COVID was a great challenge for everyone and horse owners were no exception. I am told that it was very difficult for horse owners to shift horses during the lockdown, arrange for rations and hay and make available manpower to look after the animals. The matter was taken up with the Ministry of Agriculture and Ministry of Animal Husbandry for inclusion of transportation of animals, ration and fodder into essential services which has been successful.

4.3 With the team's effort we have overcome the COVID challenges. COVID preventive directives were prepared by the Secretariat by seeking inputs from WHO, FEI, MYAS, as well as MHA. Based on the same, a centralised COVID preventive protocol was passed on to various stake holders so that max possible precautions were taken.

4.4 There were three cases the Secretariat had initiated. A case for the waiver of 30% import duty on sporting horses was taken up with the Ministry of Sports which in turn has recommended the case and taken it up with the Ministry of Finance for final concurrence. The Secretariat had taken up a case with MYAS in respect to recognition by the Ministry and subsequent to this, annual recognition has been granted till 2021. In addition to this, the

Ministry has incorporated a relaxation clause in the Sports code and on case to case basis certain relaxations could be given to NSFs.

4.5 Last year we could not hold our National Equestrian Championship for Tent Pegging and Delhi Horse Show due to COVID restrictions, and during this calendar season we have been successful in conducting the World Challenge Dressage, World Challenge Jumping, NEC Dressage, NEC Jumping, NEC Eventing, NEC Tent Pegging and FEI Eventing and a total of 50 competitions have taken place at various levels. In addition to this, we have conducted the Tent Pegging World Cup Qualifiers in which 5 countries participated, America, Belarus, Pakistan, India & Nepal. All these events were conducted efficiently with COVID monitoring due to assistance, indulgence and support of all. I would like to thank all the participants, officials and jury members for making each event a success.

4.6 I expect this AGM to go ahead with lot of foresightedness and we should have a road map for the coming Asian Games and Olympics, and I have a firm belief that whatever discussions that takes place here should be in realm of respect and honour. We must weigh our words at the time of speaking and the AGM should go ahead with significant contribution from all of you. I wish you all the best and I hand over the proceedings to the Secretary General to carry on with the affairs of the house.

(g) **Standard Operating Procedure (SOP) : EFI COVID 19 Protocol for Equestrian Training & Events.** The EFI had prepared a comprehensive COVID 19 Protocol for resumption of Training and Equestrian activities in accordance with all Govt, FEI & WHO guidelines promulgated from time to time.

The Federation was in receipt of Administrative Sanction for Rs 99,95,0000/- (Rupees Ninety Nine Lac Ninety Five Thousand only) from Sports Authority of India for various events and the balance amount of Rs 6,13,200/- was likely to be surrendered as the same was approved for AEF Young Riders (YRs) Show Jumping &amp; Dressage finals and FEI Jumping World Challenge final which stand cancelled due to the Covid pandemic.</p>	The house perused the same. (a) **Outstanding Annual Subscriptions.** Ms Sunayna Mishra sought the list of members from whom the outstanding amount was due and year wise details of due from over a year. The Secretary General replied that the outstanding figure as reflected in the Audited Statement of Accounts was of 31 Mar 2020 and thereafter annual subscriptions from the members had been received. He also added that the membership of members whose subscription was outstanding for two years or more have been recommended for termination as per list flashed earlier attached at **Appendix L.**

(b) **Incentives to Associations – List of Associations and the purpose of incentive be given.** The Joint Secretary clarified that as per decision taken in the AGM 2018 and Para 14 of REL Guidelines 2018 (amended from time to time), an incentive was being given by the EFI to a Centre/Club who successfully conducted an REL once in a calendar year (Rs 50,000/- if participation over 25 riders and Rs 25,000/- for less than 25 riders).

(c) **Non recoverable from Govt of India – 17<sup>th</sup> Asian Games.** The Joint Secretary clarified that the Ministry had paid only Rs 1,10,00,000/- (Rupees One Crore Ten Lac only) in connection with the 17<sup>th</sup> Asian Games in 2014 against a total claim of Rs 2,13,99,260.11 which was incurred by the Federation. However, this amount was still being shown as amount due for receipt from the SAI in the Federation book of accounts. In order to regularize the accounts of the Federation, it is required to write off the long outstanding dues which are unlikely to be paid by SAI.

(d) **Non recoverable from SAI & Others – 18<sup>th</sup> Asian Games.** The Joint Secretary informed the house that the claim of expenditure incurred for 18<sup>th</sup> Asian Games 2018 was forwarded to the Sports Authority of India (SAI). However, Rs 45,08,480/- was disallowed in audit on account of remuneration paid to the Team Coaches, Veterinary Doctor, Farrier and Grooms. This amount was disallowed since there was no MoU by the Government with these officials prior to the 18<sup>th</sup> Asian Games.

(e) Fees was being taken from riders based abroad to issue NOC in order to participate and represent India in overseas events. Ms Sunayna Mishra alleged that Indian riders based abroad were given NOC to represent India against a fee called NOC fees whereas athletes residing in India had to struggle through RELs and qualifying rounds to represent India. Since the NF was getting money, Indians residing outside were given permission to participate representing India.

Joint Secretary clarified that anyone who participates abroad requires a clearance from the National Federation to participate and therefore a NOC is required, however he participates in his/her individual personal capacity and not for Team India unless the individual or team has been selected by the Selection Committee and NF. Col PP Singh (Retd) said that athletes residing abroad participate in their individual capacity and not as an Indian Team, and they require an NOC from the National Federation of their passport to compete abroad. Col PP Singh (Retd) further said that the FEI allows that an Athlete can participate in an event as an individual wherever the athlete was staying but required to take a NOC from his/her parent Federation. Mr Raghuvendra Singh Dundlod queried if these athletes could carry the Indian Flag and claim to be representing India on social media. He added that athletes in India are working so hard to compete abroad and someone sitting abroad pays money for NOC and he/she was permitted to carry the India Flag which was quite unfair. Col PP Singh (Retd) answered that the FEI allows an individual to carry his national flag, it is the dispensation or pride of the nation and it is also displayed at the venue and is part of the legal system of FEI and FEI allows it. Ms Sunayana Mishra said that NSDCI-2011 clearly says name of India or Indian Flag cannot be used unless the permission is taken from the Govt of India. Col PP Singh said that EFI is signatory to FEI Code of Conduct, in this scenario the FEI Code of Conduct being an international body takes precedence over the National body.

Joint Secretary replied that any team which participated on behalf of India has to be cleared by the Federation and selected by the Selection Committee. No other individual or team

can represent India without being cleared by the federation. Mr Raghuvendra Singh Dundlod thanked for the clarification but requested to review this clause some time by the EC because it was unfair for the Indian riders who are working really hard to compete for India and someone residing outside is representing the country. He further added that the clarification explained by Col PP Singh (Retd) that NF would follow the FEI Charter and not the National Charter was a matter of dispute and discussion at a later stage.

**(f) Details of expenses payable as on 31 Mar 2020 – Equestrian Breeders & Sports Association (EBSA).**

Ms Sunayna Mishra questioned as to why an amount was to be paid to EBSA. The Secretary General clarified that Equestrian Breeders and Sports Association had deposited a refundable Corpus Money of Rs 3,00,000/- (Rupees three lac only) in connection with Junior National Equestrian Championship (Endurance) and National Equestrian Championship (Endurance) held at Palanpur, Gujrat from 14 - 15 Mar 2020. On successful completion of the event the refundable corpus money was required to be refunded which was done in the month of May 2020 and would be reflected in the audited statement of next financial year.

**6.25 Mr Gaurav Joshi** informed the house that the Jodhpur Polo and Equestrian Institute (JPEI) was affiliated with the Federation for a long time. The JPEI's name was also included in the list of club members recommended to be terminated by the EFI. The Secretary General replied that the name of JPEI Club had been removed from the termination list as the NF was in receipt of proof of documents of existence from JPEI and satisfied with the reply.

Lt Gen MKS Yadav, SM, DG ST requested the Secretary General to explain to the house the process of audit of clubs.

The Secretary General apprised the house that off late the NF had received several complaints regarding clubs not involved in equestrian activities and kept as members purely for vote bank purposes. In view of the above, Executive Committee formed a Committee to review the status of clubs/institutes/units based on holding of horses/athletes/infrastructure etc) with the help of respective Regional Members. The report of the committee was reviewed by the EC dated 26 Feb 2021

The house perused the same.

The Secretary General clarified the same and the house agreed.



and all clubs/institutes/units members recommended for termination were served show cause notices before implementing the recommendation of the committee and EC.

Mr Raghuvendra Singh Dundlod informed the house that Chetak Festival Samiti was also recommended for termination. Chetak Festival Samiti was involved in organising Endurance and Tent Pegging events and Jury had been appointed by the EFI for these events/championships. He requested the house to reconsider their plea.

Lt Gen MKS Yadav, SM clarified that over 100 Army Units and Clubs had been involved in equestrian sports but as of now were no longer involved with the sports and therefore were recommended to be removed as members. After the review we do not have any Dog unit, Petroleum Platoons, Supply Depots, MT Units as members which were intrinsic part of entire equestrian eco system as far as conduct of Equestrian competitions in the country was concerned for decades and not for one year. In case a club which had been recommended for termination of membership involves its self in equestrian activity, the club can be reinstated. He also recommended to the chair that subsequent membership to any club/institute to be given after the on ground equestrian activity is assessed by a committee consisting of the Regional Member and a rep of EFI.

Mr Ashish Amin, Secretary of Equestrian Association of Gujarat said that recently they had come to know that the membership of Equestrian Association of Gujarat had been terminated by the EFI due to non payment of annual subscription. He added that the outstanding dues had been paid by the Association and requested the house to reinstate the membership of Equestrian Association of Gujarat. The Joint Secretary requested him to send a representation to the EFI and the Federation will review the same. Joint Secretary further said that since the Federation was into a legal issue with one of the State Associations the entire concept of the State Association would be reviewed after the legal issue was done with. The Chair of the meeting also suggested that a representation be made by Mr Ashish Amin, Secretary of Equestrian Association of Gujarat and the NF would consider the same based on merits of the case. Mr Raghuvendra Singh Dundlod said that as per remarks of the Joint Secretary, if the NF would be reviewing the charter of State Association then all affiliated State Associations and those whose applications are pending should be called as

The Secretary General confirmed the same and the house approved.

stakeholders to discuss it before taking a decision on State Associations.

Mr Raghuvendra Singh further requested to reconsider the case of Chetak Festival Samiti since the request had been forwarded by courier and may have got delayed. He further mentioned that this AGM was for the year 2020 and the AGM for the year 2021 should be held before September 2021 as per the Statutes and the results of 2020-21 should be reviewed during AGM 2021.

Mr Raghuvendra Singh Dundlod raised the issue on the results on NEC 40 Km Endurance which according to him was under review of the Technical Committee. Hence results were not supposed to be published. He requested that the results be withheld till the time the Technical Committee meets and discusses the objections raised. The Secy Gen confirmed that he would see the feasibility of a meeting based on the availability of Technical Committee, Organising Committee, Technical Delegate and President Ground Jury. The moment the objection was received, the results were withdrawn from the website and only published after clearance from the Technical Committee. The Secy Gen further clarified that these results stand valid as of now until subsequently reviewed by the Technical Committee. Mr Raghuvendra Singh Dundlod objected to this and said that this would complicate the matter with complaints and legal issues since Rajasthan Govt reserves 2% of Govt Jobs for sportsmen who had participated in National Championships of any recognised sporting event. In reference to this particular issue, Mr Raghuvendra Singh Dundlod suggested that a meeting be held with the Technical Committee, the videos and results sheets be deliberated upon and the objection raised by him and his riders could be addressed and a decision given. Till such time he further requested the results to be withheld to avoid confusion.

Col PP Singh (Retd) brought out to the notice of the house that of late anyone not happy with the results brings a lawyer or advocate and threatens the Federation to go to Court. This was a wrong trend being set and wherein the results were dictated by the Courts and not by the performance of riders on ground. Unlike, every sport, Equestrian sport also has checks and balances, mechanism to address issues and set timelines for everything including raising an objection to the results. Once the internal mechanism and timelines are exhausted and if not satisfied, one is welcome to



approach the Court. In the interim intimidating the members to take the Federation to the Court and issue of legal implications are unwarranted. He further questioned the house that by doing so, is the EFI wanting to kill the sport in India or does the sport need to be decided in the Court of Law or in the field of play?

Addressing to Mr Raghuvendra Singh Dundlod, Col PP Singh (Retd) said that not declaring the results would be unfair for those who have performed and won. Col PP Singh (Retd) humbly requested to respect the given norms of the sport, to go ahead and look ahead with much to win.

Mr Raghuvendra Singh Dundlod was in total agreement with the views of Col PP Singh (Retd) but further reiterated that all the mechanisms that are there should be followed. In this particular case Mr Raghuvendra Singh Dundlod claimed that he requested the matter to be referred to the DRDC which was turned down, then to the Athletes Commission which was also turned down on the pretext that the issue was beyond their ambit and was finally referred to the Technical Committee. He further asserted that if his complaint was addressed adequately, he would be satisfied and for that there was a requirement of a physical meeting to discuss issues. He too was not interested in any legal issues.

Col SS Ahlawat, VSM (Retd) requested to concentrate on the Agendas and suggested that members should not be permitted to speak outside the line of Agendas being flashed.

Chair of the Meeting conveyed to the house to let the Tech Committee review this matter raised by Mr Raghuvendra Singh Dundlod and accordingly they would take a call.

Col SS Ahlawat, VSM (Retd) again requested for the accounts to be perused and suggested members not to be side tracked.

**AGENDA-VI**10. **Points received from Members.**

10.1 **Mr Raghuvendra Singh Dundlod.** Mr Raghuvendra Singh Dundlod brought to the notice of the Chair and the house that during review of the Technical Guidelines, the draft was put up on the website for comments. All comments received from members and stakeholders should be discussed by the Technical Committee with the members who have forwarded such points before being overlooked.

Secondly, two days before the NEC Endurance the Technical Guidelines were amended and composition of teams were changed from 4 to 5 as this was unfair as it deprived many who could have participated.

The Secy Gen informed the house and Mr Raghuvendra Singh Dundlod that the Technical Guidelines for Endurance was promulgated on 14 Dec 2020 and the first event of Endurance was conducted by Sagar Equestrian Sports Academy on 25-27 Jan 2021. The first mail on the Technical Guidelines from Mr Raghuvendra Singh Dundlod was received on 15 Jan. 2021 which was adequately replied and the last mail on the subject was on 22 Jan 2021 which was also replied appropriately. The draft Technical Guidelines was put up on the website for 15 days for comments/suggestions and comments received from members within the stipulated period were put up to the Technical Committee for consideration.





Regarding the amendment to the Technical Guidelines the Secy Gen informed the house that the Technical Guidelines were promulgated on 14 Dec 2020 and an addendum was further promulgated on 01 Jan 2021.

Mr Raghuvendra Singh Dundlod in agreement with the correspondence made with the Federation but questioned the manner in which Team composition of Endurance was changed from 4 to 5 at the last moment. The Secy Gen agreed to the concern and noted the same for future compliance.

Mr Raghuvendra Singh Dundlod said that the Rajasthan State Association has to follow the State Sports Code similar to the National Federation which has to follow the NSDCI – 2011. So when a National Championship or event is allotted to any Club, the same has to be routed through the State Association and he would like to discuss this agenda in detail during the State Association Meeting whenever it would happen.

Lastly Mr Raghuvendra Singh Dundlod raised the issue of having the Team mentioned in the participation/position certificates since the Rajasthan Govt is awarding cash incentive for medals won in National Championships.

Lt Gen MKS Yadav, SM, DGST clarified that an Olympian may be from Bihar or Rajasthan but the incentive he would receive from his State would be as per the State policy. Likewise, in the National Championship if anyone has achieved a Medal then State incentive would be as per his domicile. He further went on to inform the Hon'ble Observer that the number of District Associations in Rajasthan State Association was inadequate to be eligible to form a State Association as per the NSDCI – 2011.

Mr Raghuvendra Singh Dundlod replied to the remarks made by Lt Gen MKS Yadav, SM, DGST. He was in agreement that for international events, the Rajasthan Govt gives incentives as per State domicile but for National Championships he/she has to represent Rajasthan Team to get the benefit of 2% quota in Govt jobs. He further went on to clarify that the Rajasthan State Association was following the Rajasthan Sports Code which mandated 06 District Associations as members and had also extended provisional membership to a few and regularisation of the same had been delayed due to the COVID 19. State Associations cannot follow the NSDCI – 2011 in reference to the 50%



District Associations and a representation had been made to the Ministry for relaxation in this regard.

Col SS Ahlawat (Retd) further clarified that it is during the National Games which occurs every four years to have a Team entry. This represents the States and for the National Championship which is an annual affair, one does not require a State Entity but can participate on individual capacity.

Mr Gaurav Joshi countered the claim of Mr Raghuvendra Singh Dundlod and stated that during the last election of Rajasthan Equestrian Association (REA) only 09 Districts were part of the State Association out of which 02 were suspended and only 07 Districts for the State Association of Rajasthan. He further went on to State that during the Rajasthan State Championship held in March 2020 he had applied to participate in the championship but was refused permission on the pretext that he was from Jodhpur and since Jodhpur District was not a Member District, he was not eligible to participate. He further questioned whether the State Championship was for the entire State or only the 07 Districts affiliated with the State Association. Out of the 33 Districts, the team representing Rajasthan would be selected from the 07 affiliated districts only.

In reply to the points raised by Mr Gaurav Joshi, Mr Raghuvendra Singh Dundlod requested him to raise the issue at the State Association Meeting.

The chair of the meeting replied back to Mr Raghuvendra Singh Dundlod that as per the NSDCI – 2011, each State Association would be eligible if it has 50% of District Associations affiliated to it. In the case of Rajasthan State Association the laid down criteria as per the NSDCI – 2011 was not met and hence it was not eligible to be called a State Association.

To this Mr Raghuvendra Singh Dundlod replied that like the National Federation, the State Association had also applied to the Ministry for exemption on this particular clause.

The Chair of the meeting commented on the above with a phrase "the pot should not call the kettle black" and requested Mr Raghuvendra Singh Dundlod to discuss the agenda rather than digressing from the main point.

Lt Col MM Rahman, Jt Secy EFI requested Mr Raghuvendra Singh Dundlod and Mr Gaurav Joshi to resolve the issue brought out by Mr Gaurav Joshi at the REA General Assembly since it was an issue related to the internal functioning of REA and not relevant to the AGM of EFI.

The Chair of the meeting requested members of REA not to wash dirty linen in public and made an appeal to resolve issues internally to which Mr Raghuvendra Singh Dundlod agreed to.

Lt Gen MKS Yadav, SM, DGST referred to veteran member Maj Gen Balasubramanian (Retd) who was also one of the office bearer's when the Federation was formed and today one had lost the entire focus on the game and were indulging in unwarranted politics rather than paving pathway for facilitating the improvement of the sports. He requested the chair to proceed with the Agendas.

10.2 **Col Rajesh Pattu (Retd).** Col Rajesh Pattu (Retd) with the permission of the chair said he was in total agreement with the remarks made by Lt Gen MKS Yadav, SM, DGST and added that riders have to make full use of the organisation to promote the sport. Col Rajesh Pattu (Retd) said that he had written to the Federation since Jul 2018 and after 08 months he received a reply from the Federation in which he was being questioned rather than being answered. He further requested that a committee be formed preferably with a retired Judge as a member to look into the complaints and grievances that he had. He further requested his case be put up to the DRDC and be heard.

The Chair of the meeting informed Col Rajesh Pattu (Retd) that his case would be appropriately considered and requested him to be brief with points pertaining to the larger interest rather than personal issues. The mails of Col Rajesh Pattu (Retd) had been replied appropriately and one should not keep on whipping a dead horse. Col Rajesh Pattu (Retd) reiterated that in order to move forward, we have to address the problems. Secondly Col Rajesh Pattu (Retd) questioned as to why the AGM and EC Meetings were not held as per schedule since the competitions were being held and everything had normalised in the country.

The Secy Gen replied to Col Rajesh Pattu (Retd) by stating that equestrian sports is a non-contact sport and in the interest of the sport and athletes, events were conducted though we were constrained to delay the start of events due to the prevailing COVID 19 scenario.

A physical EC was not feasible after Feb 2020 due to the COVID 19 pandemic and the travel restrictions imposed in various States. Moreover, the EC has a number of elderly individuals on board who were apprehensive to travel during this period. However, decisions on important issues were taken on emails for the smooth functioning of the Federation and the sports. With normalcy returning this AGM had been planned which was the AGM for 2020 and it was happening in the open.

Col Rajesh Pattu (Retd) was not satisfied with the justification given by the Secy Gen and again went on to harp on the issues on which he had raised. He again said that when the parliament was functional why the EC and AGM could not be held on time.

Lt Gen MKS Yadav, SM, DGST informed the house that post COVID lockdown, the calendar of events started with lot of speculation with the first event being conducted in Nov at APRC. One option was to be complacent citing the COVID scenario but in the interest of the sports efforts were made to conduct the events.

Col Rajesh Pattu (Retd) said that in 2019 IOA General Assembly, the status of EFI was downgraded to Associate Member. He wanted to know what efforts were made to upgrade to regular member and comply with the Olympic Charter. The Secy Gen corrected Col Rajesh Pattu (Retd) and said that IOA General Assembly referred to was of 2018 and not 2019. He further informed Col Rajesh Pattu (Retd) that once the Court case pertaining to the compliance of NSDCI – 2011 was settled, the Federation will approach IOA on the issue.

Col Rajesh Pattu (Retd) handed over a document to the Chair of meeting and the Hon'ble Observer and requested them to go through it. He narrated the contents of the letter by saying that an EC Member got this letter issued from EFI on the pretext to obtain VISA for Germany for his son who is shown as an athlete. He requested the Chair to direct the Federation to check from the German Embassy if the letter was used to obtain VISA for the named official and his son. He further questioned that if this was true what action would be taken. The chair of the meeting informed Col Rajesh Pattu (Retd) that the communication handed over to him would be discussed in the EC with inputs from the Federation Secretariat.

<p>10.4 <b><u>Col Rohit Dagar</u></b>. The Secy Gen in his report had mentioned that competing athletes cannot be judges and therefore requested the Secy Gen to clarify whether this was applicable for a particular event or applicable across the year.</p> <p>Col Jagat Singh, Vice President (Tech) clarified that in Endurance, FEI had a case wherein one official also competed in the event and the matter was deliberated in the EC held on 26 Feb 2021 and it was decided that an Athlete/Official had to certify in the beginning of the calendar year as to whether the individual was willing to participate as an Athlete or officiate as an Official for that season.</p> <p>Col Rohit Dagar quoting the FEI rule of conflict of interest said that an official is prohibited from participating in the event in which he/she is officiating as a judge.</p> <p>Col PP Singh (Retd) added that in addition to the above, world over no practicing athlete is allowed to judge any event.</p> <p>Col Rohit Dagar requested to include the name of Maj Apurva Dhabhade in the result sheet as he had been ranked No 1 in the FEI World Jumping Challenge Cat C and the athlete should be recognised by the Federation. The Secy Gen acknowledged the same.</p> <p>Col Rohit Dagar requested that the Eventing Trials for the Calendar year 2021-22 needed to be re-looked as most of the Eventing riders were North India based. The Secy Gen replied that his request would be looked into.</p>		



The Chair of the meeting said that this was a relevant point in the interest of the riders and the same can be discussed in the next physical EC Meeting.

Col Rohit Dagar highlighted the point that in the draft Calendar NEC Tent Pegging was scheduled at Bangalore in March. He suggested that based on the REL qualifications the venue for NEC Tent Pegging should be considered in the zone which has maximum REL qualified riders.

The chair of the meeting agreed to reconsider the same since the calendar would be discussed in the next physical EC.

Col Rohit Dagar suggested that Ris Ajay Sawant who was conferred the prestigious Arjuna Award may be considered as the Coach for the Indian Tent Pegging Team.

Col Rohit Dagar informed the house that APRC had helped the Federation to conduct events and during COVID had even conducted events at short notices. However, Col Rohit Dagar expressed dissent for not being allowed to conduct the Northern India Horse Show alongwith JNEC whereas precedents had been there of local horse shows alongwith JNEC. He further argued that Regional Horse Shows were to promote the sports and suggested to have more Regional Shows alongwith Nationals so that riders who do not qualify for the Nationals through REL can compete in these Regional/Local Shows.

The Secy Gen clarified that the EC had decided that two medals would not be awarded for one event and hence no Local/Regional event could be clubbed with the Nationals. If any Organising Committee was to conduct any regional show concurrently with separate runs, the OC was welcome.

Col Rohit Dagar alleged that in the recently conducted NEC Tent Pegging, a regional horse show 'Noida Horse Show' was conducted alongwith the NEC. However, the OC Mr Ahmad Afsar clarified that the local show was conducted separately and not on the same runs of the National and neither was the event part of the EFI Calendar.

Col Rohit Dagar mentioned the Technical Guidelines mandates two round competition for upgradation for Show Jumping and DHS would also be considered for upgradation. The Secy Gen requested



Brig Deep Ahlawat, VSM to clarify who said that the AEC and DHS were large shows and at par with Nationals and these events would give advantage to riders for upgradation who otherwise have only one opportunity for upgradation i.e the Nationals.

Mr Raghuvendra Singh Dundlod seconded the point raised by Col Rohit Dagar regarding selecting Ris Ajay Sawant as the Coach for the Indian Tent Pegging Team and made an appeal to the AGM to take a decision. He further highlighted that during the Tent Pegging World Cup Qualifier, the Nepal Team were represented by Indian passport holders and on the result sheet, the surnames had been omitted. This could lead to an international issue and expressed apprehension if Nepal could give such permission without approval of the Nepalese Govt. He further alleged that the American Tent Pegging Team consisted of one American citizen and the other three were Green Card holders of Pakistani origin. The Federation has a large no of defence personnel and were these Pakistanis cleared by security agencies to participate as an American Team.

The Secy Gen clarified that the American Team consisted of 04 players who were American citizens. One athlete was based in Chicago while the other three had travelled to Pakistan and applied for visa at Islamabad. In the process of their security clearance for VISA purposes, their move to India was delayed by 03 days. The Secy Gen further informed Mr Raghuvendra Singh Dundlod that Military Intelligence Clearance had been obtained for Federation Officials of Defence origin to interact with these foreign nationals including those of the American team.

Col Tarsem Singh came forward to answer the queries of Col Rohit Dagar pertaining to the selection of the Coach for the Indian Tent Pegging Team. He said that the country was proud of Ris Ajay Sawant and he is a national asset but however during the trials for selection of the Indian Team, his performance was not optimum and he finished sixth and as Member Tent Pegging he felt that it was too early to engage Ris Ajay Sawant as the Coach as he was a competitive athlete and doing well as an athlete. At a later stage the services of Ris Ajay Sawant would be required as a Coach/Manager and Col Tarsem Singh strongly recommended to categorise Ris Ajay Sawant as an athlete as on date.



Mr Raghuvendra Singh Dundlod queried the criteria for a Coach to which Col Tarsem Singh replied that the same was appointed by the Selection Committee. Mr Raghuvendra Singh Dundlod further wanted to know the criteria for Judges and selection of Coaches and again put forward the issue of participation of the Nepal Team.

Col Tarsem Singh said he would clarify the issue but before that he would like to counter the misinformation being floated regarding the World Cup Qualifiers. He as Member Tent Pegging attended the virtual General Assembly of ITPF on 09 Mar 2021 which lasted for approx four hours and the major concerns raised at the meeting was whether to hold the qualifier or not. The ITPF had decided that the qualifier would be considered valid if the competition had minimum four teams. They further divided Group B into B1 and B2 and India was put into Group B1. In the same meeting Nepal which was in Group C requested for a Group change so that they could participate in India. The VISA for the US and Pakistan Teams got delayed and the instructions were very clear that if there were four teams it would be considered as a qualifier or else it would be considered as a friendly international. In view of the above, the event was delayed by 3 days by when the US and Pakistani teams arrived in India. The Nepal team was cleared by ITPF and not by EFI including the list of athletes that would be participating on behalf of Nepal.

The event was conducted under the Jury appointed by the ITPF and due clearance as required to conduct the event was obtained from MYAS, ITPF, and Military Intelligence clearance from the Army.

Mr Raghuvendra Singh Dundlod said that this issue should be raised with ITPF and perhaps some clarification would come at a later stage.

The other issue highlighted by Mr Raghuvendra Singh Dundlod was that the Tent Pegging World Cup was in 2023 and a team was selected in 2021 and before the World Cup it was likely that one or more Nationals would be held. In that case would the final team be selected based on results of the latest Nationals.

Col Tarsem Singh clarified the final dates for the World Cup had not been received till date and a final decision on the matter would be taken subsequently.



Col SS Solanki (Retd) added that the team selected was for the interim period of one year so that a team was ready for any international event during this period. However, for future events the Selection Committee will lay down the criteria for selection.

Mr Ahmad Afsar added that Col Tarsem Singh had addressed all the queries pertaining to the Tent Pegging World Cup Qualifier and that participation of the Nepal Team and the athletes representing Nepal had the approval of ITPF. He also apprised the house that the Tent Pegging Federation of a particular country is not always the Equestrian Federation of that particular country with examples like USEF does not have Tent Pegging and they have signed an MoU with US Tent Pegging Federation which represents USA in all Tent Pegging events. Similar was the case with Nepal. An official communication was received from Nepal Tent Pegging Federation (NTPF) that they would like to participate in the World Cup Qualifier being held in India since their players were already in India. Nepal originally was placed in Group C whose qualifier would be held in Oman and it would be difficult for them to travel and participate in Oman.

Mr Ahmad Afsar further went on to thank the Federation the Secy Gen, Joint Secy and the entire EC who were gracious enough to allot the event and a lot of efforts were put in to make the World Cup Qualifier a success. The event was called off on three occasions once by ITPF as they were misinformed that no team would be participating. Saudi Arabia had its borders closed so team Saudi Arabia could not come, Kazakhstan which used to organise Tent Pegging events could not field a team and the bottom line was that if we did not have four teams the event would not be considered as a World Cup Qualifier. In this particular situation he expressed his gratitude to one Ms Samira, Secretary NTPF who supported the event and agreed to participate in the World Cup Qualifier in India and the same was brought out during the virtual ITPF General Assembly.

Mr Ahmad Afsar further clarified that all US Athletes possessed US Passports and the delay in VISA was due to the fact that Indian Govt required three months for security clearance since these athletes were of Pakistani origin.

**10.5 Mr Ahmad Afsar.** Mr Ahmad Afsar claimed that this World Cup Qualifier was his fifth international event as an Organiser i.e 2010, 2012, 2013, 2015 and after a gap of six years in 2021 and probably the first when he had little role to play in the permission and security



<p>clearance by MYAS, MEA and MHA. He thanked Col Jaiveer Singh, Secy Gen, Lt Col MM Rahman, Jt Secy who made efforts to expedite the necessary permission and security clearance from MYAS, MEA and MHA especially for the VISA of the Pakistani team because we needed to conduct the event as the reputation of the country was at stake.</p> <p>He extended a word of gratitude towards Lt Gen PR Venkatesh, PVSM, SM for supporting and coming to the venue of the NEC Tent Pegging which was a boost to the event. During the NEC Tent Pegging there were 148 riders and the event happened over 7 days whereas generally previous NEC Tent Pegging events were conducted over 4 days. Mr Ahmad Afsar claimed that in the first time in the history of Tent Pegging there were 16 players who had gone in for a tie run in the Rings and Pegs which was an indication of the level of competition and went on to complement the Secy Gen, the EC, The Federation and all athletes of Tent Pegging for development of Tent Pegging.</p> <p>He further thanked the Federation and complimented Ris Ajay Sawant for the Arjuna Award for Tent Pegging and hoped the legacy continued.</p> <p>He further claimed to be the Coach and Member of the AEF Tent Pegging Committee and efforts were on to include the discipline in the Asian Games with the help of the Federation.</p>		
<p>10.6 <b>Mr Sehaj Singh Virk.</b> He supported Col Rohit Dagar's point for conducting one round Show Jumping competition at the Regional Shows which he felt would be otherwise detrimental towards horses due to warm weather conditions in Delhi. He further added if there were two rounds competition either Senior or Junior will suffer and therefore he requested for one round only for Senior Category competition at the DHS.</p>		
<p>10.7 <b>Mr Ashish Amin.</b> He in continuation with Mr Gaurav Joshi's appeal requested for a clarification for those Athletes who do not have a District Association in their district to participate in State/National championships as opposed by Mr Raghuvendra Singh Dundlod.</p>		
<p>10.8 <b>Col Tarsem Singh.</b> Col Tarsem Singh apprised the house that the Federation had to apologise in the last AGM to the Tent Peggers for the poor show at the NEC Tent Pegging 2019 held at Bhondsi. This year for the NEC Tent Pegging 2021 every query was settled and with the use of electronic timer and 100%</p>	<p>The house appreciated the efforts.</p>	





<p>videography the event was conducted in a transparent and fair manner. The standard of the sport displayed was very competitive with several ties both in the individual and team events. He also thanked Col Jaiveer Singh, Secy Gen for providing everything for smooth conduct of the event.</p> <p>The Jt Secy added that in Tent Pegging Team events one has to rely on manual timers and the Federation would make all efforts for provision of a photo-finish camera integrated with a camera to rule out any ambiguity regarding timing in team events.</p>

## FEI CODE OF CONDUCT FOR THE WELFARE OF THE HORSE

The FEI requires all those involved in international equestrian sport to adhere to the FEI Code of Conduct and to acknowledge and accept that at all times the welfare of the Horse must be paramount. Welfare of the horse must never be subordinated to competitive or commercial influences. The following points must be particularly adhered to:

### 1. General Welfare:

#### a) Good Horse management

Stabling and feeding must be compatible with the best Horse management practices. Clean and good quality hay, feed and water must always be available.

#### b) Training methods

Horses must only undergo training that matches their physical capabilities and level of maturity for their respective disciplines. They must not be subjected to methods which are abusive or cause fear.

#### c) Farriery and tack

Foot care and shoeing must be of a high standard. Tack must be designed and fitted to avoid the risk of pain or injury.

#### d) Transport

During transportation, Horses must be fully protected against injuries and other health risks. Vehicles must be safe, well ventilated, maintained to a high standard, disinfected regularly and driven by competent personnel. Competent handlers must always be available to manage the Horses.

#### e) Transit

All journeys must be planned carefully, and Horses allowed regular rest periods with access to food and water in line with current FEI guidelines.

### 2. Fitness to compete:

#### a) Fitness and competence

Participation in Competition must be restricted to fit Horses and Athletes of proven competence. Horses must be allowed suitable rest period between training and competitions; additional rest periods should be allowed following travelling.

#### b) Health status

No Horse deemed unfit to compete may compete or continue to compete, veterinary advice must be sought whenever there is any doubt.

#### c) Doping and Medication

Any action or intent of doping and illicit use of medication constitute a serious welfare issue and will not be tolerated. After any veterinary treatment, sufficient time must be allowed for full recovery before Competition.

d) Surgical procedures

Any surgical procedures that threaten a competing Horse's welfare or the safety of other Horses and/or Athletes must not be allowed.

e) Pregnant/recently foaled mares

Mares must not compete after their fourth month of pregnancy or with foal at foot.

f) Misuse of aids

Abuse of a Horse using natural riding aids or artificial aids (e.g. whips, spurs, etc.) will not be tolerated.

3. **Events must not prejudice Horse welfare:**

a) Competition areas

Horses must be trained and compete on suitable and safe surfaces. All obstacles and competition conditions must be designed with the safety of the Horse in mind.

b) Ground surfaces

All ground surfaces on which Horses walk, train or compete must be designed and maintained to reduce factors that could lead to injury.

c) Extreme weather

Competitions must not take place in extreme weather conditions that may compromise welfare or safety of the Horse. Provision must be made for cooling conditions and equipment for Horses after competing.

d) Stabling at Events

Stables must be safe, hygienic, comfortable, well ventilated and of sufficient size for the type and disposition of the Horse. Washing-down areas and water must always be available.

4. **Humane treatment of horses:**

a) Veterinary treatment

Veterinary expertise must always be available at an Event. If a Horse is injured or exhausted during a Competition, the Athlete must stop competing and a veterinary evaluation must be performed.

b) Referral centres

Wherever necessary, Horses should be collected by ambulance and transported to the nearest relevant treatment centre for further assessment and therapy. Injured Horses must be given full supportive treatment before being transported.

c) Competition injuries



The incidence of injuries sustained in Competition should be monitored. Ground surface conditions, frequency of Competitions and any other risk factors should be examined carefully to indicate ways to minimise injuries.

d) Euthanasia

If injuries are sufficiently severe a Horse may need to be euthanised on humane grounds by a veterinarian as soon as possible, with the sole aim of minimising suffering.

e) Retirement

Horses must be treated sympathetically and humanely when they retire from Competition.

5. **Education:**

The FEI urges all those involved in equestrian sport to attain the highest possible levels of education in areas of expertise relevant to the care and management of the Competition Horse.

This Code of Conduct for the Welfare of the Horse may be modified from time to time and the views of all are welcomed. Particular attention will be paid to new research findings and the FEI encourages further funding and support for welfare studies.

**Sub: National Sports Development Code of India, 2011 – inclusion of relaxation provision - regarding**

The National Sports Development Code of India, 2011 (Sports Code) has been in force since 31.01.2011. The Government has also, from time to time, issued certain other guidelines and instructions with regard to governance and management of Indian Olympic Association (IOA) and National Sports Federations (NSFs). It has been decided to add the following relaxation clause provision at No. 16 under the Heading of Relaxation Clause of the Sports Code 2011 at page 32:

**Relaxation clause:**

*“Government shall have the power to relax any of the provisions of the National Sports Development Code of India, 2011 and other instructions issued with regard to recognition of National Sports Federations (NSFs), renewal of recognition of NSFs on annual basis and governance and management of Indian Olympic Association (IOA) and NSFs, as a special exemption where considered necessary and expedient for the promotion of sports, sportspersons or to remove difficulties in giving true effect to that particular provision of the Sports Code, always being guided by and not inconsistent with the overarching spirit of good governance and ethical conduct enshrined in the Sports Code 2011. The reasons for such relaxation shall be recorded in writing. Power to relax the provisions will vest with Minister In-charge of the Ministry of Youth Affairs & Sports.”*
