#### AGENDA - I

4. <u>Opening Address by the nominated Chair</u>. The nominated Chair Lt Gen PR Venkatesh, PVSM, SM (Retd) addressed the house as under: -

"At the outset I would like to welcome all members of the EC including members of the Athlete's Commission who have travelled from far and wide taking pains to attend this meeting, especially Mr Shyam Mehta who has come all the way from Mumbai. I also welcome Dr SY Quraishi, the learned Observer appointed by the Hon'ble High Court of Delhi to oversee the proceeding, and guide us as and when felt necessary.



One of the important agendas that would be taken up for discussion is the Selection Criteria for the 19th Asian Games. During the previous EC we have already discussed portions of the criteria informally and the Selection Committee consisting of Lt Gen AJ Singh, AVSM, VSM (Retd), Col SL Reddy (Retd), Col Rakesh Nair (Retd), Lt Col Prateeg Misra and Dr Sushil Balwada who have put their shoulder to the wheel and come up with a consensus to formulate the criteria which is acceptable to all. However, the criteria would be subject to discussion in the house. In addition to the Selection Criteria, we would also be finalising the dates and venues of the trials which would be an important agenda for discussion. This will be followed by audit report for the FY 20-21 which has to be passed and finally the proposed budget for the next FY 21-22. I would like to take this opportunity to congratulate Fouaad Mirza who participated in the Tokyo Olympics 2020 and finished 23rd in order of ranking. This representation has been after a considerable gap as the previous participation was at 2000 Olympic games. We also look forward to the next year Asian Games. I request all of you to put your consensual ideas together so that we can discuss the agendas in a very honourable manner without any acrimony and differences of opinion. One could have differences but this should not be so acrimonious that we go back with a heavy heart. Majority should decide any proposal and the decisions should be taken to benefit the system. I seek your indulgence as far as these decisions are taken and to hold the hand of EFI so that we go from strength to strength and come back with flying colours as far as the 19th Asian Games are concerned. With these words I hand over to Secretary General for the proceedings.

The Secy Gen informed the house that the proposal for hiring a PR Agency as a pilot project for one year was approved in principle by the EC on 26 Feb 2021. During the EC meeting dated 30 Jun 2021, the house had suggested to publish an advertisement in a prominent newspaper inviting proposals from established PR Agencies to provide PR coverage for EFI. In response to the advertisement a number of PR firms and individuals had responded, out of which two PR firms were invited to the EC meeting to give their respective presentations and proposal. The Secy Gen also informed the house that journalist Mr S Kannan had made a very derogatory remark pertaining to the Federation while covering the performance of Mr Fouaad Mirza's Olympic performance. The house perused the comments made by Mr S Kannan and pitied him for his poor journalism, inadequate knowledge and vindictive reporting. Col SS Ahlawat informed the house that the same individual was a member of the EC at one point in time in the capacity of Member Media.  The Chair informed the house that Mr Fouaad Mirza had been adequately supported by EFI, alongwith SAI and IOA.	The EC heard both the PR agencies and after due deliberation and discussion based on the respective presentations the EC suggested that both the agencies forward a proposal highlighting scope of work, professional fees for both traditional media (print & visuals) and digital media (social media & digital platforms) separately. On receipt, the same to be circulated to all EC members on mail for review and decision thereon.	Secy Gen	



Dr Sanjay Gupta suggested that individuals who had responded to the advertisement should have been invited, to which the Jt Secy replied that the requirement of the Federation was to have a PR Agency with pan India presence and hence only firms with multiple offices in several cities were shortlisted.

Mr Shyam Mehta suggested to hire the PR Agency without any further delay so that the forth coming events could be covered adequately.

# **AGENDA - III**

6. Audited Statement of Accounts for FY 2020-21. The Secy Gen informed the house that Audited Statement of Accounts for the Financial Year 2020-21 had been finalised and a copy of the same had been circulated to all. Since the font size was small one may refer to the copy in their respective folders.

Col SS Ahlawat, VSM (Retd) and Brig SS Kashyap, questioned as to why was this not circulated to all members beforehand so that one could study the same and come prepared with queries if any. The Secy Gen justified the delay by informing the house that the report had arrived a day earlier and hence could not be circulated on time. However, he agreed to circulated the same on mail to all members. The Secy Gen informed the house that the Federation was liable to pay a tax of Rs 36,000,00/- which in consultation with the CA has been set aside and the surplus income on which the aforesaid tax was calculated has been earmarked for expenditure within the next 05 years under the provisions of Sec 11(2) of IT Rules.

The EC members unanimously passed the statement of Accounts for the financial year 2020-21.

Jt Secy informed the house that for FY 2015-16 the Federation had set aside Rs 1.20 crore under Sec 11(2) of IT Act which was required to be spent by 31 Mar 2020. Hence the Federation was not liable to pay any tax on this amount. Again, for the FY 2016-17, Rs 1.13 crore had been allocated under the same IT Section and is required to be spent by 31 Mar 2022. The EC was requested to formulate a plan for the expenditure of Rs 45 lakhs (Rupees forty five lakhs only) on



infrastructure, Rs 34 lakhs (Rupees thirty four lakhs only) training of riders & hiring of coach and Rs 34 lakhs (Rupees thirty four lakhs only) for conduct of various events otherwise the amount would entail a tax of 30%. Secy Gen confirmed that on account of training and conduct of events, the allocated amount would be expended but for infrastructure the EC had to decide on the equipment to be procured.

The Jt Secy further added that apart from the Rs 45 lakhs (Rupees forty five lakhs only) to be spent on infrastructure within this FY, the Federation had allocated another Rs 1.26 for infrastructure due to be spent by Mar 23. So within a year and a half the Federation has about Rs 1.71 Cr to be spent on infrastructure. Dr Sanjay Gupta suggested to procure an office space/ a piece of land for EFI's office which was discussed and approved earlier. The Secy Gen said that the corpus available was to be spent for growth and development of the sport and the same stands minuted in one of the EC meeting.

Col SS Ahlawat, VSM (Retd) mentioned that the federation should have a permanent office and suggested to procure decent office space for 15 – 20 people at an approx expenditure of 6 – 7 Cr.

The Jt Secy questioned whether the Federations would want its major portion of the funds spent for an office space and exhaust the whole corpus.

Col Tarsem Singh was not in agreement to exhaust the complete corpus on procurement of an office space. He stated that the predecessors of this organisation had put in lot of efforts to make EFI grow from strength to strength and build up whatever was available at present and the EC should not take a decision to exhaust all funds to procure an office space. Vice President (Sports Devp) and Col SS Ahlawat both recommended that an office space should be procured and EFI should have a permanent address. Dr Sanjay Gupta requested to place on record the subject matter for further deliberations.

The Chair suggested that with the Asian Games due next year, the Federation should focus on the Asian Games. Col SS Ahlawat questioned the house as to how the

expenditure of Rs 1.75 crore was planned. Jt Secy said that we would be procuring infrastructure pertaining to conduct of events as recommended by the committee formed in the EC meeting held on 18 Dec 2019 and approved by EC meeting held in 19 Feb 2020. Also, the budget was approved in EC meeting held on 26 Feb 2021 and approved in AGM held on 21 Mar 2021. During the last FY few infrastructure pertaining to events had been procured which had been given to various regional clubs and in the present FY, it is proposed to procure frangible devices for eventing, safety cups. Vice President (Sports Devp) suggested to procure Show Jumping Sets locally manufactured and give them to prominent centres. Jt Secy informed the house that each region would be equipped with a timer machine. Eventing centres would be equipped with francible devices and safety cups and a large number of clubs would be given safety cups for show jumping. Post discussions, Col SS Ahlawat, VSM (Retd) was in agreement with the above. Vice President (Sports Devp) suggested that whatever was available in India should be procured locally and items not available could be approved by foreign vendors.

The Secy Gen informed the house that the Govt had issued a notification wherein Equestrian was one of the sports which the Govt had approved for exemptions under IT Rule 80G. In view of the aforesaid, sponsorship could be received from firms and organisation and in return a certificate could be issued to the donor under the Rules of 80G for which the donor is entitled to claim IT exemptions. The pre-requisite was to apply with 3 years account statement and IT returns which had already been filed.

7. Proposed Budget for FY 2021-22. The Secy Gen displayed the proposed Budget for FY 2021-22. The same is attached at Appendix A.

Col Tarsem Singh brought out that in the previous EC Col SS Ahlawat & Brig Deep Ahlawat had volunteered to meet Ms Neeta Nehlani and resolve the court case. Col SS Ahlawat replied that we could sit and talk provided we had something to offer. Jt Secy requested to take up the matter during the agenda dealing with legal matters and

The EC perused and approved the Budget for financial year 2021-22 with following additional decisions: -

(a) No coaching camp to be conducted in the current year for seniors as well as juniors. The funds allotted by Sports Authority of India (SAI) to be surrendered

requested the house to proceed with the agendas as scheduled.

Vice President (Tech) gueried whether SAI would be providing financial assistance for the trials to which the Jt Secv replied that the entire expenditure for trials have to be borne by the NF which would be approx. 35 lakhs. The Vice President (Fin) requested for the breakdown of Rs 1.70 crore on account. Vice President (Tech) pointed out that the Coaching Camps should be done through SAI and EFI money should not be spent on the same. The Secy Gen informed the house that the coaching camps would be done through SAI finances. However, the expenses on account of foreign coaches have to be borne by the federation as the same has not been approved by SAI.

Col SS Ahlawat suggested that EFI finances should be preserved at this moment. as the same would be required if the federation would require to hire a coach for the Asian Games. Secy Gen clarified that SAI would consider the proposal for hiring a coach once the team is finalised i.e. next financial year. Col SS Ahlawat further gueried whether SAI would pay for the coaches which are approved by the NF. The Secy Gen clarified that the coaching camps under reference are national coaching camps and not Asian Games coaching camps and if we surrender 80 lakhs (Rupees eighty lakhs only) allocated for coaching camps we would be at a loosing end. SAI had approved only 70 lakhs based on last year's expenditure, and the Secy Gen had managed Rs 1.20 Cr under ACTC and an additional amount of Rs 35.5 lakhs for Fouaad's Olympic participation making a total of Rs 1.55 Crore. This included 8 Coaching Camps, 6 for Seniors (i.e @ two per discipline) and one each for SJ & Dressage for Juniors. The policy of SAI stipulates that quantum expended in the previous year would form the basis for allotment for the next FY. In case Rs 80 lakhs (Rupees eighty lakhs only) are surrendered, we would be damaging the financial support system of the NF. For Asian Games additional funds would be given for coaches in the next financial year. The Secv Gen further requested the house not to surrender the amount allocated for the coaching camps. Vice President (Tech) asked for the dates of the coaching camps to which

or re – appropriated for procurement of eqpts.

(b) All procurements to be done through the existing procurement committee.

the Secy Gen informed the house that for Seniors one coaching camp for each disciple of Dressage, Show Jumping and Eventing would be at the start of the season and the second coaching camp before the respective NECs. For the Juniors, Show Jumping coaching camp before JNEC and Dressage coaching camp before Delhi Horse Show. Vice President (Tech) suggested to utilise the services of Indian coaches instead of foreign coaches to which the Vice President (Sports Devp) also expressed his support. Secy Gen clarified that only approx expenditures had been factored into the budget and it was upto the EC to decide whether to utilise the services of foreign/Indian coaches. Vice President (Sports Devp) suggested that for junior coaching camps foreign coaches should not be engaged. Ms Vanita Malhotra, Chairperson Athletes' Commission also suggested to have the coaching camps prior to the start of the particularly before the season, commencement of the trials. The services of Indian coaches could be utilised for juniors and for seniors, foreign coaches could be considered. Col SS Ahlawat said that once an individual is selected as a probable of the team, then efforts would be made to make available the best of coaches. Jt Secv informed the house that for the eventing coaching camp, there was a foreign coach and the coaching camp was oversubscribed. However, for the Show Jumping coaching camp we had a good Indian coach and the same was highly under subscribed as athletes backed out after coming to know about the coach engaged. This implies that the success of a coaching camp is highly dependant on the coach selected. Col Tarsem Singh supported the narrative by the Jt Secy. Col SS Ahlawat queried that if a coaching camp is to be held for seniors then where is it proposed to be held. Secy Gen replied that for each discipline coaching camp per discipline one Bangalore before the trials and then one coaching camp per discipline before the respective NECs i.e Meerut, Mumbai, Meerut. Col SS Ahlawat further gueried as to who all would be eligible to attend the coaching camps before the trials in Bangalore. Secy Gen replied that the participation would be based on previous years rider points for each discipline. Jt Secy said that if the coaching camp are scheduled before the respective trials each athlete competing in the trials

should be included in the coaching camp to provide a level playing field. Col SS Ahlawat rightly agreed. Jt Secy further said that for each disciplines it is not feasible to conduct coaching camp for 50 athletes under one coach. Col SS Ahlawat said that figure may go upto 80-90 also. The Jt Secy said that if a coaching camp is to be held before the trials then all have to be included or none. Vice President (Sports Devp) suggested that in such a situation undue favour should not be given to anyone. Col SS Ahlawat guestioned that the financial assistance given for RELs as mentioned at ser No 15 of the audit report was for one year for development only and not a permanent feature. Vice President (Sports Devp) suggested that the financial assistance for conduct of REL should continue. Col Tarsem Singh highlighted that on most of the issues it was only two-three members only speaking and a decision is taken based on the same and requested all members to contribute and not let the EC be hijacked by anyone. Col Tarsem was asked to give his point if any to which he replied that the pandemic was not over yet and all clubs conducting RELs, are not financially sound like Tollygunge, ARC, and APRC. If funds were available then why not give to clubs which contribute towards the sport. Jt Secy replied that in addition to the REL incentive of Rs 50,000/-, clubs which conducted RELs during the year were allotted an additional amount of Rs 50,000/- as Covid relief fund which was borne by EFI. Col SS Ahlawat said the REL assistance concept was introduced in 2017 for the year 2018 to encourage such events and was again extended for 2018-19 and thereafter continued post the pandemic.

Jt Secy said that the money accumulated for conduct of events need to be expended and hence recommended that the incentive for REL should continue since the total amount on account of this was approx. 10 lakhs only. Col SS Ahlawat informed the house that he was told that the Federation did not have the finances to conduct show jumping trials abroad.

Col SS Ahlawat queried about the Rs 1 crore mentioned at Ser No 19 of the proposed budget to which the Jt Secy replied that the same was allocated for misc expenditure for the Asian Games which would not be

catered/approved through Govt grants since despite all Govt sanctions, the Federation had to spend almost Rs 50 lakhs for misc expenditure which was not covered in the sanction. Vice President (Fin) suggested that the same should be mentioned in the remarks for clarification purpose. Vice President (Sports Devp) queried about the procurement of Show Jumping set. Jt Secy informed the house that quotations were called from Europe and one firm has quoted Rs 35 lakhs for one jumping set inclusive of freight. Vice President (Fin) suggested to procure Indian make jumping sets so that more number could be procured. Chair suggested to procure one imported set and the balance could be procured locally. Vice President (Fin) said the quality of the imported jump set would be superior to the locally procured ones. Col SS Ahlawat suggested that water Jump for Show Jumping, Frangible devices and Safety Cup be procured from abroad since these FEI approved items are not manufactured in India. Dr Sanjay Gupta suggested that a committee be formed amongst EC members to for the procurement to which the Jt Secy replied that a committee as suggested already existed with the members viz Col Jagat Singh, Ms Vanita Malhotra, and Col Mangal Singh. Vice President (Tech) suggested that respective disciple members should decide on items pertaining to their respective disciple but Dr Sanjay Gupta emphasised that any procurement should be undertaken by the existing committee.

### AGENDA - IV

8. New Membership. The Secy Gen displayed the names of all new applicants (Life/Club) desirous to enrol as members of EFI. The list of the applicants were attached at Appendix B.

The house perused the list and approved the membership of the new applicants.

Selection Criteria: 19th Asian Games 9. 2022 and Trials to be conducted by EFI for same, subject to receipt confirmation of Technical Standards for the ibid from AEF. The Secy Gen informed the house that during the AEF General Assembly held on 15 Jul 2021, AEF had agreed to keep the standards of the events of the 19th Asian Games similar to that of the EC Members perused. discussed and deliberated upon the selection criteria. The following decision were recommended by EC: -

previous games but however approval of the FEI was awaited on the same, since most of the FEI officials dealing on the subject matter were engaged for the Tokyo Olympics.

On 15<sup>th</sup>August 2021, AEF had promulgated the technical standards which was forwarded to the Selection Committee on 16 Aug 2021 and based on that the committee had prepared the selection criteria which was tabled for approval. There after the Chair gave a prelude to the drafting of the criteria in which after two to three meetings of the Selection Committee which consisted of five members namely, Lt Gen AJ Singh, AVSM, VSM (Retd), Col Rakesh Nair (Retd), Col SL Reddy (Retd), Dr Sushil Balwada and Lt Col Prateeq Misra, the final criteria as proposed was compiled.

Col SS Ahlawat suggested a few amendments to the criteria wherein the Dressage test for eventing should be on both Test A/B and the competition for Show Jumpina should be on a two round competition. The Secy Gen requested the house to propose whatever amendments felt necessary but at the same time made an appeal to the members to finalise and approve the criteria since time was at premium and one running behind time frames schedule. Chair requested the house to be organised and do a good job so that the criteria is finalised. Chairperson, Athletes' Commission suggested to take up the document page by page.

Col SS Ahlawat suggested to have the Dressage and Show Jumping trials in India as CDN and CSN over two round competition respectively. For trials abroad CDI for Dressage and two round Show Jumping competition for Show Jumping to be organised by EFI with the help of local NFs as per guidelines issued by EFI.

Secy Gen said that Show Jumping trials abroad would cost the Federation approx one crore to which Col SS Ahlawat remarked that the NF had sufficient funds for the same.

Lt Col Raj Sangram Singh, Vice Chairperson, Athletes' Commission suggested that the order of merit for the final selection should be based on the order of merit of the results of the trials.

by Secretariat for recommendation of EC members present at the earliest on email and then forward to Selection Committee for approval.



Secy Gen agreed to forward all the suggested amendments to all EC members by mail by the beginning of the coming week and requested members to confirm the same by 2 - 3 days so that the same could be forwarded to the Selection Committee so that the criteria is rectified, approved and promulgated at the earliest.

Vice Chairperson, Athletes Commission queried whether the criteria would be put up to the AGM for approval to which the Chair of the meeting replied that the same wouldn't be feasible since confirmed dates of the AGM were not available and the criteria needed to be published at the earliest.

10. **Draft EFI Calendar 2021-22**. The Secy Gen flashed the draft EFI Calendar for the year 2021-22 and requested the house to take a decision on coaching camps as included in the calendar.

Secy Gen recommended to discuss the calendar with the first event AEC.

Jt Secy suggested that the dates of the Asian Games trials be finalised and thereafter other events could be filled in appropriately.

Chair suggested to take up the discussion disciple wise and for eventing requested the house to deliberate on the venues and the sequence of events that were planned.

The Chair informed the house that action had already been initiated to activate the EDFZ at Meerut and all stake holders had already been informed. Col Tarsem Singh suggested to have a trial event prior to the Asian Games trials which the house agreed to have at Meerut / New Delhi.

Vice Chairperson, Athletes' Commission apprised the house that during the last EC, a discussion had taken place to consider conduct of 05 trials each at Bangalore, Mumbai and Delhi for Show Jumping and 05 trials each at Bangalore and Delhi for Dressage wherein the jury could move from one location to another with minimum movement of the rider and horses. However after deliberation the house did not agree to conduct 15 trials at 3 venues for

After due deliberation and discussion on the subject the EC was of the opinion that holding of coaching camps prior to the trials would give undue advantage to riders attending coaching camps since all members competing in the trials could not he accommodated in the coaching camps. Hence the EC was of the opinion that coaching camps prior to the trials not to be held. Also, those planned during the season need to be cancelled due to 19th Asian Games trials and issues related to it.

After detailed deliberation and discussion the house was of the opinion that 05 trials be conducted for eventing with the first event at Jaipur, followed by Delhi, then Bangalore, back to Delhi and the last eventing trial at Meerut.

Col SS Ahlawat suggested to procure three water jumps for Bangalore, ARC & AGL for Show Jumping trials.

Secy Gen suggested that a jury be given an opportunity to judge only one event and no jury to be repeated for any event. The same was appreciated by the Athlete's Commission.

The Secy Gen requested the house to finalise the dates of the trials as per the respective venues. Col SS Ahlawat volunteered to finalise the draft and circulate to all EC members for consideration. Col Tarsem Singh appreciated the concern of the Vice Chairperson, Athletes' Commission, towards representing the athletes but at the same time requested the member to keep in mind certain organisational challenges. Gupta appreciated Sanjay the point highlighted by Col Tarsem.

The house after due deliberation agreed to have 1st trial for Show Jumping at EIRS, Bangalore, 2nd and 3rd trial at Mumbai (ARC) and last two trials at Delhi (AGL). For dressage first two trials at Bangalore (ASC Centre & College) and the remaining three trials Delhi at (AGL Stables).

The house agreed to the proposal made by the Secy Gen

After due deliberation decided was that members would forward the date to the Secretariat which would be compiled and sent back to EC members as early as possible to finalise the same.

#### AGENDA - VI

#### 11. Secretary General's Briefing

Olympics 2020 final result. 11.1 Secy Gen apprised about the performance of Mr Fouaad Mirza astride Seigneur Medicott at the 2020 Tokyo Olympic Games. He informed the house that Mr Fouaad Mirza achieved 23rd position with a score of 59.6 penalties.

The Secy Gen informed the house that Rs 25,00,000/- (Rupees twenty five lac only) was awarded by Indian Olympic Association to each NF which had participated in the 2020 Tokyo Olympic Games and one lac to each Olympic Athletes.

- Government Grants : Olympics 11.2 2020. The Secy Gen informed the house that Rs 35,50299/- had been approved by the Govt for the Olympic participation with details as below.

This is with reference to points from our Athletes. Below are our points which we would like to take up for discussion during the EC meet scheduled on 20<sup>th</sup> August 2021. Although some points were already discussed in the previous EC but final decision is still awaited.

#### 1. Finalisation of Calendar 2021-22

- 2. Selection trials for the forthcoming Asian Games 2022 the venues and scheduled dates . It is advisable it is circulated as soon as possible so that the riders can prepare accordingly.
- 3. With reference to the mails from received Mr. Danny Swittens, Mr Rohit Daggar and few other riders requesting that Bangalore not to be the venue for the 1st Eventing trial. Request if this riders request can be considered as their reason is genuine looking at the logistics.
- 4. Selection criteria for the forthcoming Asian Games 2022 be shared as soon as confirmed by the Asian Federation.
  - 5. Conduct of Coaching camps before the trials for preparation of the riders.
  - 6. Athletes Commission SOP to be finalized
  - 7. Rider's participating in trials abroad to declare the chosen events as trials in the beginning of the season. Only in case of Covid restrictions due to travel restrictions, the rider should be permissible to change the trial event. Also if issue by the NF to get an entry for rider then another event can be selected by rider.
  - 8. Restriction on the number of residual trials once a fresh horse is entered by the rider for the selection trails. It should be the same for rider based in India or Abroad.
- 9. The dope test for the abroad entries should be conducted for horses like it is done for horses in India .
  - 10. Riders request for a warm/ practice event be conducted before the trials.
- 11. Request that all grades of Eventing be conducted along with the trials at all the venues.
- 12. In case of few Probables being placed abroad by the EFI at any stage during the trials, the selection of the same should be strictly according to the selection criteria, on the basis of merit only.
- 13 Request to kindly share the warning letter issued to Ms. Viveka Rathore with us so that we can further intimate the federation's action to the respective complainants Ms Sweta Hooda, Mr. Gaurav Pundir and any other complaint on this issue.
- 14. Any other rider points which comes before the EC, would take the permission of the Chair and request if can bring it up.

1- Thank you for your email dated August 12 2021 and putting the matter to the EC for discussion

2- The mentioned reply dated Feb 6, 2021 by the NF was based on inaccurate interpretation of the FEI rule by the NF where the NF had strangely suggested that the FEI rule relates to only "occupied" judges huts where as there is no such distinction anywhere in the FEI DR Article 429.6.1 between occupied versus empty judges huts- this fact was promptly raised in my reply dated Feb 9, 2021 with several related specific questions for which I have no reply till date

- 3- Refer to para 2- 'violation may have occurred'- kindly clarify if this is to mean that the NF is still unsure of the violation despite videographic evidence of a member of public sitting within 10 meters of a dressage arena in violation of FEI DR 429.2, and inside the judges hut with banned equipment per FEI Article 429.6.1?
- 4- While the source of the noise and reason for the horse's multiple spooks during the test only became evident to me when I reviewed my test videos, which cannot be done within 30 minutes of the completion of event causing this observation to be technically time barred, should the NF be repeatedly misusing this unfortunate and genuine limitation to simply ignore such gross negligence on the part of PGJ and the Steward at the biggest national equestrian event, in plain sight at Judge's hut at B? What action is the NF proposing against those responsible for not discharging their duty, either due to negligence or oversight?
- 5- While the NF is refusing to even issue certificates to top three placed riders including myself for this event, does the NF realise its own contribution in the loss of scores for my event due to these distractions on top of pathetic water logged ground conditions, since there is no acknowledgement or apology? Please refer to the video clips already submitted to the NF establishing direct correlation between the spooks and the high speed shutter noises from the judges hut during movements carrying coefficient of 2, meaning 'double loss of scores, times 3 judges', equating to loss of scores in one movement that alone can bring one's total score below merit in one straight shot, leave alone the loss of scores during the entire test in all movements once the horse enters its natural instinct for fight or flight sensing danger which repeatedly is heard from the same corner

6- I welcome the mention of 'good governance and transparency' in your reply, but without any supporting action, the below reply is sadly inconsequential on top of being pending for over half a year!

1- Thank you for your email dated August 12 2021 and putting the matter to the EC for discussion

- 2- Kindly stand corrected that Animal Abuse matters are NOT time barred under FEI rules, that these matters can be reported by anyone including members of the public (unlike other objections that have to be channeled through certain officials), that these matters can be reported whenever these are observed (even if witnessed in a video recording post conclusion of an event), and this fact has been repeatedly made clear to the NF in my past correspondence in the regard, I once again urge you to revisit FEI GR 161.3 for better education of all concerned especially given the serious nature of such matters around animal welfare ie the mainstay of our sport
- 3- Kindly also make note of the fact that as an participating athlete in the same class, it is practically impossible to focus on anything other than ones own preparation and performance. Hence to repeatedly say that this was to be reported at the venue is both unfair and unreasonable. Having said that, for the sake of the horse, I wish I had observed this on ground and somehow cut short the daily cycle of abuse this horse must be enduring at home, and also set an example for others who may be abusing horses
- 4- Kindly note the NF has complete and full freedom to take strictest action against the abuser at any time, no matter how much time has lapsed since the event- a fact fully supported by FEI rules which can be also re verified as necessary. Anything short of this will be raising more questions and doubts
- 5- Therefore the NF is urged to set a precedent in this case of clear animal abuse per FEI Rules, which not only cover any form of discomfort to the horse, but also the mere likelihood of discomfort to the horse, either knowingly or even unknowingly- the relevant rules with the applicable language have already been submitted to the NF in my previous correspondence
- 6- The abuser rider has in writing accepted to the NF / AC that they were 'sitting' on the rein which in itself is enough proof of their abuse and clear violation per FEI Animal Abuse rules, although the reality is worse, in that, in full public view at a national competition ground, this rider was captured in pictures / videos in a position where looking at the saddle flap and the riders leg position, it is clear that the curb rein was tied causing extreme pressure on the horses mouth / pallet , possible injury to head / neck / mouth incase of a spook, and causing pain to the animal right before the competition to impart fresh memory of pain so the horse keeps its head down during the test
- 7- The NF is applauded for finally taking cognisance of this serious matter, however anything as mild as only a warning letter to the rider will prove counter productive and will be against the FEI Rules and spirit of equestrian sport. As custodians of our horses, who rely on us to watch for their welfare, a stricter action is strongly urged by the NF to deter any such attempt by riders in the future

1- Thank you for your email dated 12 August 2021 and for putting up the matter at the last EC

- 2- Kindly share an example of any NF, in any country, in any sport, where the top three placed riders are not recognised for their placing in a sporting competition. Unless there is a precedent, or else a strong compelling argument against recognising the hard work and achievements for both horse and rider for achieving a position, the NF urged to reconsider their verdict
- 3- The merit or cut off percentages are an entirely separate matter which mainly govern the upgradation of horses and serve to set standards for the sport for us athletes to strive and work towards. However if the standard of sport at a given time in the country is such that the top placed athletes werent able to achieve the merit, then this is not cause to de-recognise these athletes in this manner by the NF and negate the time, effort, risk, and expense these athletes incur to pursue this sport and compete
- 4- In common practice, athletes are recognised for even participation leave alone placing, and athletes placing fourth also are routinely felicitated in equestrian competitions worldwide
- 5- It is requested that the EC kindly recognises the above and again deliberate. Any revision to rules to the contrary shall amount to a regressive approach for the sport, will be unfair as a unique exception based on no credible reason hence open to widespread discontent in the athlete community, and only serve to discourage and dissuade athletes who want to constantly improving with the help of some positive encouragement along the way

I am writing to you in regard to the below copied email of Col. Sarpartap Singh. This subject of State Teams and the issuance of EFI certificates has long been raised by me at all levels of the EFI functionary. Unfortunately till date the matter has not been resolved in the interest of the participants for reasons best known to the EFI officials.

I once again for the last time submit my points as under:--

- 1. In all National Championships in all sports, the State Teams participate through their State Association duly sanctioned by the respective State Councils after due selections from State championships.
- 2. The State team players at the Nationals if achieve any position get cash awards from the respective State Governments.
- 3. The State team medal winners are also eligible for out of turn government jobs as per the criteria of the sport categorization by the MYAS.
- 4. Some State Governments have reserved certain percentage of seats in government services if the player represents the State at the Nationals.



- 5. The State teams are eligible to get TA / DA from the State Sports Councils for taking part in the Nationals.
- 6. The REL system seems to have been introduced by the EFI to curtail participants at the Nationals. This can be done away with if the teams are selected by the State associations. The existing REL system of 2 participation is a costly affair for riders and it is encouraging the host clubs to use unfair means to select their members for the Nationals. This REL system should be discussed with the State Associations.

The States which do not have a State Association at present should hold a selection trail under the State Sports Council and select the team to represent the concerned State, which will enable the riders to avail the State Government benefits.

The EFI is the only federation in the country which allows clubs to participate at the National level. The club participants get no benefit from the State Government.

The certificates issued by the EFI to National participants do not have the name of the team from which the player has participated. This allows the club and army riders to falsely apply to the State Governments for the above benefits and the State Associations are called upon to verify the certificates, thereby causing conflict in the States among the participants and officials.

I once again request the EC members to discuss this issue and find a way to resolve the same in the interest of the riders.

I am addressing this to all the EC members with a hope that they will take this up in their next meeting.

At the 59th AGM I had raised an issue on the NOC given by the EFI to overseas Indian riders who are working abroad and participating in equestrian events under the name and flag of India. The EFI is charging US \$ 500 per NOC and has in the year 2019-20 received in the Federation account a sum of Rs. 1,75,19,797.59.

These riders are participating in overseas events without taking part in any National Championship in India. This seems very unfair to Indian riders who are working very hard in the country to qualify to participate under the name and flag of India at International events.

Your reply was that NOC is not given to participate under the name and flag of India. This is not understood.

A NO OBJECTION CERTIFICATE if asked for and issued by a National Federation would mean that the person is authorised by the Federation to use the name of India.

If this is not authorised than why would a person ask for the NOC. He should be able to participate overseas from any club or from where he works without the name of India.

I may point out to you the High Court rulings and rules of the MYAS which totally prohibit such participation. This needs to be reconsidered in the next EC and AGM for further clarification for the future.

She is desirous of replacing the horses mentioned at serial number 1 and 2 of the import license no. 0519243176 dated 16/10/2020 with miniature horses from Germany. In fact, Serial no 3 of the existing license is for a miniature horse. Miniature or smaller size horses are an important part of sport horses from the therapeutic and psychological point of view. They are used as companions for high strung talented sport horses for better and enhanced performance as they calm the extremely sensitive sport horses. They are extremely significant because of their nerve calming effects .They also help riders therapeutically. Many of the foreign rider athletes are successfully using miniature horses to enhance their performance. In Equestrian sport , the horse is the main athlete and keeping him in a good mental is as important as the physical state. To compete with them we need to support our rider athletes as well and allow the import and use of miniature horses. Because of their size they can comfortably travel in the same box as the main horse.



# Subject: The World Cup Qualifiers Tournament that was held in India March 2021

At the beginning, we thank you very much for your efforts to improve the sport of Tent Pegging in India.

Reference to the above subject, we would like to inform you that the ITPF Board have formed a committee to investigate further on the incident that took place with the Nepalese Team at the WC Qualifiers and the decision of the Board is as follows, kindly note that this decision was Unanimously agreed by all the BOD members:

- 1- Suspension of the competitors who represented the Nepal team (Indian passport holders) from participating in local and international competitions for a period of 24 months starting from 29 June 2021, and the Indian Federation shall follow up on this.
- 2- The Indian Equestrian Federation should write a letter of apology to the International Tent Pegging Federation, which stated that is has not abided by the legal procedures followed internationally before the start of the competition and to verify the passports of the participants.

In the event of no response from Indian Equestrian Federation within 21 days, the WC Qualifier in India will be canceled, and the Qualifiers will be repeated with the participation of all countries according to the previously approved schedule.

Off-course mistakes do happen, and as a normal practice during such qualifiers & major championships the ITPF always sends a Technical Supervisor to overlook the overall championship and make sure that everything is following the standard protocol, unfortunately in the WCQ in India this did not happen as our Representitive could not travel due to the Covid restrictions his country imposed on travellers while returning back.

With the issue in hand and of Nepal, the ITPF's official Representitive for Nepal is/was Mr. Ashutosh Mishra, and he has been active since 2019.

We have found out now, that he is not the official representative only after this Qualifier and that although he was introduced to us by an Asian NF as the Representitive of Nepal, he provided us fake credentials towards his application.

Going forward is what we aim for and thrive, and from this issue a good outcome has come out and we are now in coordination with the officials in Nepal Equestrian Federation and thanks to your assistance they have approached us and we will be finalising their application and considering the previous application sent by the late Mr. Ashutosh Null & Void..

We are at the ITPF thinking along this route, an opinion to disqualify the results of the team whom participated in India under the so called Nepalese Team, players whom participated under a different country will be stopped for x years from international events, how did the OC overlook or accepted involving such players without authentication, but yet we are awaiting the full reports from India, Mr. Mansoor & Mr. Rafat Bella, and then for the concerned committee to send the final report to the President with the findings to take the final decision by the BOD of ITPF.

Looking at it from a bigger picture and considering the Covid situation and the efforts that the NF & OC has put to make this tournament a success with making sure that 4 countries from Group B1 participated that will allow india to qualify to the WC Finals and awaiting the other Group B2 one team to qualify alongside with India representing Group B.
