- 3. Opening Address by the Vice-President (Adm):- The Vice-President (Adm) welcomed all the members. He further expressed his opinion that all should participate in the proceedings with open mind and without inhibition as this forum is basically for improvement of the equestrian sports in India.

- 4. Agenda-I: Progress on last EC Minutes Points and Passing of Minutes.
 - 4.1 <u>Promotion of Equestrian Sports in India/NE India</u>:- The Secretary General informed the house that FEI Solidarity Officer visited India wef 09 Apr to 12 Apr 2015 and the report is being submitted to FEI soon.
 - 4.2 <u>Court Case: Mr Angad Sahlot v/s Uoi & Others</u>: The Secretary Gen informed that the NF advocate appeared on our behalf on 17 Apr 2015 at Delhi High Court. However, the Hon'ble court has adjourned the matter and now listed the case for hearing on 11 Sep 2015
 - 4.3 <u>17th Asian Games</u>: The Secy Gen informed the house that claim of Rs 1,13,99,260/- is still pending with IOA. After a meeting with Secy Gen (IOA) on 23 May 2015, it was informed that the claim forwarded by all NFs are under audit at their HQ, the same will be cleared once the audit is carried out by IOA.
