SALIENT POINTS OF SELECTION CRITERIA	
➤	Duration of trials – 01 Aug 2017 to 31 May 2018 - Para-3.
➤	In case change in criteria of the Asian Games the selection criteria will be revised - Para-4.
➤	Para 11 to 15 - specific to conduct of trials in India.
➤	Para 16 to 20 - Specific to conduct of trials riders based abroad.
➤	Para 14 - To equate all the riders participating in trials in India and abroad the least aggregate of the penalties of the three selection trials in order of merit will count towards the selection of team / indl members. Any score more than 53 penalties (including time penalties) will not be counted towards selection. For indl selection a score less than 45 total penalties will be considered
➤	Dressage. Any trial less than qualifying % will not be considered i.e. 67% for Team & 70% for Indl - Para 11.

SALIENT POINTS OF SELECTION CRITERIA	
➤	Show Jumping. Trials with 04 penalty and below (including time penalty) will only be considered - Para -12.
➤	Eventing. Any score more than 53 penalties (including time penalty) will not be counted - Para 14.
➤	Technical standards and specification for all trials in all discipline for riders/ horses abroad will be same as standards for riders/horses in India - Para 17 (a).
✓	Technical Standard for Dressage. ▪ Team – PSG- Qualifying score of 67% ▪ Indl – Inter-I & Inter-I (FS to music)- Qualifying score 70%
✓	Technical standard for Eventing. ▪ Team – CCI* (Qualifying score of 53 including time penalty) ▪ Indl – CCI* (Qualifying score less than 45 penalty)
✓	Technical standard for Show Jumping. ▪ Team - 1.40m (Qualifying score less than 04 penalties incl time penalties) ▪ Indl - 1.50m (Qualifying score less than 04 penalties incl time penalties)



SALIENT POINTS OF SELECTION CRITERIA (CONTD)



- **Type of Event for rider based abroad - Para-17(a)**
 - ✓ **Dressage** – **CDI/CDN (Amended later)**
 - ✓ **Eventing** – **CCI* (National Championship deleted)**
 - ✓ **Show Jumping** – **CSI*/National Events (Amended later)**



SALIENT POINTS OF SELECTION CRITERIA



- **15 Days of advance notice before each trial - Para 17(f).**
- **Riders requesting for additional/exclusive trial are not acceptable - Para 19(a).**
- **Consent letter from the owner/lease stating that the horse will be made available to the rider and National Federation to be fielded as an Indian entry in Asian Games is required to be sent by 31 May 2018.**
- **Selection of 06 probable riders for each discipline (only those who have achieved required qualification).**
- **Following officials will be selected :-**
 - ✓ **Indian coach for each discipline.**
 - ✓ **Manager**
 - ✓ **Vet Doctor**
 - ✓ **Asst Vet Doctor**
 - ✓ **Quarantine protocol officer**
 - ✓ **Farrier**
 - ✓ **Indian Equestrian Team Manager.**



SALIENT POINTS OF SELECTION CRITERIA



- Post selection of probables, the order of merit shall be sacrosanct unless there is steep drop in performance during coaching camps or the horse/rider become unfit due to some unforeseen circumstance. However under no circumstances will the coach give one horse to another rider without the consent of the selection committee who will also take the views of the original rider, other team members, foreign and Indian coach before taking the final decision.



SALIENT POINTS OF SELECTION CRITERIA



- All selected probables for all the disciplines will be considered as probables till Selection Committee in consultation with Indian and foreign coaches for each discipline again reviews the entire selection process before submission of definite entry. Fitness of riders and horses, horse-rider combination, performance during camps and original merit will be of paramount importance and will be taken into consideration for final selection of individuals/teams. The entire selection process will be reviewed by the selection committee in consultation with coaches, vet doctor and executive committee before definite/confirmed entries are forwarded to organizing committee of the Asian Games in order to ensure best teams/individuals are selected to win medals for the country. In case of a change in original merit of team/indl entries, the selection committee will be bound to endorse complete justification on selection/weeding out of a horse-rider combination.



SALIENT POINTS OF SELECTION CRITERIA



- **Note:** EFI reserves the rights to amend its selection criteria as necessary, particularly where there is a change to the qualification system or circumstances affecting the nomination/entries process – Para 34.

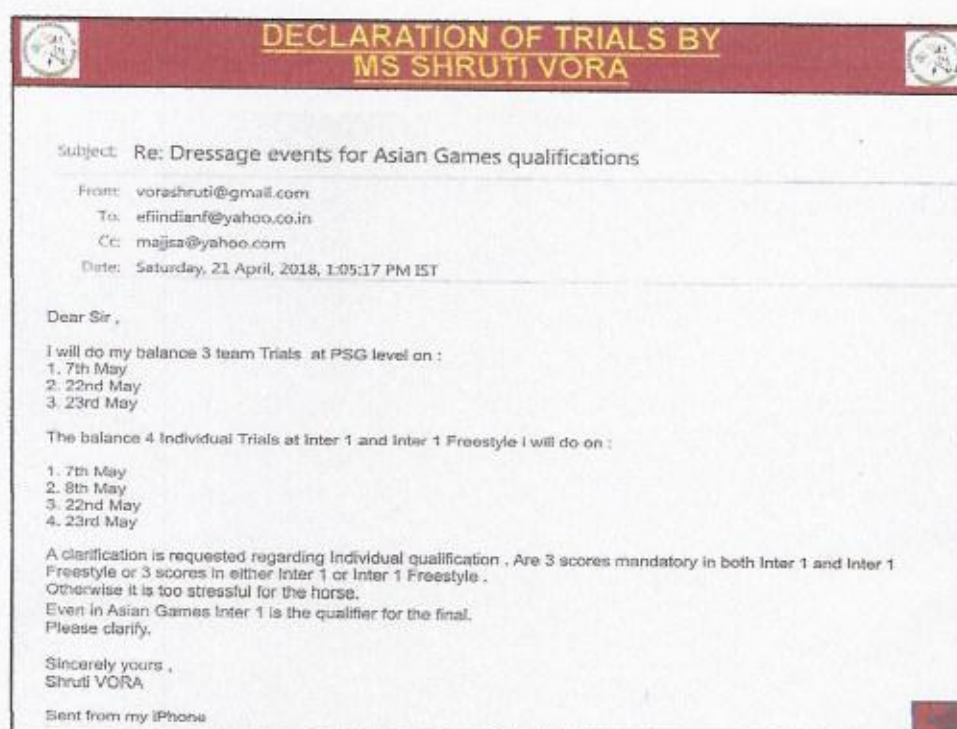
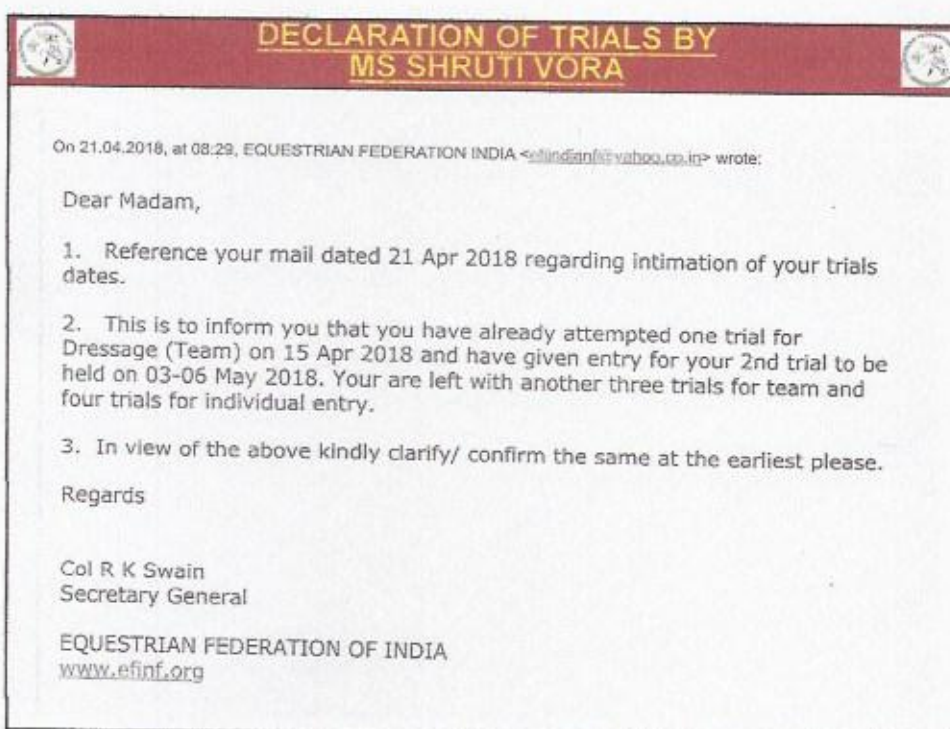

- 1) The trial was conducted under the supervision of Paul Engel, General Secretary of the Luxembourgish Equestrian Federation.
- 2) The trial was not part of a National Championship but organised by the national equestrian federation of Luxembourg following the EFI trial guidelines.
- 3) The course was designed by FEI course designer Kai Olsch and the EFI trial specifications were checked by myself and Paul Engel.
- 4) There was a 3 member jury consisting of one FEI judge and one Technical delegate which was again Paul Engel.
- 5) Two riders DNS as they claimed to have received qualification in similar trials before this.
- 6) The riders conveyed that there were no events in Europe where they could ride two rounds on the same day.
