GENERAL INFORMATION

1. The **Regional Equestrian League (REL)** will be conducted according to the EFI guidelines and relevant FEI rules by Elite Sports Academy at the Gurukul Horse Riding Club, Ghaziabad as per programme enclosed. The dates are as under:-

- (a) REL – Tent Pegging : 22 November 2019
- (b) REL – Show Jumping : 26 – 27 November 2019

2. **Schedule of Event:** Details are given at Appendix “A”.

3. **EFI HORSES PASSPORT:** As per EFI rules all horses participating in the Regional Equestrian League events must have a valid EFI passport in original. Entries will not be accepted without the EFI Registration/Passport/Show Number of the horse.

4. **EFI RIDER REGISTRATION:**

(a) All riders participating in the Regional Equestrian League must have a valid EFI Rider Identification Number.

(b) Riders not having EFI rider ID No. will not be permitted to participate.

5. **CHANGE OF HORSE/RIDER:** A horse/rider can be changed only up to two hours prior to the draw of lots of the event. However the entry shall be treated as a post entry.

6. **Entries :-** (a) All entries will be on a proper Entry Form as given in Appendix “B”.

Entries not on the prescribed entry form or entry form not accompanied with entry fee will not be considered. ALL ENTRIES FOR JUNIOR RIDERS AND CHILDREN RIDERS MUST BE ACCOMPANIED BY BIRTH CERTIFICATES/AADHAAR CARD.

(b) **Entry Fee :-**

(i) **Team Events** : Rs. 1000/- per team

(ii) **Individual Events** : Rs. 500/- per exhibit

(c) **Closing Date for Entries** : Entries will close by 20 November 2019. Entries received thereafter will be regarded as POST ENTRIES. No entry will be accepted without an entry fee.

(d) **Post Entries:** Post entries will be accepted twenty four hours before the event. Post entry fee will be :

(i) **Team Events** : Rs. 2,000/- per team



(ii) Individual Events : Rs. 1000/- per exhibit

(e) **Description and Registration of Horses:** All entries must give the description, EFI Registration No., grading and name of the horse concerned. The name of the rider will be given for all mounted classes.

7. **Payments:** All entries must be paid in cash or by cheque/DD in favour of :- "Elite Sports Academy" payable at Noida.

8. **Withdrawal of Entry :-** The Entry fee of a horse entered for any event will not be refunded if the horse/rider does not participate in the class.

9. **Cancellation:** The Organising Committee may cancel any class which has less than four entries, or for any reason at their discretion. In that case, the entry fee will be refunded.

10. **Eliminations:** Eliminations may be held depending on the number of entries received

11. **Reporting for Each Class:** All horses will report to the Collecting Ring Steward half an hour before the time of judging of the class. Any entry not reporting in time will be eliminated.

12. **Appeal:** Appeal can be lodged by competitors within one hour before the commencement of any class and within one hour after announcement of the result. A fee of Rs. 2000/(Rupees Two Thousand only) should be deposited with the Organising Secretary – Regional Equestrian League 2019, along with the objection. Money will be refunded if the objection is upheld.

13. **Responsibility:** The Organising Committee accepts no responsibility for any loss, damage or injury to any animal or any other property or the exhibitors themselves. Neither the Committee nor the Doctor will be held responsible for any first aid or other medical treatment provided .

14. **Cruelty to Animals:** The judges are empowered to disqualify the competitors at any stage of the competition for rough handling, excessive brutality or any form of cruelty to animals. Rapping will be severely penalized.

15. **Whips/Spurs:** As per EFI and relevant FEI rules per discipline.

16. **Grading of Horses:** It will be the responsibility of the riders/clubs/units to ensure that their horses are entered in the correct grade as per the latest updated list. Entry of the horse in the wrong grade will entail elimination from that event.

17. DRESS CODE, TACKS, WHIPS AND SPURS :

As per EFI guidelines and relevant FEI rules.

- i) For Show Jumping, riders may present themselves in Breeches and Club T-shirts/ open collar, however Helmets are mandatory.
- ii) GAG BIT is prohibited in all the event
- iii) For Tent Pegging – Club T-Shirt, Breeches, Riding Boots and Helmet.

CAMPING:

Camp: The camping space for horses and grooms of all participants will be available at the Gurukul Horse Riding Club, Ghaziabad for the entire duration of REL 2019. All Riders / Units must bring their Own Tentage.

Those riders / Units not bringing their own Tentage may request the Camp Commandant for the same, at least one week in advance on payment basis.

Self Containment: All teams coming to participate in the REL 2019 must be self contained i.e they should bring their own tentage, equipment for camping, cooks and transport, etc.

Canteen & Mess Facility will also be available at the Venue for Breakfast/Lunch/Dinner and other Refreshments on payment basis.

Ration/Fodder: All participants are advised to bring maximum quantity of grain/fodder to sustain their horses during their stay in Ghaziabad (U.P).

Coggin and Glander Tests: All rules and instructions issued from the EFI on the subject will be strictly adhered to by all concerned. All horses must produce a valid negative EIA and Glander status (CFT) certificate on arrival to Ghaziabad. Coggins and Glanders negative certificate with a validity of a minimum of 10 days on arrival and exist of horses from the camp is mandatory.

Security Deposit: There is No Security Deposit for all contingents temporarily stabling at the Gurukul Horse Riding Club, Ghaziabad.
