REGIONAL EQUESTRIAN LEAGUE PROSPECTUS

General

1. The Regional Equestrian League (Show Jumping) 2020., will be conducted on November 7th 2020 as per the rules of the Equestrian Federation of India at HESA Stables in Mohali.
2. **Entry fees** for riders participating in Regional Equestrian League 2020, Show Jumping:-
 - (a) **Entry fees:** INR 500
 - (b) **Post entry:** INR 1000

ADMINISTRATION INSTRUCTION

3. **Venue.** All events will be held at The HESA Stables, Village Makkran Mohali,Punjab. For directions/Google map –Call-+918872881612.
4. **Camp.** All horses will be stabled at The HESA Stables, Mohali. All horse handlers are permitted to stay along with the horses in temporary accommodation. All teams are requested to share the number of horses/ handlers per contingent, which are likely to come latest by **4th November, 2020** with the show secretary via E- mail.

5. **Self-containment.** In addition to the above all teams must be self-contained in terms of tentage, equipment for camping and transport in order to be prepared for any unforeseen emergency.
6. **Ration /Fodder.** All teams should bring their own feed, hay, bedding, grass, etc. for their horses and should make their own provision for staff food. HESA stables will not provide any assistance for the above unless special facilities are being provided for all teams.
7. **Coggin's and Glanders Test.** All rules and instructions issued from the EFI on this subject will be strictly adhered to by all participating teams. All teams must produce a valid negative EIA and Glanders status certificate on arrival with a validity advised by the governing authorities.
8. **Veterinary commission.** The Veterinary Commission detailed by Equestrian Federation of India, HESA Stables for Regional Equestrian League will have the right to examine all the horses participating.
9. **Medical cover.** The organizing committee shall not accept any liability for medical treatment given to a competitor on the venue or the consequences there of. Each rider participating in the Regional Equestrian League will fill the Indemnity Bond attached as and submit the same along with entry form.

10. **Insurance.** The organizing committee recommends units/club/associations to take insurance policies for competitors, personnel, grooms and horses for their transportation to HESA Stables and during the conduct of the events. The organizing committee will assume no responsibility for any accident or illness due to fall of any horse, competitors, groom/ any other member of the team.

11. **Responsibility.** The organizing committee accepts no responsibility for any loss, damage or injury to any animal or any other property or the exhibitors themselves.

12. **Clearance Certificate.** Horse owners are required to obtain clearance certificate from the OC during work hours. All concerned accounts need to be cleared before they can obtain the same. No horses/ Person will be allowed to leave by the Camp In-charge without the clearance certificate.

14. **Note:** The organizing committee may at any time alter/ amend any of the above conditions owing to unforeseen circumstances.

15. **COVID-19 Protocol.** In light of the COVID-19 pandemic, strict protocols and guidelines must be followed in order to ensure a safe and successful conduct of the event. The guidelines for resuming equestrian training and competition activities in a COVID-19 environment issued by the EFI will be strictly adhered to.

TECHNICAL INSTRUCTIONS

17. **Technical Conduct.** Regional Equestrian League (REL) at HESA, Mohali will be conducted as per EFI's REL Guidelines 2020 and relevant rules of FEI/EFI Technical Guidelines.

18. **Schedule of Tentative Events for REL.** Refer attached schedule.

19. **Entries.**

(a) All entries will be on proper Entry Form as attached for the Regional Equestrian League and should be completed in all respect. Entries not on the prescribed entry form will not be considered.

(b) **Entry Fee:** INR 500

(c) **Closing date for Entries** All entries for the Regional Equestrian League will closed by **November 4th 2020**. Entries received thereafter will not be accepted under any circumstances.

(d) **Description and Registration of Horses.** All entries must give the description, EFI Registration/Passport/Show Number, name and year of birth of the horse concerned.

20. **EFI Horses Passport.**

As per EFI rules all horses participating in the Regional Equestrian League events must have a valid EFI passport in original. Entries will not be accepted without the EFI Registration/Passport/Show Number of the horse.

21. **EFI Rider Registration.**

(a) All riders participating in the Regional Equestrian League must have a valid EFI Rider Identification Number.

(b) Riders not having renewed EFI rider ID No. will not be permitted to participate.

22. **Grading of Horses.** It will be the responsibility of the participant to ensure that their horses are entered in the correct grade as per the latest updated list. Entries of the horses in the wrong grade will lead to elimination from that event and disqualification from the entire horse show.

23. **Withdrawal, Change, Transfer or Substitutions of Entry.**

(a) **Withdrawal.** The entry fee of a horse will not be refunded if the horse does not participate in the class.

(b) **Transfer and Substitutions.** A horse cannot be transferred from one class to another without paying an additional entry fee for the class to which is transferred. A horse once entered in any event cannot be substituted by another horse for any reason whatsoever.

(c) **Change of Riders.** Riders cannot be changed unless the Jury accepts that there are sufficient reasons for change of riders. All changes will be treated as Fresh Entries. Once an event has started, being judged, no change in rider / horse will be accepted.

(d) **Technical specification of events.** The events will follow broadly the EFI REL Guidelines and EFI Technical guidelines as per relevant discipline. However, the organizing committee reserves the right to amend technical specifications for various events keeping in consideration prevalent weather conditions and local merits / climate in consultations with EFI.

24. **Cancellation or reschedule.** The Organizing committee may cancel or reschedule any class which has less than four entries or for any reason at their discretion. In that case, the entry fee will be refunded. However, depending on the numbers of entries received, the organizing committee may decide against this for any particular event.

25. **Reporting for Each Class:** All horses will report to the collecting ring Steward half an hour before the time of judging of the class. Any entry not reporting in time will be eliminated unless the exhibitor shows good cause for the delay. The Ring Steward has full authority to take disciplinary action.
26. **Show Number.** All horses will display the EFI Registration Number on the bridle during competition and veterinary inspection and whenever taken out of the stable under the saddle.
27. **Abuse/ Cruelty to horses.** Refer to relevant rules of EFI /FEI Technical guidelines.
28. **Rosettes.** A horse will wear no rosettes during judging.
29. **Elimination / Disqualification.** The judges are empowered to disqualify the competitors at any stage of the competition for rough handling, or any type of cruelty to animals. Rapping will be severely penalized.
30. **Whips/spurs.** As per relevant EFI /FEI rules per discipline.
31. **Dress code.** As per EFI guidelines.
32. **Appeal.** Any competitor can lodge an appeal two hours before the commencement of any class and within half an hour after announcement of the result. A fee of Rs 2000/- (Rupees two thousand only) should be deposited with the show secretary along with the objection in writing. Money will be refunded if the objection is upheld.

DECLARATION (INDEMNITY BOND)
