COVID 19 PROTOCOL

1. In light of the COVID-19 pandemic, strict protocols and guidelines must be followed in order to ensure a safe and successful conduct of the event. The guidelines for resuming equestrian training and competition activities in a COVID-19 environment issued by the EFI will be strictly adhered to.
2. Wearing a mask at all times in ground, camp, show office etc. is mandatory.
3. All riders, grooms, horse owners, competitors, spectators and parents must carry sanitizes at all times.
4. A hand wash sink along with antiseptic soap will be provided by organizers. All riders, grooms, horse owners, competitors, spectators and parents are advised to wash their hands properly.
5. All riders, grooms, horse owners, competitors, spectators and parents are requested to maintain a proper distance between each other in camp, ground show office and during the competition.
6. All riders, grooms, horse owners, competitors, spectators and parents are requested to kindly follow guidelines of State/Centre Govt. for COVID19.

INTRODUCTION

ADMINISTRATIVE AND TECHNICAL INSTRUCTION

1. **VENUE:** Regional Equestrian League (REL) will be held at The Punjab Public School, Nabha on 01st December, 2020 **as per EFI guidelines for REL.**
2. **ENTRIES:**
 - (i) Entry fee for REL will be Rs. 500 per exhibit.
 - (ii) All Entries will be made on the entry form attached as Appendix II and will be as per the EFI technical guidelines.
 - (iii) No entry will be accepted without an entry fee.
 - (iv) Payment: All entries must be made to the Show Secretary at the show office.
 - (v) No entry will be accepted after the Draw of Lots.
 - (vi) No entry fees will be refunded once deposit.
3. **CLOSING DATE FOR RECEIPT OF ENTRIES:**

All Entries must be submitted on or before 30th November, 2020 (05.00 PM)

Note:- After the closing date all entries will be accepted as POST ENTRIES, which will be double of the normal entry for the particular event.
4. **ELIGIBILITY for the RIDER:-**
 - (a) To participate in the REL Rider's EFI ID No. is mandatory.
 - (b) No entry will be accepted without EFI's valid/renewed Rider ID.
 - (c) Other eligibility for riders will be as per FEI/EFI guidelines.
5. **REGISTRATION OF HORSES :-**

All Horses participating in the Regional Equestrian League (REL) must be registered with EFI and registration No. allotted by EFI must be tie on bridle of horse, during participation and when the horse moves out of the stables/camping area during stay at Championship. No horse is allowed to participate without EFI horse registration.
6. **ROSETTES**

No rosettes will be worn by a horse during judging.
7. **ELIMINATION/DISQUALIFICATION**

The judges are empowered to disqualify the competitors at any stage of the competition for rough handling, excessive brutality or any form of cruelty to animals. Rapping will be severely penalised. Please refer relevant EFI and FEI rules.
8. **WHIPS/SPURS**

As per EFI and relevant FEI rules per discipline

8. **CAMP**

(a) The camp will be located adjacent to the Equestrian Grounds. The Camp In-charge will earmark the site for each contingent. The Camp will become operational on 30th November, 2020 and will be closed on 02nd December, 2020.

(b) Horses, riders, grooms/farriers coming to participate in Regional Equestrian League will stay in the camping area. No team will be allowed to enter the camping area before 30th November, 2020.

(c) Advance information about the number of participants/ horses must be conveyed to the organizers by 29th November, 2020 so as to finalize camping arrangements.

9. **SELF CONTAINMENT:**

All teams coming to participate in the Regional Equestrian League (REL) must be **self-contained**, i.e. they should bring their own equipment, tent, feed, fodder, cooks, farriers and transport etc.

10. **CLIMATE:**

The climate in the month of December is cold in Nabha. Participants are advised to make requisite arrangements.

11. **LIGHTING:**

The participants are requested to bring their own Hurricane Lanterns/ Petromax Lamps for emergency use. Power / light will be provided under camp arrangements where feasible.

12. **DISCIPLINE:**

All the participants staying in the camp will be under the camp in-charge for the purpose of discipline.

13. **FIRE PRECAUTIONS:**

All the participants are required to undertake fire-fighting precaution in their respective areas.

14. **SANITATION AND HYGEINE:**

All participants should observe proper sanitation and hygienic measures. There should be proper disposal of litter at pre designated location.

15. **MEDICAL ASSISTANCE:**

Medical assistance will be provided at the camp site and competition area.

16. **VETERINARY ASSISTANCE:**

Veterinary assistance will be available at the Camp site and competition area.

17. **RESPONSIBILITY:**

The organizing committee accepts no responsibility for any injury or loss to entrant/competitor through accident or any other cause. Neither the organizers nor the vet / medico will be held responsible for the consequences of the first aid or other medical treatment given to any injured horse or rider.

18. **DRESS CODE:**

Riders Dress Code & tack of horse will be as per FEI/EFI Guidelines.

19. **COGGIN's & MALLEIN TEST:**

All participating horses must possess a negative Coggins & Glanders (CFT) Test Report. No horse will be allowed inside the camping area without valid Coggins & Mallein (CFT) test reports.

20. **SPECTATORS/OUTSIDE ASSISTANCE:**

The spectators or the supporters of the participants are not to interfere with the Judges. The Arena Steward has the right to eliminate any participant who has outside help. Once the event has commenced, all spectators and helpers are to clear the arena. The Judges' decision will be final. Parents must not enter the arena or dispute the decision or confront the Judges.

21. **VETERINARY INSPECTION:**

All participants for the Regional Equestrian League (REL) are required to present their horses for veterinary inspection (Trotting Parade) on 1st December, 2020 at 9:00 AM in the competition grounds along with a copy of the Coggins & Glanders (CFT) Test report and EFI passports of the horses.

22. **CONDUCT RULES:**

- (a) The events will be conducted & adjudged as per rules of EFI (Equestrian Federation of India)
- (b) The events are judged by the panel of judges who are experts in the field of equestrian sports.
- (c) The decision of the jury will be final.

23. **OBJECTIONS:**

- (a) Objections may only be lodged by owner or person responsible for horses taking part in the event.
- (b) The objections must be lodged within half an hour of the result announced.
- (c) A deposit of Rs 2000/- must accompany all objections in regard to any matter during the REL.

24. **MISCELLANEOUS:**

- (a) Any questions arise not provided for, it must be referred to the Jury, whose decisions will be final.
- (b) Scheduling time and entries are subject to alteration at the discretion of the organizing committee.
