REGIONAL EQUESTRIAN LEAGUE (REL) FOR JNEC-2020

TECH & ADM INSTRS

1. **General.** **REL for JNEC-2020** will be held with effect from 28 Oct to 1 Nov 2020 at the, Sagar Equestrian Sports Academy, Gajadharpur, Jaipur, under the aegis of REL & Tech guidelines & rules/regulations of the Equestrian Federation of India. All participants are advised to go through the latest EFI REL Guidelines, technical guidelines, rules, regulations and specification, before the event, irrespective of the extract reproduced in this prospectus.

2. **Tentative Programme.** Refer **Appendix 'A'**

3. **Entries.**

(a) All entries must be on the prescribed Entry form given in **Appendix 'B'** and should be completed in all respects. Entries not in the prescribed entry form and not accompanied by the entry fee will not be considered. All entries for **REL for JNEC-2020** must be accompanied by proof of age (birth certificate). All entries must be EFI horse passport number description, EFI registration number & name of the horse concerned & Rider's EFI I.D.

(b) Entries must be sent to the Show office, Sagar Equestrian Sports Academy, Gajadharpur, Jaipur. To facilitate processing of the data please also email a copy of the entries to sagarequestianacademy@gmail.com

4. **Entry Fee.**

(a) The entry fee will be as under:-

(i) Individual Events- Rs-500/- per entry + 18% GST

(ii) Team Events Rs. 1000/- Per Team + 18% GST

(iii) No Entry will be accepted without the prescribed fee.

(b) **Closing Date for Entries.** Entries will close by 12:00 hours on 27 Oct 2020. Entries received thereafter will be regarded as POST ENTRIES. However, post entries will be accepted up to one hour before the draw of lots for each event. No entries will be accepted thereafter. Post entry fee will be:-

(i) Individual Events Rs. 1000/- per exhibit.

(ii) Team events Rs. 2000/- Per Team

5. **EFI Horses Passport.**

(a) As per EFI rules all horses participating in the **REL for JNEC-2020** have to be in possession of EFI passport.

(b) No entry will be accepted without valid EFI Hors Passport. For further information pertaining to registration, contact EFI. Please register the horses participating in the event with the EFI prior to the event.

6. **REGISTRATION OF RIDERS WITH EFI .**

(a) As per EFI rulings all Riders participating in the EFI Events have to be registered with the EFI.

(b) Entries will not be accepted without Valid /RENEWED/ ACTIVE EFI registration number.

(c) All the riders, participating in the EFI recognized events should be in possession of Renewed EFI identity number in 2020.

7. **Withdrawal, Change, Transfer or Substitutions of Entry.**

(a) **Withdrawal**- The entry fee of a horse entered for any category will not be refunded if the horse does not participate in the class.

(b) **Transfer and Substitutions** – A horse cannot be transferred from one class to another without paying an additional entry fee for the class to which it is transferred. A horse once entered in any category cannot be substituted by another horse for any reason whatsoever.

(c) **Change of Riders** – Riders cannot be changed unless the jury accepts that there are sufficient reasons for change of riders. Once a class has started being judged, no change in rider will be accepted.

(d) All changes will be treated as post entries.

8. **Cancellation**- The organizing Committee may cancel any class which has less than four entries or for any reason at their discretion. In that case, the entry fee will be refunded.

9. The class will start once the draw of lots for the order of start has been held.

10. **Show Number** – All horses will display the EFI registration number on the bridle during competition and veterinary inspection and whenever taken out from the stable.

11. **Elimination/Disqualification** – The judges are empowered to disqualify the competitors at any stage of the competition for rough handling, excessive brutality or any form of cruelty to animal. Rapping will be severely penalized.

12. **Whips/Spurs.** As per EFI rules on the subject.

13. **Dress Code.** As per EFI rules on the subject.

14. **Appeal.** Appeal can be lodged by competitors with two hours before the commencement of any class and within an hour announcement of the result. A fee of Rs. 2000/- (Rupees Two Thousands only) should be deposited with the show secretary. SESA along with the objection. Money will be refunded if the objection is upheld. The class has commenced once the draw of lots has been held.

15. **Medical Cover.** SESA will provide medical cover for riders at the venue. SESA will not accept any liability for medical treatment given to a rider on the venue or the consequences hospital where necessary, through every possible means available. Each rider participating in the **REL for JNEC-2020** will fill the indemnity Bond attached at **Appendix C** and submit the same along with entry form.

16. **Insurance.** The Organizer recommends that units/clubs/associations/schools to take Insurance policies for competitors, personnel, grooms and horses for their transportation to Jaipur during the events. The Organizer will not assume responsibility for any accident or illness due to fail of any horse, competitors, groom/ any other member of the team.

17. **Responsibility.** The Organizer accepts no responsibility for any loss, damage or injury any animal of any other property or the exhibitors themselves. Neither the Organizer nor the Doctor will be held responsible for any aid or other medical treatment provided.

18. **Eligibility of Rider.** As Per latest EFI REL Guidelines and Technical Guidelines.

19. **Restriction on Horse.** As Per latest EFI REL Guidelines and Technical Guidelines.

20. **Saddlery and Equipment** As per EFI rules on the subject.

21. **Technical conduct .** As Per latest EFI REL Guidelines and Technical Guidelines.

22. **Accommodation.** Participants are required to make arrangement for their accommodation. In Case any assistance is required you may contact show secretary SESA, Jaipur.

23. **Inspection Decorum.** As per EFI rules on the subject.

24. **Abuse/cruelty to horses.** As per EFI rules on the subject.

25. **Camp**

(a) The SAGAR EQUESTRIAN SPORTS ACADEMY JAIPUR has permitted stabling of horses for all participants in **REL for JNEC-2020** for the duration of the event.. Camp will open on 26 Oct 2020 and close on 02 Nov 2020. All teams that require stables must send their requirements as per format attached at **Appendix D** before the 24th October 2020, after which no stable orders can be accepted. All bio-degradable waste including horse dung is to be put into the pits provided. The camp is a green campus and NO PLASTIC Zone and defaulters will be fined Rs 1000/- without any appeal . All waste is to be put into the dustbin provided. No open fires are permitted on camp grounds. Cutting of trees, branches bushes is strictly prohibited.

(b) The Camp incharge will earmark the site for each contingent. The rep of the contingent will take over the site allotted to them from the Camp incharge on arrival & handover the same before departure in the same condition, any damage to camp, accommodation or property will be the responsibility of the contingent. The teams should come self contained in all respects for camping in respect of their personnel and animals. All teams will intimate the total strength of contingent in terms of men and horses positively by 24 Oct 2020 and intimate exact Time of Arrival well in advance to SESA, Jaipur to org Administrative Arrangements.

26. **Rent Chargeable for Stabling.**

All teams should preferably come fully equipped with their own tentage for stabling, and enough grain and fodder for the duration of the show. A fee of Rs 500 + taxes will be charged per stable which is set up on SESA grounds. The cost of one temporary stable provided by SESA is Rs. 2500 + taxes for the duration of the show on first come first basis'.

27. **Self – Containment** – All teams coming to participate in the **REL for JNEC-2020** must be self-contained, i.e, they should bring their own tentage, equipment for camping, cooks and transport, etc.

28. **Ration/Fodder**- Army contingents are advised to bring maximum quantity of grain/ fodder to sustain their horses during their Stay in Jaipur or, they can ask for attachment both the local Supply Depot. Other contingents are advised to make their own arrangements for animal rations. The Organisers will try to arrange for bedding straw and fodder to be made available for sale at retail prices.

29. **Coggin and Glander Test** – All rules and instructions issued from the EFI and Remount veterinary Directorate, army Headquarters on the subject will be strictly adhered to by concerned. All horses must produce a valid negative EIA and Glander Status (CFT) certificate on arrival to Jaipur .Coggins and glanders negative certificate with a validity of a minimum of 14 days arrival and exit of horses from the camp is mandatory.

30. **Trotting Parade** – All participants are requested to present their horses for veterinary inspection (Trotting parade) at 1000 Hrs on 27 Oct 2020.at SESA SHOW JUMPING GROUND.

31. **Ground jury, Veterinary / technical delegate, Appeal Committee and insurance-** These are as per Equestrian Federation of India under governing competitions.

32. **Spectators.** In view of Covid-19, the public/spectators will be limiting or prohibiting on the competition grounds to reduce risk.

33. **Prize Distribution** – Tentatively prizes will be distributed after each event on the same day.

34. **Fire Fighting Arrangement** – All contingents are requested to carry adequate fire fighting equipment.

35. **Veterinary Commission** – The Veterinary Commission detailed by the Equestrian Federation of India will have full right to examine all the horses participating.

36. **Veterinary Assistance** – The following is available for vet assistance in case of an emergency.

37. **Clearance Certificate** – All horse owners/riders are required to obtain a clearance certificate from the Show office during working hours. All accounts concerned needed to be cleared before they can obtain the same. No horses will be allowed to leave unless they obtain the clearance certificate.

38. **COVID-19 Protocol.** In light of the COVID-19 pandemic, strict protocols and guidelines must be followed in order to ensure a safe and successful conduct of the event. The guidelines for resuming equestrian training and competition activities in a COVID-19 environment issued by the EFI will be strictly adhered to.
