FEIDRESSAGECDI2* & EFI DRESSAGE (CDN) EVENTS

1. General.

(a) FEI Dressage CDI2* alongwith EFI Dressage (CDN) events will be organized by Modi Equestrian Academy, Modi Puram from 04 Dec to 07 Dec 2022 according to the FEI rules and Technical guidelines of Equestrian Federation of India (EFI) in vogue.

(b) This document will be divided in two parts:-

(i) Part I - Administrative Instructions

(ii) Part II - FEI Schedule

PART I - ADMINISTRATIVE INSTRUCTIONS

2. Programme. Tentative Programme of FEI Dressage CDI2* and CDN events is attached at **Appendix 'A'.**

3. Entries.

(a) All entries must be on the prescribed Entry form given in **Appendix 'B'** and should be completed in all respects. Entries not in the prescribed Entry form and not accompanied by the entry fee will not be considered. All entries for FEI Dressage CDI2* and CDN events must be accompanied by proof of age (birth certificate). All entries must have EFI horse passport number description, FEI/EFI registration number & name of the horse concerned & Rider's EFI/FEI ID.

(b) A max of 16 Horse-Rider combinations in EFI Dressage (CDN) events are permitted for categories listed in the schedule of events as **Appendix A**. Entries will be fwd via email to EFI and on first cum first basis, their entries for participation will be accepted.

(c) Entries must be sent to the EFI Office directly. To facilitate processing of the data please also email a copy of the entries to OC on their email contact@modiequestrian.com

4. Entry Fee.

(a) The entry fee:-

(i) FEI CDI 2* - @ Rs 2000/- to be directly paid to EFI.

(ii) EFI CDN Events - @ Rs 500/- to be directly paid to EFI.

(b) Closing Date for Entries.

(i) Definite Entries - 28 Nov 2022

(ii) Last date for substitutions - 03 Dec 2022

No entries will be accepted thereafter.

5. Score achieved by a horse-rider combination in FEI Dressage CDI2* competition shall be considered for indl/team selection for 19th Asian Games if rider request the EFI for the same as per para 4 and 30 of Selection Criteria (Version-V).

6. **EFI Horses Passport.**

(a) As per EFI rules all horses participating in the FEI Dressage CDI2* & EFI Dressage (CDN) events have to be in possession of EFI passport.

(b) No entry will be accepted without valid EFI Horse Passport. For further information pertaining to registration, contact EFI. Please register the horses participating in the event with the EFI prior to the event.

7. **EFI Rider Registration.**

(a) All riders participating in the FEI Dressage CDI2* & EFI Dressage (CDN) events must have a valid EFI Rider Identification Number.

(b) Riders not having EFI rider ID No. will not be permitted to participate.

(c) **Registration of Horses & Riders with FEI** All Athletes and Horses participating in FEI Dressage CDI2* must be registered with the FEI.

8. **Withdrawal, Change, Transfer or Substitutions of Entry.**

(a) **Withdrawal.** The entry fee of a horse will not be refunded if the horse does not participate in the class.

(b) **Transfer and Substitutions.** A horse cannot be transferred from one class to another without paying an additional entry fee for the class to which is transferred. A horse once entered in any event cannot be substituted by another horse for any reason whatsoever.

(c) **Change of Riders:** Riders cannot be changed unless the Jury accepts that there are sufficient reasons for change of riders. All changes will be treated as Fresh Entries. Once an event has started, being judged, no change in rider / horse will be accepted.

9. **Reporting for Each Class.** All horses will report to the collecting ring Steward half an hour before the time of judging of the class. Any entry not reporting in time will be eliminated unless the exhibitor shows good cause for the delay. The Ring Steward has full authority to take disciplinary action.

10. **Show Number.** All horses will display the EFI Registration Number on the bridle during competition and veterinary inspection and whenever taken out of the stable under the saddle.

11. **Abuse/ Cruelty to horses.** As per relevant rules of EFI/FEI.

12. **Rosettes.** A horse will wear no rosettes during judging.

13. **Elimination / Disqualification.** The judges are empowered to disqualify the competitors at any stage of the competition for rough handling, or any type of cruelty to animals. Rapping will be severely penalized.

14. **Whips/spurs.** As per EFI and relevant FEI rules per discipline.
15. **Dress code.** As per EFI/FEI rules. When inspecting the course, dress must be neat and tidy. In any case, riding boots, white breeches, a white or lightly colored plain shirt, white tie and Jacket must be worn. Service personnel will be in uniform.

16. **Stabling/ Camp facility & Charges**

- (a) Venue & stabling will be open on 2nd Dec2022, 0700 hours and close on 8thDecember2022, 1000 hours.
- (b) Limited show stables are available and will be allotted on first cum first serve basis.
- (c) All teams that require stables must send their requirements before November28th 2022 to the OC, after which no stable requests will be accepted. All requirements are to be submitted on the prescribed stable/ camp request form on sent via what's app on 9311330573.
- (d) It will be at the discretion of the participant to choose the stabling facility as given below:-
- (i) If the OC provides an area wherein the participants will build their own temporary shed, charges levied will be maximum Rs. 500/- per horse to take care of electricity, water and cleaning charges thereof.

OR

- (ii) If the OC provides permanent show stables constructed by them for the duration of the event the charges levied will be a maximum of Rs. 2500 per horse.

17. **Venue.** The event will be held at Modi Equestrian Academy, Modi Puram. Route chart of the same is attached.

(Note: The venue will open on **December 2nd2022 at 0700** Hours and close on **December8th 2022 at 1000 hours**)

(NOTE: *Athletes, grooms, trainers, family, or any other person visiting Modi Equestrian Academy will not be permitted to enter without the Covid 19 Self Declaration & Travel Declaration form as prescribed by EFI)*

18. **Camp.** All horses will be stabled at Modi Equestrian Academy. Stables will be allotted by the organizing committee to all teams depending on the number of horses per team. All horse handlers are permitted to stay along with the horses in temporary accommodation earmarked for the same. All teams are requested to share the number of horses/ handlers per contingent, which are likely to come latest by **November28th2022** with the show secretary via E-mail/whatsapp.

19. **Self-containment.** In addition to the above all teams must be self-contained in terms oftentage, equipment for camping and transport in order to be prepared for any unforeseen emergency.

20. **Ration /Fodder;** All teams should bring their own feed, hay, bedding, grass, etc. for their horses and should make their own provision for staff food. Modi Equestrian Academy will not provide any assistance for the above unless special facilities are being provided for all teams.

21. **Coggin's and Glanders Test;** All rules and instructions issued from the EFI on this subject will be strictly adhered to by all participating teams. All teams must produce a valid negative EIA and Glanders status certificate on arrival with a validity advised by the governing authorities.

22. **Veterinary commission**The Veterinary Commission detailed by Equestrian Federation of India, Modi Equestrian Academy will have the right to examine all the horses participating.

23. **Veterinary Assistance;**Dr. Vikram Malhotra is the official VET for all Modi Equestrian Shows. Mobile - +919871490564. The charges will be borne by the horse owners.

24. **Farrier** All teams and riders are responsible to arrange their own farrier.

25. **Medical cover.** The organizing committee shall not accept any liability for medical treatment given to a competitor on the venue or the consequences there of. Each rider participating in the FEI DressageCDI2* and EFI Dressage (CDN) events will fill the Indemnity Bond attached and submit the same along with entry form.

26. **Insurance.** The organizing committee recommends units/club/associations to take insurance policies for competitors, personnel, grooms and horses for their transportation to Modi Equestrian Academy and during the conduct of the events. The organizing committee will assume no responsibility for any accident or illness due to fall of any horse, competitors, groom/ any other member of the team.

27. **Responsibility.** The organizing committee accepts no responsibility for any loss, damage or injury to any animal or any other property or the exhibitors themselves.

28. **Appeal.** Appeal may be lodged in writing by the team captain/competitors as per FEI GR 161. A fee equivalent to 150 CHF should be deposited with the show secretary, MEA along with the objection. Money will be refunded if the objection is upheld.

29. **Compliance of NADA Rules** As per the rules in vogue, each participant (both human and equine) are liable for screening for doping at EFI approved events. In view of the above, athlete if approached by NADA to give sample for dope testing are mandatorily required to comply with the same. Any refusal may result in debarment of the athlete.

30. **Clearance Certificate.** Horse owners are required to obtain clearance certificate from the OC during work hours. All concerned accounts need to be cleared before they can obtain the same. No horses/ Person will be allowed to leave by the Camp In-charge without the clearance certificate.
