EFI SHOW JUMPING (CSN) EVENTS

1. General.

EFI Show Jumping (CSN1*/CSN3*) events will be organized by Modi Equestrian Academy, Modi Puram from 11 Dec to 15 Dec 2022 according to the FEI rules and Technical guidelines of Equestrian Federation of India (EFI) in vogue.

2. CATEGORIES

(a) Show Jumping 1.40 m over two rounds

(b) Show Jumping 1.50 m over two rounds

3. PROGRAMME

Schedule of Events - Attached at **Appendix 'A'**

4. ENTRIES

(a) All entries will be given on a proper Entry Form as given in **Appendix 'B'**. Entries not on the prescribed entry form or without entry fee will not be considered.

(b) **Entry Fee:**

(i) Normal Entry: Rs.500/- (Entry fee will need to be paid for each category)

(ii) Post Entry : Rs. 1,000/ -

(c) **Closing Date for Entries:** Entries will close **07 Dec 2022 by 12 noon.** Entries received thereafter will be regarded as **POST ENTRIES**. No entry will be accepted without an entry fee and after vet inspection. Post entries will be accepted till two hours before the vet inspection.

(d) Foreign Nationals & OCI card holders cannot participate in the subject Show Jumping event. It is the responsibility of OC to ensure this aspect by obtaining a copy of Indian Passport from all athletes along with entry form.

5. Score achieved by a horse-rider combination in EFI Show Jumping (CSN1*/CSN3*) competition shall be considered for indl/team selection for 19th Asian Games if rider request the EFI for the same as per para 4 and 30 of Selection Criteria (Version-V).

6. REGISTRATION OF HORSES WITH EFI

(a) As per EFI rulings, all horses participating in the EFI approved events have to be in possession of the EFI passport. No entry will be accepted without EFI Registration number. For further information pertaining to registration, contact EFI. Please register the horses participating in the event with the EFI prior to the event.

(b) Team captains are requested to ensure that their horses are all registered before entries for the Event. The registration Number has to be filled in the entry form as per EFI ruling.

(c) Entries will not be accepted without EFI registration number.

7. **EFI Rider Registration.**

(a) As per EFI rulings all Riders participating in the EFI Events have to be registered with the EFI.

(b) Entries will not be accepted without valid /RENEWED/ ACTIVE EFI registration number.

(c) All the riders, participating in the EFI recognized events should be in possession of Renewed EFI identity number in 2022.

8. **Withdrawal, Change, Transfer or Substitutions of Entry.**

(a) **Withdrawal.** The entry fee of a horse will not be refunded if the horse does not participate in the class.

(b) **Transfer and Substitutions.** A horse cannot be transferred from one class to another without paying an additional entry fee for the class to which is transferred. A horse once entered in any event cannot be substituted by another horse for any reason whatsoever.

(c) **Change of Riders** Riders cannot be changed unless the Jury accepts that there are sufficient reasons for change of riders. All changes will be treated as Fresh Entries. Once an event has started, being judged, no change in rider / horse will be accepted.

9. **Reporting for Each Class.** All horses will report to the collecting ring Steward half an hour before the time of judging of the class. Any entry not reporting in time will be eliminated unless the exhibitor shows good cause for the delay. The Ring Steward has full authority to take disciplinary action.

10. **Show Number.** All horses will display the EFI Registration Number on the bridle during competition and veterinary inspection and whenever taken out of the stable under the saddle.

11. **Abuse/ Cruelty to horses.** As per relevant rules of EFI/FEI.

12. **Rosettes.** A horse will wear no rosettes during judging.

13. **Elimination / Disqualification.** The judges are empowered to disqualify the competitors at any stage of the competition for rough handling, or any type of cruelty to animals. Rapping will be severely penalized.

14. **Whips/spurs.** As per EFI and relevant FEI rules per discipline.

15. **Dress code.** As per EFI/FEI rules. When inspecting the course, dress must be neat and tidy. In any case, riding boots, white breeches, a white or lightly coloured plain shirt, white tie and Jacket must be worn. Service personnel will be in uniform. It is compulsory for anyone

jumping a horse to wear a properly fastened hard hat with three-point retention harness including riders in uniform.

16. **Stabling/ Camp facility & Charges**

- (a) Venue & stabling will be open on 9 Dec 2022, 1700 hours and close on 16 Dec 2022, 1000 hours.
- (b) Limited show stables are available and will be allotted on first cum first serve basis.
- (c) All teams that require stables must send their requirements before December 1st 2022 to the OC, after which no stable requests will be accepted. All requirements are to be submitted on the prescribed stable/ camp request form on sent via what's app on 9311330573.
- (d) It will be at the discretion of the participant to choose the stabling facility as given below:-
 - (i) If the OC provides an area wherein the participants will build their own temporary shed, charges levied will be maximum Rs. 500/- per horse to take care of electricity, water and cleaning charges thereof.

OR

- (ii) If the OC provides permanent show stables constructed by them for the duration of the event the charges levied will be a maximum of Rs. 2500 per horse.

17. **Venue.** The event will be held at Modi Equestrian Academy, Modi Puram. Route chart of the same is attached.

(Note: The venue will open on **9 Dec 2022 at 1700** Hours and close on **November 16th 2022 at 1000 hours**)

(NOTE: Athletes, grooms, trainers, family, or any other person visiting Modi Equestrian Academy will not be permitted to enter without the Covid 19 Self Declaration & Travel Declaration form as prescribed by EFI)

18. **Camp.** All horses will be stabled at Modi Equestrian Academy. Stables will be allotted by the organizing committee to all teams depending on the number of horses per team. All horse handlers are permitted to stay along with the horses in temporary accommodation earmarked for the same. All teams are requested to share the number of horses/ handlers per contingent, which are likely to come latest by **November 27th 2022** with the show secretary via E-mail/whatsapp.

19. **Self-containment.** In addition to the above all teams must be self-contained in terms of tentage, equipment for camping and transport in order to be prepared for any unforeseen emergency.

20. **Ration /Fodder;** All teams should bring their own feed, hay, bedding, grass, etc. for their horses and should make their own provision for staff food. Modi Equestrian Academy will not

provide any assistance for the above unless special facilities are being provided for all teams.

21. **Coggin's and Glanders Test:** All rules and instructions issued from the EFI on this subject will be strictly adhered to by all participating teams. All teams must produce a valid negative EIA and Glanders status certificate on arrival with a validity advised by the governing authorities.

22. **Veterinary commission** The Veterinary Commission detailed by Equestrian Federation of India will have the right to examine all the horses participating.

23. **Veterinary Assistance:** Dr. Vikram Malhotra is the official VET for all Modi Equestrian Shows. Mobile - +919871490564. The charges will be borne by the horse owners.

24. **Farrier** All teams and riders are responsible to arrange their own farrier.

25. **Medical cover.** The organizing committee shall not accept any liability for medical treatment given to a competitor on the venue or the consequences thereof. Each rider participating in the EFI Show Jumping (CSN) events will fill the Indemnity Bond attached and submit the same along with entry form.

26. **Insurance.** The organizing committee recommends units/club/associations to take insurance policies for competitors, personnel, grooms and horses for their transportation to Modi Equestrian Academy and during the conduct of the events. The organizing committee will assume no responsibility for any accident or illness due to fall of any horse, competitors, groom/ any other member of the team.

27. **Responsibility.** The organizing committee accepts no responsibility for any loss, damage or injury to any animal or any other property or the exhibitors themselves.

28. **Appeal.** Appeal may be lodged in writing by the team captain/competitors as per FEI GR 161. A fee equivalent to 150 CHF should be deposited with the show secretary, MEA along with the objection. Money will be refunded if the objection is upheld.

29. **Compliance of NADA Rules** As per the rules in vogue, each participant (both human and equine) are liable for screening for doping at EFI approved events. In view of the above, athlete if approached by NADA to give sample for drug testing are mandatorily required to comply with the same. Any refusal may result in debarment of the athlete.

30. **Clearance Certificate.** Horse owners are required to obtain clearance certificate from the OC during work hours. All concerned accounts need to be cleared before they can obtain the same. No horses/ Person will be allowed to leave by the Camp In-charge without the clearance certificate.
