GENERAL INSTRUCTIONS

1. EFI COVID 19 PROTOCOL

All participants will have to comply with the Covid 19 protocol for equestrian training and events issued by EFI. All riders, horse owners, syces should maintain social distancing, wearing of mask and using hand sanitizers is compulsory.

2. ENTRIES

There shall be an entry fee of Rs. 500/- for the Individual Events.

The last date for receipt of the entries is 06 Nov 2022. All entries received from 07 Nov 2022 and till two hours before vet inspection of the event, will be considered as a post entry and the **fees will be Rs. 1000/- for individual entries.** Entry not sent on the Prescribed form or not accompanied by Birth Certificate and EFI registration number, will not be entertained. **Birth certificate/ Proof of age, certified by the school/college must accompany the entry form for the Young Rider, Junior, and Children I & II.**

3. ENTRY FORM

All entries must be sent in the prescribed form attached to this prospectus. The name of the rider must be specifically mentioned in the Entry Form. A horse, once entered, cannot normally be substituted by another horse. The same horse cannot compete in the same event by different riders. The organizers reserve the right to reject any entry without assigning any reasons.

4. PAYMENTS.

All payments will be made to “The Tollygunge Club Ltd” in the form of NEFT / RTGS or cash only. **Cheques will NOT be accepted.**

5. WITHDRAWAL OF ENTRIES

Any entry can be withdrawn till 06 Nov 2022 without attracting any loss of fees. No refund of fees will be allowed for entries withdrawn after 06 Nov 2022 unless it has to be withdrawn on Veterinary grounds, and in such cases, a certificate from the Veterinary Officer will be required.

6. VET PROTOCOL

It is mandatory for all teams to submit the following valid test reports in respect of their horses before entering the camp.

- (a) Coggins Tests
- (b) Glanders Test

7. CHANGE OF HORSE/ RIDER

A horse/rider can be changed only up to two hours prior to the draw of lots of the event. However the entry shall be treated as a post entry.

8. ELIMINATION ROUND

In case there are a large number of participants for any event, elimination round will be held.

9. CANCELLATION OF AN EVENT:

In case the organizers feel that there are not enough entries for any particular event, that event may be cancelled. Such cancellation or alternative arrangements will be announced at the time of draw of lots for the events, a day prior to the event.

10. ARRIVAL OF THE HORSES / RIDERS AT THE SHOW GROUND:

All horses/riders should be present at the venue half an hour before the scheduled starting time for the respective event and report to the Marshall of the event.

11. CHANGE IN SCHEDULE OF EVENTS:

The organizers may make changes in the schedule of events for which necessary announcements will be made at the event area.

12. REGISTRATION OF HORSES WITH EFI: (EFI Horse passport)

- (a) As per EFI rules all horses participating in the REL have to be in possession of EFI passport.
- (b) No entry will be accepted without EFI registration number. For further information pertaining to registration, contact EFI.

13. REGISTRATION OF RIDERS:

- (a) All the riders participating in the EFI recognized events should obtain EFI ID no.
- (b) A rider who does not have an EFI rider ID number will not be permitted to take part in REL.
- (c) NRI/OCI Card Holders. OCI Card Holders/NRI's/ Foreigners shall be given Rider ID but they cannot participate in RELs which shall be only for Indian Citizens. NRI/OCI Card Holders/Foreigners would be allowed to participate in REL as HC entry only.

14. SHOW NUMBERS:

All horses will display the EFI Registration Number on the bridle during competition, veterinary inspection and whenever taken out of the camp.

15. JUDGING

The decision of the Judges will be final.

16. OBJECTIONS. Any appeal shall be dealt as per FEI GY 161

17. LOSS OR DAMAGE

The organizers accept no responsibility for any loss, damage or injury to any horse, rider or to any other person or property arising directly or indirectly from accident or any other causes. Neither the Committee nor the Vet / Med doctor will be held responsible for any first aid or other medical treatment provided.

18. ABUSE/CRUELTY

As per EFI and relevant FEI rules per discipline.

19. ABANDONMENT

If for any reasons the show has to be abandoned, the competing units/civilian participants and concerned riders will be informed by fax, email or wireless.

20. RULES

The rules of the Equestrian Federation of India (EFI) and the Federation Equestre Internationale (FEI) will be followed for the conduct of the events of the competition, until and unless otherwise specified for any event.

21. TACKS, WHIPS AND SPURS

As per EFI guidelines and relevant FEI rules

23. DRAW OF LOTS/STARTING ORDER:

The draw of lots will normally be held on the day before the day of the event. However, the organizers, may change the draw of lots to any other time, after making necessary announcements for the same.

24. **Insurance:** The Organising Committee recommends units/clubs/associations to take insurance policies for competitors, personnel, grooms and horses during the events. The Organising Committee will assume no responsibility for any accident or illness due to fall of any horse, competitors, grooms/any other member of the team.
