FEI DRESSAGE WORLD CHALLENGE 2022 SOUTH INDIA

General.

1. FEI World Dressage Challenge 2022 (South India) will be conducted from 5th Nov to 6th Nov 2022 at ASC Riding & Polo Academy (ARPA), c/o ASC Centre & College, Bangalore.
2. Selection trial for selection of Indian Team for FEI Dressage World Challenge 2022 including elimination will be conducted from 27th to 28th Oct 2022 and maximum of 40 horse-rider combinations to participate in the final event on 5th Nov to 6th Nov 2022.
3. Technical specification will be as per FEI World Dressage Challenge Rule-2022 and other relevant rule of FEI.

4. Tests will be held on the following categories of Dressage:-

(f) **Rules.** FEI World Dressage Challenge 2022 rules are attached at **Appx A**. The extant FEI rules for World Dressage Challenge will be followed in their entirety with no deviations whatsoever. Participants are advised to be conversant with the rules and to participate in the event accordingly

5. **Programme.** Tentative Programme of FEI World Dressage Challenge 2022 are attached at **Appendix 'B'**.

6. **Entries.**

(a) All entries will be on proper Entry Form as per format attached at **Appendix 'C'** should be submitted to EFI office latest by 1200H on 23 Oct 2022. The organizing Committee is not responsible for any wrong entry. All entries will be made on FEI Entry system on IT Platform.

(b) **Entry Fee.** Rs 500/- per entry.

(c) **Closing date for Entries:** Entries for FEI Dressage World Challenge 2022 will be closed by 1200H on 23 Oct 2022. In case of there being less than 40 entries at any venue, late entries will be allowed till the figure of 40 is reached. This will be submitted individually by email only and will be strictly first come first serve basis going by time received.

(d) The distribution of entries (Not Horses) for final event will be as follows:-

(e) Final selection of the 40 entries and the Indian Team will be based on overall score achieved by the participants keeping in mind the difficulty quotient across all categories after computation of the final score. The Indian Team will comprise of four riders and they can be from any category/class. There will be no fixed vacancy in the formulation of the Indian Team. It will comprise of the four highest scores keeping in mind the coefficient factor laid down by FEI.

(f) It may please be noted that further participation in the competition as individual or as team member of the Indian team will only be allowed to those participants who undergo the world challenge selection trial at Bangalore on 27-28 Oct 2022.

(g). **Foreign Riders.** EFI is requested to obtain MI Clearance for managers/coaches /judges /Riders who are taking part in FEI Events. Foreign officials/riders whose MI Clearance is not obtained will not be allowed to enter in ASC Centre & College, Bangalore being Army area.

7. **Stabling/ Camp facility & Charges**

(a) Venue & stabling will be open on October 23rd 2022 and close on November 07th 2022.

(b) Limited permanent / fixed stables are available and will be allotted on first cum first serve basis.

(c) All teams that require stables must send their requirements before October 20th 2022 to the OC, after which no stable requests will be accepted.

(d) It will be at the discretion of the participant to choose the stabling facility as given below:-

(i) If the OC provides an area wherein the participants will build their own temporary shed, charges levied will be maximum Rs. 500/- per horse to take care of electricity, water and cleaning charges thereof.

OR

(ii) If the OC provides fixed / permanent stables constructed by them for the duration of the event the charges levied will be a maximum of Rs. 2500 per horse.

ADMINISTRATION

8. **Venue.** The event will be held at ASC Riding and Polo Academy, Bangalore-560007. Venue & stabling will be open on October 23rd 2022 and close on November 07th 2022.

9. **Camping and Accommodation.**

(a) All teams should have come fully equipped with their own tentage for stabling, and enough grain and fodder for the duration of show.

(b) The Organisers will try to arrange for bedding straw and fodder to be made available for sale at retail prices at ARPA location.

(c) All teams must inform the organiser of their total strength (personnel and animals) by 20th October 2022, so that camp sites of appropriate size can be allocated for all teams, both civilian and government.

(d) All teams must inform organizers of their estimated time of arrival well in advance.

(e) Any teams requiring a vehicle to transport luggage from the Bangalore Railway Station to ASC Centre & College must inform the organizers by 20 Oct 2022, to facilitate the transport and the Cost of civil truck will be charged from respective owner of animals as actual.

(f) The cost of transportation from the railway station to ASC Centre & College will be arranged by the respective clubs. The cost of local vendor for local truck hiring is Mr Chatrapal 9913217775/ 9901851860.

(g) All bio-degradable waste including horse dung is to be put into the pits provided.

(h) All plastic and paper waste is to be put into the dustbin provided. Please minimize your use of plastic materials.

(j) No open fires are permitted on ARPA grounds.

(k) Cutting of trees, branches bushes is strictly prohibited.

10. **Self-containment.** All teams coming to participate in the FEI Dressage World Challenge 2022 must be self-contained in terms of tentage, equipment for camping, cooks and transport etc.

11. **Ration /Fodder;** **Army** teams are advised to bring maximum quantity of grain/fodder to sustain their horses during their stay in Bangalore or, they can ask for attachment with the local Supply Depot. Other contingents are advised to make their own arrangements for animal rations.

12. **Coggin's and Glanders Test;** All rules and instructions issued from the EFI and Remount Veterinary Directorate, Army Headquarters on the subject will be strictly adhered to by all concerned. All horses must produce a valid negative EIA and Glander status (CFT or Mallein) certificate on arrival to ASC Centre & College, Bangalore as per directions. Coggins and glanders negative certificate with a validity of a minimum of 15 days on arrival and exit of horses from the camp is mandatory.

13. **Veterinary commission** The Veterinary Commission detailed by Equestrian Federation of India, Modi Equestrian Academy will have the right to examine all the horses participating.

14. **Veterinary Assistance:** The following are available for vet assistance in case of an emergency:-

15. **Medical Cover.** The Club will provide first aid medical cover for riders at the venue. The Club shall not accept any liability for medical treatment given to a rider on the venue or the consequences thereof. The Club will only provide first aid emergency treatment as well as

evacuation to the hospital where necessary, though every possible available medical cover will be presented. Each riders participating in the Event will please fill the Indemnity Bond attached as **Appendix 'D'** and submit the same along with entry form.

16. **Insurance.** The Organizing Committee recommends units/clubs/associations to take insurance policies for competitors, personnel, grooms and horses for their transportation to ARPA, Bangalore and during the events. The Organising Committee will assume no responsibility for any accident or illness due to fall of any horse, competitors, groom/any other member of the team.

17. **Responsibility.** The Organising Committee accepts no responsibility for any loss, damage or injury to any animal or any other property or the exhibitors themselves. Neither the Committee nor the Doctor will be held responsible for any first aid or other medical treatment provided.

19. **Clearance Certificate.** Horse owners are required to obtain clearance certificate from the OC during work hours. All concerned accounts need to be cleared before they can obtain the same. No horses/ Person will be allowed to leave by the Camp In-charge without the clearance certificate.

20. **Compliance of NADA Rules and FEI Equine Anti-Doping and Controlled Medication Regulation (EADCM).** As per the rules in vogue, each participant (both human and equine) are liable for screening for doping at EFI approved events. In view of the above, athlete if approached by NADA to give sample for dope testing are mandatorily required to comply with the same. Any refusal may result in debarment of the athlete.

COVID-19.

21. In light of the COVID-19 pandemic, strict protocols and guidelines must be followed in order to ensure a safe and successful conduct of the event. **Strict adherence to MHA guidelines as renewed from time to time will be followed.** The guidelines for resuming equestrian trg and competition activities in a COVID-19 envt issued by the EFI will be followed strictly.

TECHNICAL INSTRUCTIONS

23. Technical Specifications.

Event will be conducted as per FEI Dressage World Challenge Rule 2022/ FEI Dressage Rules.

24. Entries.

(a) All entries will be on proper Entry Form as attached for the FEI Dressage World Challenge 2022 and should be completed in all respect and to be submitted to the Equestrian Federation of India Office. Entries not on the prescribed entry form will not be considered.

(b) **Entry Fee:** Rs 500/- per entry

(c) **Closing date for Entries** All entries for FEI Dressage World Challenge 2022 will close by **October 23th 2022 at 1200 hours.**

(d) **Description and Registration of Horses;** All entries must give the description, EFI Registration/Passport/Show Number, name and year of birth of the horse concerned.

25. **EFI Horses Passport** As per EFI rules all horses participating in the FEI Dressage World Challenge 2022 events must have a valid EFI passport in original. Entries will not be accepted without the EFI Registration/Passport/Show Number of the horse.

26. EFI Rider Registration.

(a) All riders participating in the FEI Dressage World Challenge 2022 must have a valid EFI Rider Identification Number.

(b) Riders not having EFI rider ID No. will not be permitted to participate.

27. Withdrawal, Change, Transfer or Substitutions of Entry.

(a) **Withdrawal.** The entry fee of a horse will not be refunded if the horse does not participate in the class.

(b) **Transfer and Substitutions.** A horse cannot be transferred from one class to another without paying an additional entry fee for the class to which is transferred. A horse once entered in any event cannot be substituted by another horse for any reason whatsoever.

(c) **Change of Riders;** Riders cannot be changed unless the Jury accepts that there are sufficient reasons for change of riders. All changes will be treated as Fresh Entries. Once an event has started, being judged, no change in rider / horse will be accepted.

28. **Cancellation or reschedule;** The Organizing committee may cancel or reschedule any class which has less than four entries or for any reason after consultation with EFI who will apprise

the FEI for the same. In that case, the entry fee will be refunded. However, depending on the numbers of entries received, the organizing committee may decide against this for any particular event.

29. **Reporting for Each Class.** All horses will report to the collecting ring Steward half an hour before the time of judging of the class. Any entry not reporting in time will be eliminated unless the exhibitor shows good cause for the delay. The Ring Steward has full authority to take disciplinary action.

30. **Show Number.** All horses will display the EFI Registration Number on the bridle during competition and veterinary inspection and whenever taken out of the stable under the saddle.

31. **Abuse/ Cruelty to horses.** As per relevant rules of EFI/FEI.

32. **Rosettes.** A horse will wear no rosettes during judging.

33. **Elimination / Disqualification.** The judges are empowered to disqualify the competitors at any stage of the competition for rough handling, or any type of cruelty to animals. Rapping will be severely penalized.

34. **Whips/spurs.** As per EFI and relevant FEI rules per discipline.

35. **Dress code.** As per EFI/FEI rules.

36. **Appeal.** Appeal may be lodged in writing by the team captain/competitors as per FEI GR 161. A fee equivalent to 150 CHF should be deposited with the show secretary, ARPA along with the objection. Money will be refunded if the objection is upheld.

DECLARATION (INDEMNITY BOND)
