ADM AND TECH INSTR FOR FEI JUMPING WORLD CHALLENGE 2022
(SOUTH ZONE)

General.

1. The FEI Jumping World Challenge -2022 will be conducted on 11 Oct 22 to 21 Oct 22 at ASC Riding and Polo Academy (ARPA), Bangalore as per guidelines of the Equestrian Federation of India, FEI Jumping Rules and FEI Jumping World Challenge Rule-2022.

2. **Stabling/ Cam Facility and Charges.**

- (i) Venue & stabling will be open 08 Oct 2022 and close on 22 Oct 2022.
- (ii) Limited permanent/fixed stables are available which will be allotted on first cum first serve basis.
- (iii) All teams that require stables must send their requirements before the 03 Oct 2022, after which no stable orders can be accepted.
- (iv) It will be at the discretion of the participant to choose stabling facility as give below:-

If the OC provides an area wherein the participants will built their own temp shed, charges levied will be max Rs 500/- per horse for entire duration of events (08 Oct to 22 Oct 22) to take care of electricity, water and cleaning charges thereof.

OR

If the OC provides a Temp/fixed stables constructed under ARPA arrangement for duration of a event or a permanent stable, the charges levied will be max Rs 2500/- per horse for complete duration of event.

- (v) **Venue.** The event will be held at ASC Riding and Polo Academy, Bangalore -560007. Venue & stables will be open on 08 Oct 2022 and close on 22 Oct 2022.

3. **Camping.**

- All teams shall have come fully equipped with their own tentage for stabling, and enough grain and fodder for the duration of show.
- The Organisers will try to arrange for bedding straw and fodder to be made available for sale at retail prices at ARPA location.
- All teams must inform the organiser of their total strength (personnel and animals) by 03 Oct 2022, so that camp sites of appropriate size can be allocated for all teams, both civilian and government.
- All teams must inform the organizers of their estimated time of arrival well in advance.

- Any teams requiring a vehicle to transport luggage from the Bangalore Railway Station to ASC Centre & College must inform the organizers by 03 Oct 2022, to facilitate transport and the Cost of civil truck will be charged from respective owner of animals as actual.
 - The cost of transportation from the railway station to ASC Centre & College will be arranged by the respective clubs. The contact of local vendor for local truck hiring if reqd is Mr Chatrapal 9913217775/9901851860.
 - All bio-degradable waste including horse dung is to be put into the pits provided.
 - All plastic and paper waste is to be put into the dustbin provided. Please minimize your use of plastic materials.
 - No open fires are permitted on ARPA grounds.
 - Cutting of trees, branches bushes is strictly prohibited.
4. **Self Containment.** All teams coming to participate in the FEI Jumping World Challenge 2022 must be self-contained, ie, they should bring their own tentage, equipment for camping, cooks and transport, etc.
5. **Ration/Fodder.** Army contingents are advised to bring maximum quantity of grain/fodder to sustain their horses during their stay in Delhi or, they can ask for attachment with the local Supply Depot. Other contingents are advised to make their own arrangements for animal rations.
6. **Coggin's and Glanders Tests.** All rules and instructions issued from the EFI and Remount Veterinary Directorate, Army Headquarters on the subject will be strictly adhered to by all concerned. All horses must have a valid negative EIA and Glander status (CFT) certificate on arrival to ASC Centre & College Bangalore as per directions. Coggins and glanders negative certificate with a validity of a minimum of 15 days on arrival and exit of horses from the camp is mandatory.
7. **Veterinary Commission.** The Veterinary Commission detailed by the Equestrian Federation of India will have full right to examine all the horses participating.
8. **Veterinary Assistance.** The following are available for vet assistance in case of an emergency :-

9. **Farrier.** All teams and riders are responsible to arrange their own farrier. ARPA will not provide any assistance.
10. **Médical Cover.** The Club will provide first aid medical cover for riders at the venue. The Club shall not accept any liability for medical treatment given to a rider on the venue or the consequences thereof. The Club will only provide first aid emergency treatment as well as evacuation to the hospital where necessary, though every possible available medical cover will be presented. Each riders participating in the FEI World Jumping Challenge 2022 will please fill the Indemnity Bond attached to this document and submit the same along with entry form.

11. **Insurance**. The organizing committee recommends units/ club to take insurance policies for competitors, personnel, grooms & horses for their transportation to ARPA during the conduct of the events. The organizing committee will assume no responsibility for any accident or illness due to fall of any horse, competitors, and groom/ any other member of the team.

12. **Responsibility**. The Organising Committee accepts no responsibility for any loss, damage or injury to any animal or any other property or the exhibitors themselves. Neither the Committee nor the Doctor will be held responsible for any first aid or other medical treatment provided.

13. **Clearance certificate**. All horses' owners/ riders are required to obtain a clearance certificate from the organizing committee during working hours. All concerned accounts need to be cleared before they can obtain the same. No horses/ person will be allowed to leave the camp by the Camp in charge unless they obtain the clearance certificate.

TECHNICAL INSTRUCTIONS

15. **Technical Specification.** Events will be conducted as per FEI Jumping World challenge rules 2022/ FEI Jumping Rules available on FEI/EFI website.
16. **Programme.** Tentative programme of FEI Jumping world Challenge 2022 is att at Appendix 'A'.
17. **Entries.**
- (a) All entries will be on proper entry form as per format attached at Appx 'B' should be submitted to EFI office latest by 08 Oct 2022. EFI: (M) +91-7042472080 | (E) efiindianf@yahoo.co.in
 - (b) **Entry Fee** - Rs 500/- per competition to be paid directly to EFI as per guidelines.
 - (c) **Closing date of Entries-** Entries will be closed on 08 Oct 2022. No entries will be accepted post this date as the entries will need to be uploaded on the FEI Portal.
 - (d) **FEI WJC Horse Declaration.** Participants with more than one horse need to fill the FEI horse declaration form and submit to the organizing committee before the VET check
 - (e) **Description and Registration of Horses.** All entries must give description, EFI Registration, Passport/ Show Number, EFI Regn Number, Name and year of Birth of the horse.
 - (f) **Payment.** All entry fees must be paid to Equestrian Federation of India either online, by local cheque or NEFT in favor of Equestrian Federation of India.
18. **EFI Horse Passport.** As per EFI rules all horses participating in the FEI Jumping World Challenge 2022 events must have a valid EFI passport in original. Entries will not be accepted without the EFI Registration/Passport/Show Number of the horse.
19. **EFI Riders Registration.**
- (a) All riders participating in any EFI event must have a valid/ renewed EFI Riders identification Number.
 - (b) Riders not having renewed EFI rider ID number will not be permitted to participate.
20. **Withdrawal, Change, Transfer or Substitutions of Entry.**
- (a) **Withdrawal.** The entry fee of a horse will not be refunded if the horse does not participate in the class.
 - (b) **Transfer and Substitution.** A horse cannot be transferred from one class to another without paying an additional entry fee for the class to which is transferred. A horse once entered in any event cannot be substituted by another horse any reason whatsoever.

- (c) **Change of Rider.** Riders cannot be changed unless the Jury accepts that there are sufficient reasons for change of riders. All changes will be treated as post entries. Once an event has started being judged, no change in rider/ horse will be accepted.
- (d) **Technical specification of event.** The events will follow broadly the FEI Jumping rules/FEI WJC 2022 rules and guidelines of EFI as per relevant discipline.
21. **Cancellation or reschedule.** The organizing committee may cancel or reschedule any class which has less than four entries or for any reasons after consultation with FEI/EFI. In that case, the entry fee will be refunded. However, depending on the numbers of entries received, the organizing committee may decide against this for any particular event.
22. **Reporting of each class.** All horses will report to the collecting ring steward half an hour before the time of judging of the class. Any entry not reporting in time will be eliminated unless the exhibitor show good cause for the delay. The ring steward has full authority to take disciplinary action.
23. **Show number.** All horse will display the EFI Registration Number on the bridle during competition and veterinary inspection and whenever taken out of the stable under the saddle.
24. **Abuse/ Cruelty to horses.** Refer to EFI Technical guidelines and FEI rules.
25. **Rosettes.** A horse will wear no rosettes during judging.
26. **Elimination/ Disqualification.** The judges are empowered to disqualify the competitors at any stage of the competition for rough handling, or any type of cruelty to animals. Rapping will be severely penalized.
27. **Whips/ spurs.** As per EFI and relevant FEI rules per discipline.
28. **Dress Code.** When inspecting the course, dress must be neat and tidy, In any case, riding boots, white breeches, white or lightly colored plain shirts, white tie and Jacket must be worn. Service personnel will be in uniform. It is compulsory for anyone jumping a horse to wear a properly fastened hard aht with a three point retention harness including riders in uniform.
29. **Appeal.** Appeal may be lodged in writing by the team captain/competitors as per FEI GR 161. A fee equivalent to 150 CHF should be deposited with the show secretary, ARPA along with the objection. Money will be refunded if the objection is upheld.
30. **Compliance of NADA and FEI Equine Anti-Doping and Controlled Medication Regulation (EADCM).** As per the rules in vogue, each participant (both human and equine) are liable for screening for doping at EFI approved events. In view of the above, athlete if approached by NADA to give sample for dope testing are mandatorily required to comply with the same. Any refusal may result in debarment of the athlete.
31. **COVID-19 Protocol.** In light of the COVID-19 pandemic, strict protocols and guidelines must be followed in order to ensure a safe and successful conduct of the event. The guidelines for resuming equestrian training and competition activities in a COVID-19 environment issued by the EFI will be strictly adhered to.
