1. The Regional Equestrian League 2022 will be conducted from November 5th to November 6th 2022 as per the rules of the Equestrian Federation of India by West Bengal Equestrian Association at Swami Vivekananda State Police Academy (SVSPA, Barrackpore) , Barrackpore 700120.

2. **Entry fees and stabling charges** for riders participating in Regional Equestrian League 2022, Show Jumping & Dressage:

ADMINISTRATION:

3. **Venue.** (a) All events will be held at SVSPA, Barrackpore 700120.

(b) The venue will open on November 4th 2022 at 15-00 Hours)

(c) All horses will be stabled at Swami Vivekananda State Police Academy. Stables will be allotted by the organizing committee to all teams depending on the number of horses per team. All horse handlers are permitted to stay along with the horses in temporary accommodation earmarked for the same. All teams are requested to share the number of horses/ handlers per contingent, which are likely to come latest by 4th November 2022 with the show secretary via E-mail and also the Camp I/C Insp. Somnath Bhattacharya - +918240072815

4. **Self-containment.** In addition to the above all teams must be self- contained in terms of tentage, equipment for camping and transport in order to be prepared for any unforeseen emergency.

5. **Ration /Fodder:** All teams should bring their own feed, hay, bedding, grass, etc. for their horses and should make their own provision for staff food. i Swami Vivekananda State Police Academy will not provide any assistance for the above unless special facilities are being provided for all teams.

6. **Coggin's and Glanders Test :** As per EFI/FEI Guidelines.
7. **Veterinary commission** The Veterinary Commission detailed by West Bengal Equestrian Association will have the right to examine all the horses participating in the competition. Trotting Parade / Veterinary Examination will be carried out by the Veterinary Commission detailed by West Bengal Equestrian Association.
8. **Veterinary Assistance:** Dr. Surajit Basu is the official VET for all Equestrian Shows. Mobile +919051700365. The charges will be borne by the horse owners.
9. **Medical cover.** The organizing committee shall not accept any liability for medical treatment given to a competitor on the venue or the consequences thereof. Each rider participating in the Regional Equestrian League will fill the Indemnity Bond attached as and submit the same along with entry form.
10. **Insurance.** The organizing committee recommends units/club/associations to take insurance policies for competitors, personnel, grooms and horses for their transportation to Swami Vivekananda State Police Academy and during the conduct of the events. The organizing committee will assume no responsibility for any accident or illness due to fall of any horse, competitors, groom/ any other member of the team.
11. **Responsibility.** The organizing committee accepts no responsibility for any loss, damage or injury to any animal or any other property or the exhibitors themselves.
12. **Clearance Certificate.** Horse owners are required to obtain clearance certificate from the OC during work hours. All concerned accounts need to be cleared before they can obtain the same. No horses/ Person will be allowed to leave by the Camp In-charge without the clearance certificate.

TECHNICAL INSTRUCTIONS

1. The Regional Equestrian League 2022 will be conducted from November 5th to November 6th 2022 as per EFI REL Guidelines 2022, EFI latest Technical Guidelines and relevant rules of FEI by West Bengal Equestrian Association, Kolkata at Swami Vivekananda State Police Academy (SVSPA, Barrackpore).
2. **Schedule of Tentative Events for REL.** Refer attached schedule.
3. **Entries.**
 - (a) All entries will be on proper Entry Form as attached for the Regional Equestrian League and should be completed in all respect. Entries not on the prescribed entry form will not be considered.
 - (b) **Entry Fee:** INR 500
 - (c) **Closing date for Entries** All entries for the Regional Equestrian League will close by 03 Nov 2022 at 1700 hours. Entries received thereafter will not be accepted under any circumstances.
 - (d) **Description and Registration of Horses;** All entries must give the description, EFI Registration/Passport/Show Number, name and year of birth of the horse concerned.
4. **EFI Horses Passport.** As per EFI rules all horses participating in the Regional Equestrian League events must have a valid EFI passport in original. Entries will not be accepted without the EFI Registration/Passport/Show Number of the horse.
5. **EFI Rider Registration.**
 - (a) As per EFI rulings all Riders participating in the EFI Events have to be registered with the EFI.
 - (b) Entries will not be accepted without Valid /RENEWED/ ACTIVE EFI registration number.
 - (c) All the riders, participating in the EFI recognized events should be in possession of Renewed EFI identity number in 2022.
6. **Withdrawal, Change, Transfer or Substitutions of Entry.**
 - (a) **Withdrawal:** The entry fee of a horse will not be refunded if the horse does not participate in the class.
 - (b) **Transfer and Substitutions.** A horse cannot be transferred from one class to another without paying an additional entry fee for the class to which is

transferred. A horse once entered in any event cannot be substituted by another horse for any reason whatsoever.

(c) **Change of Riders;** Riders cannot be changed unless the Jury accepts that there are sufficient reasons for change of riders. All changes will be treated as Fresh Entries. Once an event has started, being judged, no change in rider / horse will be accepted.

(d) **Technical specification of events;** the events will follow broadly the REL/Technical guidelines of EFI and FEI as per relevant discipline.

7. **Cancellation or reschedule;** The Organizing committee may cancel or reschedule any class which has less than Three entries or for any reason in consultation with EFI. In that case, the entry fee will be refunded.

8. **Reporting for Each Class;** All horses will report to the collecting ring Steward half an hour before the time of judging of the class. Any entry not reporting in time will be eliminated unless the exhibitor shows good cause for the delay. The Ring Steward has full authority to take disciplinary action.

9. **Show Number.** All horses will display the EFI Registration Number on the bridle during competition and veterinary inspection and whenever taken out of the stable under the saddle.

10. **Abuse/ Cruelty to horses;** As per EFI and relevant FEI rules per discipline.

11. **Rosettes;** A horse will wear no rosettes during judging.

12. **Elimination / Disqualification** The judges are empowered to disqualify the competitors at any stage of the competition for rough handling, or any type of cruelty to animals. Rapping will be severely penalized. Refer to relevant EFI & FEI Rules .

13. **Whips/spurs;** As per EFI and relevant FEI rules per discipline.

14. **Dress code;** As per EFI guidelines.

15. **Appeal.** Any appeal shall be dealt as per FEI GR 161.

16. **COVID-19 Protocol.** In light of the COVID-19 pandemic, strict protocols and guidelines must be followed in order to ensure a safe and successful conduct of the event. The guidelines for resuming equestrian training and competition activities in a COVID-19 environment issued by the EFI will be strictly adhered to.

DECLARATION (INDEMNITY BOND)

1. I, _____ resident of _____ desirous to participate in the Regional Equestrian League 2023/ Dressage / Show jumping at Swami Vivekananda Police Academy, Barrackpore conducted under West Bengal Equestrian Association hereby undertake and agree: -

(a) That horse riding and all equestrian sports are inherently unpredictable and potentially dangerous.

(b) That only some basic provisions for medical treatment are made at the event venue and I am responsible for my safety equipment.

(c) That the Equestrian Centre has various unsupervised areas that may be generally risky.

(d) That in the event of any loss or injury to property or person including injury resulting in death I may suffer while participating, I or any other legal representatives shall not hold Swami Vivekananda State Police Academy, Barrackpore and West Bengal Equestrian Association responsible for the same or for any consequence thereof.

2. If any rights exist by operation of law, I hereby waive them and undertake not to initiate any action against Swami Vivekananda State Police Academy and West Bengal Equestrian Association & other persons.

3. It is further declared that stamp duty payable on this undertaking shall be borne by me.
