FEI JUMING WORLD CHALLENGE 2022 NORTH INDIA

General

1. The FEI Jumping World Challenge 2022 will be conducted from October 13th to October 23rd 2022 and will be conducted as per the rules of the Equestrian Federation of India/ FEI Jumping World Challenge 2022 rules by Modi Equestrian Academy, Modi Puram.

2. **Program** Schedule of Events – Attached as **Appendix 'A'**

3. **Entry** Entries for FEI Jumping World Challenge 2022 are to be submitted to the Equestrian Federation of India office latest by October 8th 2022, 1700 hours on a proper entry form as attached at **Appendix 'B'**. No entries will be accepted after the due date under any circumstances, as the same has to be entered through FEI IT Platform.

4. **Stabling/ Camp facility & Charges**

(i) Venue & stabling will be open on October 12th 2022 1700 hours and close on October 24th 2022 1000 hours.

(ii) Limited show stables are available and will be allotted on first cum first serve basis.

(iii) All teams that require stables must send their requirements before October 3rd 2022 to the OC, after which no stable requests will be accepted. All requirements are to be submitted on the prescribed stable/ camp request form on sent via what's app on **9311330573**.

(iv) It will be at the discretion of the participant to choose the stabling facility as given below:

- If the OC provides an area wherein the participants will build their own temporary shed, charges levied will be maximum Rs. 500/- per horse to take care of electricity, water and cleaning charges thereof.

OR

- If the OC provides permanent show stables constructed by them for the duration of the event the charges levied will be a maximum of Rs. 2500 per horse.

ADMINISTRATION

5. **Venue.** The event will be held at Modi Equestrian Academy, Modi Puram. Route chart of the same is attached.

(Note: The venue will open on **October 12th 2022 at 1700** Hours and close on **October 24th 2022 at 1000 hours**)

(NOTE: Athletes, grooms, trainers, family, or any other person visiting Modi Equestrian Academy will not be permitted to enter without the Covid 19 Self Declaration & Travel Declaration form as prescribed by EFI)

6. **Camp.** All horses will be stabled at Modi Equestrian Academy. Stables will be allotted by the organizing committee to all teams depending on the number of horses per team. All horse handlers are permitted to stay along with the horses in temporary accommodation earmarked for the same. All teams are requested to share the number of horses/ handlers per contingent, which are likely to come latest by **October 3rd 2022** with the show secretary via E-mail.

7. **Self-containment.** In addition to the above all teams must be self-contained in terms of tentage, equipment for camping and transport in order to be prepared for any unforeseen emergency.

8. **Ration /Fodder;** All teams should bring their own feed, hay, bedding, grass, etc. for their horses and should make their own provision for staff food. Modi Equestrian Academy will not provide any assistance for the above unless special facilities are being provided for all teams.
9. **Coggin's and Glanders Test;** All rules and instructions issued from the EFI on this subject will be strictly adhered to by all participating teams. All teams must produce a valid negative EIA and Glanders status certificate on arrival with a validity advised by the governing authorities.
10. **Veterinary commission** The Veterinary Commission detailed by Equestrian Federation of India, Modi Equestrian Academy will have the right to examine all the horses participating.
11. **Veterinary Assistance:** **Dr. Vikram Malhotra** is the official VET for all Modi Equestrian Shows. Mobile - +919871490564. The charges will be borne by the horse owners.
12. **Farrier** All teams and riders are responsible to arrange their own farrier.
13. **Medical cover.** The organizing committee shall not accept any liability for medical treatment given to a competitor on the venue or the consequences thereof. Each rider participating in the FEI Jumping World Challenge 2022 will fill the Indemnity Bond attached as and submit the same along with entry form.
14. **Insurance.** The organizing committee recommends units/club/associations to take insurance policies for competitors, personnel, grooms and horses for their transportation to Modi Equestrian Academy and during the conduct of the events. The organizing committee will assume no responsibility for any accident or illness due to fall of any horse, competitors, groom/ any other member of the team.

15. **Responsibility.** The organizing committee accepts no responsibility for any loss, damage or injury to any animal or any other property or the exhibitors themselves.

16. **Clearance Certificate.** Horse owners are required to obtain clearance certificate from the OC during work hours. All concerned accounts need to be cleared before they can obtain the same. No horses/ Person will be allowed to leave by the Camp In-charge without the clearance certificate.

18. **COVID-19 Protocol.** In light of the COVID-19 pandemic, strict protocols and guidelines must be followed in order to ensure a safe and successful conduct of the event. The guidelines for resuming equestrian training and competition activities in a COVID-19 environment issued by the EFI will be strictly adhered to.

A separate set of guidelines will be sent from time to time to ensure safety of all. You are all requested to abide by the same. All decisions made by the

COVID – 19 Compliance Officer will be final and binding.

It is mandatory for all athletes, parents, trainer, grooms and all accompanying individuals to fill the COVID – 19 Self Declaration Form.

TECHNICAL INSTRUCTIONS

19. Technical Specifications.

Event will be conducted as per FEI Jumping World Challenge Rule 2022/ FEI Jumping Rules.

20. Entries.

(a) All entries will be on proper Entry Form as attached for the FEI Jumping World Challenge 2022 and should be completed in all respect and to be submitted to the Equestrian Federation of India Office. Entries not on the prescribed entry form will not be considered.

(b) **Entry Fee:** Rs 500/- per competition

(c) **Closing date for Entries** All entries for FEI Jumping World Challenge 2022 will close by **October 8th 2022 at 1700 hours**. Entries received thereafter will not be accepted under any circumstances.

(d) **FEI JWC Horse declaration** Participants with more than **one** horse need to fill the FEI Horse declaration form and submit to the organizing committee before the vet check duly signed by PGJ.

(e) **Description and Registration of Horses;** All entries must give the description, EFI Registration/Passport/Show Number, name and year of birth of the horse concerned.

21. EFI Horses Passport As per EFI rules all horses participating in the FEI Jumping World Challenge 2022 events must have a valid EFI passport in original. Entries will not be accepted without the EFI Registration/Passport/Show Number of the horse.

22. EFI Rider Registration.

(a) All riders participating in the FEI Jumping World Challenge 2022 must have a valid EFI Rider Identification Number.

(b) Riders not having EFI rider ID No. will not be permitted to participate.

23. **Withdrawal, Change, Transfer or Substitutions of Entry.**

(a) **Withdrawal.** The entry fee of a horse will not be refunded if the horse does not participate in the class.

(b) **Transfer and Substitutions.** A horse cannot be transferred from one class to another without paying an additional entry fee for the class to which is transferred. A horse once entered in any event cannot be substituted by another horse for any reason whatsoever.

(c) **Change of Riders;** Riders cannot be changed unless the Jury accepts that there are sufficient reasons for change of riders. All changes will be treated as Fresh Entries. Once an event has started, being judged, no change in rider / horse will be accepted.

24. **Cancellation or reschedule;** The Organizing committee may cancel or reschedule any class which has less than four entries or for any reason after consultation with EFI who will apprise the FEI for the same. In that case, the entry fee will be refunded. However, depending on the numbers of entries received, the organizing committee may decide against this for any particular event.

25. **Reporting for Each Class.** All horses will report to the collecting ring Steward half an hour before the time of judging of the class. Any entry not reporting in time will be eliminated unless the exhibitor shows good cause for the delay. The Ring Steward has full authority to take disciplinary action.

26. **Show Number.** All horses will display the EFI Registration Number on the bridle during competition and veterinary inspection and whenever taken out of the stable under the saddle.

27. **Abuse/ Cruelty to horses.** As per relevant rules of EFI/FEI.

28. **Rosettes.** A horse will wear no rosettes during judging.

29. **Elimination / Disqualification.** The judges are empowered to disqualify the competitors at any stage of the competition for rough handling, or any type of cruelty to animals. Rapping will be severely penalized.

30. **Whips/spurs.** As per EFI and relevant FEI rules per discipline.

31. **Dress code.** As per EFI rules.
32. **Appeal.** Appeal may be lodged in writing by the team captain/competitors as per FEI GR 161. A fee equivalent to 150 CHF should be deposited with the show secretary, MEA along with the objection. Money will be refunded if the objection is upheld.
33. **Compliance of NADA Rules** As per the rules in vogue, each participant (both human and equine) are liable for screening for doping at EFI approved events. In view of the above, athlete if approached by NADA to give sample for drug testing are mandatorily required to comply with the same. Any refusal may result in debarment of the athlete.

DECLARATION (INDEMNITY BOND)
