REGIONAL EQUESTRIAN LEAGUE PROSPECTUS

General

1. The Regional Equestrian League 2022 will be conducted from 13 Nov to 14 Nov 2022 and will be conducted as per the rules of the Equestrian Federation of India by Verdinand Equestrian Academy, Bijwasan.

2. **Entry fees and stabling charges** for riders participating in Regional Equestrian League 2022, Jumping & Dressage:

Entry fees: INR 500

Post entry: INR 1000

Stabling charges: As per EFI Guidelines (Please contact OC)

Note: The entries will not be accepted without the COVID – 19 Self Declaration Form.

ADMINISTRATION

3. **Venue.** All events will be held at Verdinand Equestrian Academy, Bijwasan. Route chart of the same is attached.

(Note: The venue will open on 11 Nov 2022 at 1700 Hours)

4. **Camp.** All horses will be stabled at Verdinand Equestrian Academy, Bijwasan. Stables will be allotted by the organizing committee to all teams depending on the number of horses per team. All horse handlers are permitted to stay along with the horses in temporary accommodation

earmarked for the same. All teams are requested to share the number of horses/ handlers per contingent, which are likely to come latest by **09 Nov 2022** with the show secretary via E-mail.

5. **Self-containment.** In addition to the above all teams must be self-contained in terms of tentage, equipment for camping and transport in order to be prepared for any unforeseen emergency.
6. **Ration /Fodder;** All teams should bring their own feed, hay, bedding, grass, etc. for their horses and should make their own provision for staff food. Verdinand Equestrian Academy will not provide any assistance for the above unless special facilities are being provided for all teams.
7. **Coggin's and Glanders Test;** All rules and instructions issued from the EFI on this subject will be strictly adhered to by all participating teams. All teams must produce a valid negative EIA and Glanders status certificate on arrival with a validity advised by the governing authorities.
8. **Veterinary commission** The Veterinary Commission detailed by Equestrian Federation of India, Verdinand Equestrian Academy will have the right to examine all the horses participating.

9. **Veterinary Assistance**: Mr Rajesh Kumar is the official VET for all Equestrian Shows at Verdinand Equestrian Academy. Mobile - +919774964322. The charges will be borne by the horse owners.

10. **Medical cover**. The organizing committee shall not accept any liability for medical treatment given to a competitor on the venue or the consequences there of. Each rider participating in the Regional Equestrian League will fill the Indemnity Bond attached as and submit the same along with entry form.

11. **Insurance**. The organizing committee recommends units/ club / associations to take insurance policies for competitors, personnel, grooms and horses for their transportation to Verdinand Equestrian Academy and during the conduct of the events. The organizing committee will assume no responsibility for any accident or illness due to fall of any horse, competitors, groom/ any other member of the team.

12. **Responsibility**. The organizing committee accepts no responsibility for any loss, damage or injury to any animal or any other property or the exhibitors themselves.

13. **Clearance Certificate**. Horse owners are required to obtain clearance certificate from the OC during work hours. All concerned accounts need to be cleared before they can obtain the same. No horses/

Person will be allowed to leave by the Camp In-charge without the clearance certificate.

15. COVID-19 Protocol. In light of the COVID-19 pandemic, strict protocols and guidelines must be followed in order to ensure a safe and successful conduct of the event. The guidelines for resuming equestrian training and competition activities in a COVID-19 environment issued by the EFI will be strictly adhered to.

A separate set of guidelines will be sent from time to time to ensure safety of all. You are all requested to abide by the same. All decisions made by the

COVID – 19 Compliance Officer will be final and binding.

It is mandatory for all athletes, parents, trainer, grooms and all accompanying individuals to fill the COVID – 19 Self Declaration Form.

TECHNICAL INSTRUCTIONS

16. The Regional Equestrian League 2022 will be conducted from 13 Nov to 14 Nov 2022 as per latest EFI REL Guidelines 2022.

17. **Schedule of Tentative Events for REL.** Refer attached schedule.

18. **Entries.**

(a) All entries will be on proper Entry Form as attached for the Regional Equestrian League and should be completed in all respect. Entries not on the prescribed entry form will not be considered.

(b) **Entry Fee:** INR 500

(c) **Closing date for Entries** All entries for the Regional Equestrian League will close by **10 Nov 2022 at 1700 hours**. Entries received thereafter will not be accepted under any circumstances.

(d) **Description and Registration of Horses;** All entries must give the description, EFI Registration/Passport/Show Number, name and year of birth of the horse concerned.

19. **EFI Horses Passport.**

As per EFI rules all horses participating in the Regional Equestrian League events must have a valid EFI passport in original. Entries will not be accepted without the EFI Registration/Passport/Show Number of the horse.

20. **EFI Rider Registration.**

- (a) As per EFI rulings all Riders participating in the EFI Events have to be registered with the EFI.
- (b) Entries will not be accepted without Valid /RENEWED/ ACTIVE EFI registration number.
- (c) All the riders, participating in the EFI recognized events should be in possession of Renewed EFI identity number in 2022.
- (d) NRI/OCI Card Holders. OCI Card Holders/NRI's/ Foreigners shall be given Rider ID but they cannot participate in RELs and NEC which shall be only for Indian Citizens. NRI/OCI Card Holders/Foreigners would be allowed to participate in REL/NEC as HC entry only.

21. **Withdrawal, Change, Transfer or Substitutions of Entry.**

- (a) **Withdrawal:** The entry fee of a horse will not be refunded if the horse does not participate in the class.
- (b) **Transfer and Substitutions.** A horse cannot be transferred from one class to another without paying an additional entry fee for the class to which is transferred. A horse once entered in any event cannot be substituted by another horse for any reason whatsoever.
- (c) **Change of Riders;** Riders cannot be changed unless the Jury accepts that there are sufficient reasons for change of riders. All changes will be treated as Fresh Entries. Once an event has started, being judged, no change in rider / horse will be accepted.

(d) **Technical specification of events**; the events will follow broadly the technical guidelines of FEI and EFI as per relevant discipline.

22. **Cancellation or reschedule**; The Organizing committee may cancel or reschedule any class which has less than four entries or for any reason in consultation with EFI. In that case, the entry fee will be refunded.

23. **Reporting for Each Class**; All horses will report to the collecting ring Steward half an hour before the time of judging of the class. Any entry not reporting in time will be eliminated unless the exhibitor shows good cause for the delay. The Ring Steward has full authority to take disciplinary action.

24. **Show Number**. All horses will display the EFI Registration Number on the bridle during competition and veterinary inspection and whenever taken out of the stable under the saddle.

25. **Abuse/ Cruelty to horses**. As per EFI and relevant FEI rules per discipline.

26. **Rosettes**; A horse will wear no rosettes during judging.

27. **Elimination / Disqualification** The judges are empowered to disqualify the competitors at any stage of the competition for rough handling, or any type of cruelty to animals. Rapping will be severely penalized. Refer to relevant FEI Rules.

28. **Whips/spurs**; As per EFI and relevant FEI rules per discipline.

29. **Dress code**; As per EFI guidelines.

30. **Appeal**; Any appeal shall be dealt as per FEI GR 161.

DECLARATION (INDEMNITY BOND)
