GENERAL INSTRUCTIONS

1. EFI COVID19 PROTOCOL

All participants will have to comply with the Covid 19 protocol for equestrian training and events issued by EFI. All riders, horse owners, syces should maintain social distancing, wearing of mask and using hand sanitizers is compulsory.

2. ENTRIES

There shall be an entry fee of Rs.500/- for every Individual Event.

The last date for receipt of the entries is 15 Dec 2022. All entries received from 15 Dec 2022 and till two hours before vet inspection of the event, will be considered as a post entry and the **fees will be Rs. 1000/- for individual entries.** Entry not sent on the Prescribed form or not accompanied by Birth Certificate and EFI registration number, will not be entertained.

3. ENTRY FORM

All entries must be sent in the prescribed form attached to this prospectus. The name of the rider must be specifically mentioned in the Entry Form. A horse, once entered, cannot normally be substituted by another horse. The same horse cannot compete in the same event by different riders. The organizers reserve the right to reject any entry without assigning any reasons.

4. PAYMENTS.

All payments will be made to "Elite Sports Academy" in the form of NEFT / RTGS or cash only. **Cheques will NOT be accepted.**

5. WITHDRAWAL OF ENTRIES

Any entry can be withdrawn till 15 Dec 2022 without attracting any loss of fees. No refund of fees will be allowed for entries withdrawn after 15 Dec 2022 unless it has to be withdrawn on Veterinary grounds, and in such cases, a certificate from the Veterinary Officer will be required.

6. CHANGE OF HORSE/RIDER

A horse/rider can be changed only up to two hours prior to the draw of lots of the event. However, the entry shall be treated as a post entry.

7. CANCELLATION OF AN EVENT:

In case the organizers feel that there are not enough entries for any particular event, that event may be cancelled. Such cancellation or alternative arrangements will be announced at the time of draw of lots for the events, a day prior to the event.

8. ARRIVAL OF THE HORSES/ RIDERS AT THE SHOW GROUND:

All horses/riders should be present at the venue half an hour before the scheduled starting time for the respective event and report to the Marshal of the event.

9. CHANGE IN SCHEDULE OF EVENTS:

The organizers may make changes in the schedule of events for which necessary announcements will be made at the event area.

10. REGISTRATION OF HORSES WITH EFI: (EFI Horse passport)

- (a) As per EFI rules all horses participating in the REL have to be in possession of EFI passport.
- (b) No entry will be accepted without EFI registration number. For further information pertaining to registration, contact EFI.

11. REGISTRATION OF RIDERS:

- (a) All the riders participating in the EFI recognized events should obtain EFI ID no.
- (b) A rider who does not have an EFI rider ID number will not be permitted to take part in REL.

12. SHOW NUMBERS:

All horses will display the EFI Registration Number on the bridle during competition, veterinary inspection and whenever taken out of the camp.

13. JUDGING

The decision of the Judges will be final.

14. OBJECTIONS. As per FEI relevant rules.

15. LOSS OR DAMAGE

The organizers accept no responsibility for any loss, damage or injury to any horse, rider or to any other person or property arising directly or indirectly from accident or any other causes. Neither the Committee nor the Vet / Med doctor will be held responsible for any first aid or other medical treatment provided.

16. ABUSE/CRUELTY

As per EFI and relevant FEI rules per discipline.

17. ABANDONMENT

If for any reasons the show has to be abandoned, the competing units/civilian participants and concerned riders will be informed by fax, email or wireless.

18. RULES

The rules of the Equestrian Federation of India (EFI) and the ITPF will be followed for the conduct of the events of the competition, until and unless otherwise specified for any event.

19. TACKS, WHIPS AND SPURS

As per EFI guidelines and relevant ITPF rules

20. **Insurance:** The Organising Committee recommends units/clubs/associations to take insurance policies for competitors, personnel, grooms and horses during the events. The Organising Committee will assume no responsibility for any accident or illness due to fall of any horse, competitors, grooms/any other member of the team.

CAMPING:

1. **Camp:** The camping space for horses and grooms of all participants will be available at the Elite Sports Academy Ground, Ghaziabad for the duration of the REL Tent Pegging. Charges for Horse Parking at ESA are earmarked at INR 500 per Horse for the entire duration of REL 16-19 Dec 2022. The Camp for Stabling will Open on 16 December 2022 and close on 19 December 2022.
2. **Self Containment:** All teams coming to participate in the REL must be self-contained i.e they should bring their own tentage, equipment for camping, cooks and transport, etc. For teams that wish to get Tentage, fodder, food etc may request with the CAMP Commandant at-least 1 week in advance to arrange the same on payment basis
3. **Ration/Fodder:** All participants are advised to bring maximum quantity of grain/fodder to sustain their horses during their stay in Ghaziabad (U.P).
4. **Coggin and Glander Tests:** All rules and instructions issued from the EFI on the subject will be strictly adhered to by all concerned. All horses must produce a valid negative EIA and Glander status (CFT) certificate on arrival to Ghaziabad. Coggins and Glanders negative certificate with a validity of a minimum of 15 days on arrival and exit of horses from the camp is mandatory.
5. **Security Deposit:** All contingents temporarily stabling at the ESA will pay **refundable** Security Deposit of INR 5,000 (Five Thousand Indian Rupees) prior to setting up camp as under. The amount is returned after inspecting the camp area by the The Camp Commandant.

(a) **Security.** Entry and stabling within the ESA will be regulated by the OIC ESA. No permanent structure will be constructed at the GHRC by the equestrian teams both Army and civil. Separate camping area will be earmarked for Army and civilian contingents. They will strictly adhere to the rules and regulations for the camping facility. Any violation of the rules would render the concerned contingent liable to be asked to vacate the ESA premises forthwith.

(b) **Documentation.** Following documents should be submitted for considering the camping facility as per **Appendix 'B'** attached:-

- (i) Application to be addressed to the OIC/Camp Commandant GHRC.
- (ii) Passport of horses (issued by EFI).
- (iii) Coggins and glanders negative certificate valid for a minimum of 15 days at the time of entry.
- (iv) Certificate/affidavit.
- (v) Indemnity Bond.
- (vi) Undertaking certificate.
- (vii) Details of Horses.
- (viii) COVID-19 Self Declaration Form.

(c) **Discipline.**

- (i) No liquor is permitted within the ESA premises. Intoxication, assault or affray will be viewed seriously and will result in the individuals being expelled immediately and in turn vacation of the respective camp with immediate notice.
- (ii) Cooking on fire wood is not permitted.
- (iii) No contingent will tap electricity lines.
- (iv) No horses will be tied to trees nor will support of trees be taken for construction of camp.

6. **Insurance Cover.** It is recommended that all players/individual take insurance against any injury sustained while participating in the events or practicing at the GHRC. It would be ideal for the ponies as well to be covered under some insurance policy. The Camp Commandant may be informed as regard the above while signing the medical declaration. The OC Ghaziabad Horse Show excludes all liability for any injury and/or loss occasioned to any person and/or their property within the premises of GHRC, Ghaziabad.

7. **Clearance Certificate.** All riders are required to obtain a clearance certificate from the Camp Commandant office during working hours. All outstanding needed to be cleared before they can obtain the same.

8. **Final Decision.** The decision of the Organizing Committee will be final on all matters connected with the REL Tent Pegging.

MISCELLANEOUS

9. **Hotels:** Ghaziabad has various categories of **Hotels** from OYO Rooms to 4 Star Hotels. The players requiring Hotel Rooms may request the Camp Commandant to facilitate the same on direct payment to the Hotels.
