FEI JUMPING CHILDREN CLASSIC'S (SILVER & BRONZE TOUR)-2022

General.

1. FEI Jumping Children Classic's (Silver & Bronze Tour)-2022 will be held at Sagar Equestrian Sports Academy, Jaipur from 17 - 20 Nov 2022.
2. Selection trial for Selection of Team India will be conducted on 17 Nov 2022.
3. Technical specification will be as per FEI Jumping Children Classic's Rule-2022 as attached at **Appendix A** and other relevant rule of FEI.
4. **Programme.** Tentative Programme of FEI Jumping Children Classic's (Silver & Bronze Tour) - 2022 are attached at Appendix '**B**'.

5. Entries.

- (a) All entries will be on proper Entry Form as per format attached at **Appendix 'C'** should be submitted to EFI office latest by 15 Nov 2022.
- (b) **Entry Fee.** Rs 500/- per entry.
- (c) **Closing date for Entries:** Entries for FEI Jumping Children Classic's (Bronze Tour)-2021 will be closed on **November 15, 2022**. No Entries will be accepted post this date.
- (d) **Description and Registration of Horses.** All entries must give description, EFI Registration/Passport/Show Number, name & year of birth of the horse.
- (e) **FEI Horse Declaration.** Participants with more than one horse need to fill the FEI horse declaration form and submit to the organizing committee before the VET Check.

6. EFI Horses Passport.

- (a) As per EFI rulings ALL horses participating in the FEI Jumping Children Classic's -2022 should be in possession of EFI passport. No entry will be accepted without valid EFI Horse Passport.
- (b) Team captains are requested to ensure that all horses are registered before entries for the Event. The registration No has to be filled in the entry form as per EFI ruling. Entries will not be accepted without EFI registration number.

7. EFI Riders ID Number.

- (a) As per EFI ruling any riders participating in the FEI Jumping Children Classic's-2022 need to have EFI ID No. The EFI ID No has to be filled in the Entry Form as per EFI ruling. Entries will not be accepted without EFI ID number.
- (b) All the riders, participating in the FEI Jumping Children Classic's-2022 should be in possession of Renewed EFI identity number for the year 2022.

8. Withdrawal, Change, Transfer or Substitutions of Entry.

- (a) **Withdrawal-** The entry fee of a horse entered for any category will not be refunded if the horse does not participate in the class.

(b) **Transfer and Substitutions** – A horse cannot be transferred from one class to another without paying an additional entry fee for the class to which it is transferred. A horse once entered in any category cannot be substituted by another horse for any reason whatsoever.

(c) **Change of Riders** – Riders cannot be changed unless the jury accepts that there are sufficient reasons for change of riders. Once a class has started being judged, no change in rider will be accepted.

9. **Cancellation**. The organizing Committee may cancel any class which has less than four entries or for any reason at their discretion. In that case, the entry fee will be refunded.

10. The class will start once the draw of lots for the order of start has been held.

11. **Show Number**. All horses will display the EFI registration number on the bridle during competition and veterinary inspection and whenever taken out from the stable.

12. **Rosette**- No rosette will be worn by a horse during judging.

13. **Elimination/Disqualification**. The judges are empowered to disqualify the competitors at any stage of the competition for rough handling, excessive brutality or any form of cruelty to animal. Rapping will be severely penalized.

14. **Whips/Spurs**. As per FEI/EFI rules on the subject.

15. **Dress Code**. When inspection the course, dress must be neat and tidy. In any case, riding boots, white breeches, a white or lightly colored plain shirt, white tie and Jacket must be worn. Service personnel will be in uniform. It is compulsory for anyone jumping a horse to wear a properly fastened hard hat with three point retention harness.

16. **RULES**. FEI Jumping Children Classic's Rule-2022 and other relevant rules of FEI/EFI will be followed for the conduct of the events of the competition.

17. **JUDGING**. The decision of the judges will be final.

18. **Protest/Appeal**. Protest can be lodged by competitors in terms of FEI GR 161. A fee equivalent to 150 CHF should be deposited with the Show Secretary, SESA along with the protest. Money will be refunded if the protest is upheld.

19. **Medical Cover**. Sagar Equestrian Sports Academy (SESA) will provide medical cover for riders at the venue. SESA not accept any liability for medical treatment given to a rider on the venue or the consequences hospital where necessary, through every possible means available. Each rider participating in the FEI Jumping Children Classic's 2022 will fill the indemnity Bond attached at **Appendix E** and submit the same along with entry form.

20. **Insurance**. The Organizer recommends that clubs/associations/schools to take Insurance policies for competitors, personnel, grooms and horses for their transportation to Jaipur

during the events. The Organizer will assume no responsibility for any accident or illness due to fail of any horse, competitors, groom/ any other member of the team.

21. **Responsibility.** The Organizer accepts no responsibility for any loss, damage or injury to any animal or any other property or the exhibitors themselves. Neither the Organizer nor the Doctor will be held responsible for any aid or other medical treatment provided.

22. **Reporting for Each Class.** All horses will report to the collecting ring Steward half an hour before the time of judging of the class. Any entry not reporting in time will be eliminated unless the exhibitor shows good cause for the delay. The Ring Steward has full authority to take appropriate action as per existing rules.

23. All events scheduled in the afternoon will continue under lights, when required.

24. **Accommodation.** All Participants are required to make arrangement for their accommodation. In Case any assistance is required you may contact show secretary SESA Jaipur.

25. **Abuse/cruelty to horses.** As per relevant rules of FEI.

26. **Camp.** The SESA has permitted stabling of horses for all participants in SESA, Jaipur for the duration of the event. Permission to stable horses during the above period is subject to certain conditions to this prospectus. Security aspects as mentioned in to civilian employees of all contingents including Club members entering the SESA for temporary stabling will be strictly adhered to. No civilian employee of any contingent will be allowed to enter SESA without civil police verification. Camp will open on 15 Nov 2022.

27. It will be at the discretion of the participant to choose stabling facility as given below:-

If the OC provides an area wherein the participants will built their own temp shed, charges levied will be max Rs 500/- per horse to take care of electricity, water and cleaning charges thereof.

OR

If the OC provides a temp stable constructed by them for duration of a event or a permanent stable, the charges levied will be max Rs 2500/- per horse for the duration the event .

28. The Camp In charge will earmark the site for each contingent. The rep of the contingent will take over the site allotted to them from the Camp In charge on arrival & handover the same before departure in the same condition, any damage to camp, accommodation or property will be the responsibility of the contingent. The teams should come self contained in all respects for camping in respect of their personnel and animals. All teams will intimate the total strength of contingent in terms of men and horses positively by 15 Nov 2022 and intimate exact Time of Arrival well in advance to SESA to org Administrative Arrangements.

29. **Self Containment.** All teams coming to participate in the FEI Jumping Children Classic's 2022 must be self-contained in terms of tentage, equipment for camping, cooks, rations and transport in order to be prepared for any unforeseen emergency.

30. **Ration/Fodder**- Army contingents are advised to bring maximum quantity of grain/ fodder to sustain their horses during their Stay in Jaipur or, they can ask for attachment both the local Supply Depot. Other contingents are advised to make their own arrangements for animal rations.
31. **Fire Fighting Arrangement –** All contingents are requested to carry adequate fire fighting equipment.
32. **Coggin and Glander Test.** All rules and instructions issued from the EFI and RVC Directorate, Army Headquarters on the subject will be strictly adhered to by concerned. All horses must produce a valid negative EIA and Glander Status (CFT) certificate on arrival to Jaipur. Coggins and glanders negative certificate with a validity of a minimum of 15 days arrival and exit of horses from the camp is mandatory.
33. **Ground Jury, Veterinary / Technical delegate, Appeal Committee and insurance-** These are as per Equestrian Federation of India under governing competitions.
33. **Spectators.** The Spectators or the supporters of the participants are not to interfere with the judges. The Arena Steward has the right to eliminate any participant who has outside help. Once the event has commenced, all spectators and helpers are to clear the arena. The Judges decision will be final. Parents must not enter the arena or dispute the decision or directly confront the judges.
34. **Prize Distribution.** Tentatively prizes will be distributed after each event on the same day.
35. **Trotting Parade.** All participants are requested to present their horses for veterinary inspection as per Appx B.
36. **Veterinary Commission.** The Veterinary Commission detailed by the Equestrian Federation of India will have full right to examine all the horses participating.
37. **Veterinary Assistance.** The following is available for vet assistance in case of an emergency:-

38. **Clearance Certificate –** All horse owners/riders are required to obtain a clearance certificate from the Show Office during working hours. All accounts concerned needed to be cleared before they can obtain the same. No horses will be allowed to leave unless they obtain the clearance certificate.
39. **Compliance of NADA Rules and EFI Equine Anti- doping and Controlled medication Regulation (EADCM).** As per rules in vogue each participant (Both human and Equine) are liable for screening for doping at EFI approved events. In View of the above, athlete if approached by NADA to give sample for doping testing are mandatorily required to comply with the same . Any refusal may result in debarment of the athlete.
40. **COVID 19 Protocol.** In light of the Covid 19 pandemic, strict protocols and guidelines must be followed in order to ensure a safe and successful conduct of the event. Strict adherence to MHA/MP state guidelines as renewed from time to time will be followed. The guidelines for

resuming equestrian trg and competition activities in a covid 19 environment issued by the EFI will be followed strictly.
