REGIONAL EQUESTRIAN LEAGUE (TENT PEGING & JNEC)

COVID GUIDELINES

- a) Wearing a mask at all times in ground, camp, show office etc. is mandatory.**
- b) All riders, grooms, horse owners, competitors, spectators and parents must carry sanitizes at all times.**
- c) A hand wash sink along with antiseptic soap will be provided by organizers. All riders, grooms, horse owners, competitors, spectators and parents are advised to wash their hands properly.**
- d) All riders, grooms, horse owners, competitors, spectators and parents are requested to maintain a distance of between each other in camp, ground show office and during the competition.**
- e) All riders, grooms, horse owners, competitors, spectators and parents are requested to kindly follow guidelines of State/Centre Govt. for COVID and other related instructions and guidelines.**
- f) All riders' groomers, horse owners, spectators (above 18 years) and parents coming with teams for REL must get both dose of Covid Vaccination.**
- g) All riders, grooms, horse owners, competitors, spectators and parents, who are coming from other states are mandatory to get their RT-PCR covid test negative report before entering the Punjab. Not any person will allowed entering in ground without RT-PCR negative report.**

INTRODUCTION

The PAP Horse Riding Club hosting the **Regional Equestrian League on 30-31 Oct. 2022** according of the rules of the Equestrian Federation of India, at PAP Campus Jalandhar . 1. **Venue.** Regional Equestrian League will be conducted on **30-31 Oct. 2022** at PAP Campus Jalandhar
2. List of Events & Schedule of Events are attached as Annexure I.
3. All Entries will be made on the entry form attached as Appendix II and will be as per the E.F.I. rules.
4. No entry will be accepted without an entry- fee. This rule will be implemented across the board for all events.
5. Entry fees:- Rs. 500/- per rider/event.

Payment: All entries must be made to the Show Secretary at the show office.
6. No entry will be accepted after the Draw of Lots for the particular event.
7. A horse cannot be transferred from one event to another without paying an additional entry fee for the event, a horse once entered, in any event cannot be substituted by another horse for any reason whatsoever.

8. In the Tent Pegging Event the minimum age requirement of a rider is 16 yrs.
9. **Closing date for receipt of entries.**_____The last date for submission of entries is 29 Oct 2022 (5PM).
10. The payment for the entries can be submitted once the teams arrive. Otherwise, all entries on prescribed forms must reach the show office by 29 Oct 2022 (5-00 PM). The entries can be sent by email at the following addresses:-

Note:- After the closing date all entries must be treated as Post Entry, which will be double to the Normal Entry.

11. **Registration of horses :-**All Horses participating in **Regional Equestrian League** must be registered with EFI. EFI No.'s will be displayed on the bridle, when the horse moves out of the stables camping area during stay during REL.
12. **EFI Rider ID:-** All riders participating in the Regional Equestrian League must have the Rider Identification No's allotted by the Equestrian Federation of India. No rider will be allowed to participate in Regional Equestrian League without EFI Rider ID, which must have renewed in the year of 2022-23.

NOTE:- IF ANY RIDER OR HORSE PARTICIPATES IN REL's WITHOUT RIDER ID/HORSE REGISTRATION NUMBER/RENEWAL OF RIDER ID/RENEWAL OF HORSE REGISTRATION NUMBER.HIS RESULT WILL NOT BE SEND TO EFI FOR CONSIDERATION FOR NEC/JNEC.

13. **Withdrawal. Substitution or Change of Entry/Rider.**

(a) **Withdrawal.** The Entry fee of a horse entered for any event will not be refunded if the horse does not participate in the event.

(b) **Change of Riders.**

- (i) Riders or Horse can be changed only on medical ground with sufficient Medical Certificate BY Veterinary Commission.
- (ii) Once an event has started being judged, no change in rider will be accepted.

14. **Camp.**

(i) The camp will be located at PAP Jalandhar. The Camp In-charge will earmark the site for each contingent. The Camp will become operational on 28 Oct 2022 and will be closed on 01 Nov 2022.

(ii) Horses, grooms/farriers coming in **Regional Equestrian League** will stay in the camping area. No team will be allowed to enter the camping area before 28 Oct 2022.

(iii) Advance information about the number of participants/ horses must be conveyed to the organizers by 28 Oct 2022 so as to finalize camping arrangements.

15. **Self-Containment.** All teams coming to participate in the **Regional Equestrian League must be self-contained**, i.e they should bring their own equipment, tent, feed, fodder, cooks, farriers and transport etc.

16. **Climate.** The climate in the month of October is pleasant. Participants are advised to make requisite arrangements.

17. **Lighting.** The participants are requested to bring their own Hurricane Lanterns/ Petromax Lamps for emergency use. Power / light will be provided under camp arrangements where feasible.

18. **Discipline.** All the participants staying in the camp will be under the camp in-charge for the purpose of discipline.

19. **Fire Precautions.** All the participants are required to undertake fire-fighting precaution in their respective areas.

20. **Sanitation and Hygiene.** All participants should observe proper sanitation and hygienic measures. There should be proper disposal of litter at pre designated location.

21. **Medical Assistance.** Medical assistance will be provided at the camp site and competition area.

22. **Veterinary Assistance.** Veterinary assistance will be available at the Camp site and competition area.

23. **Responsibility.** The organizing committee accepts no responsibility for any injury or loss to entrant/competitor through accident or any other cause. Neither the organizers nor the vet / medico will be held responsible for the consequences of the first aid or other medical treatment given to any injured horse or rider

24. **Whips and Spurs.** As per EFI and relevant FEI rules per discipline. Any form of beating, punishment and brutality to horse will lead to disqualification & elimination of the competitor.
25. **Coggins & Mallein Test.** All participating horses must possess a negative Coggins and Glanders Test (CFT) Report. No horse will be allowed inside the camping area without valid negative Coggins and Glanders Test (CFT) Reports.
26. **Cancellation.** The Organizing committee may cancel any event for any reason entirely at their discretion. In such case, the entry fee will be refunded.
27. **Reporting for each class.** All horses will report to the Arena Steward half an hour before the time of judging of the class. Any entrant not reporting in time will be eliminated unless the exhibitor shows good cause for the delay. The Arena Steward has full authority to take disciplinary action.
28. **Spectators/outside assistance.** The spectators or the supporters of the participants are not to interfere with the Judges. The Arena Steward has the right to eliminate any participant who has outside help. Once the event has commenced, all spectators and helpers are to clear the arena. The Judges' decision will be final. Parents must not enter the arena or dispute the decision or confront the Judges.
29. **Veterinary Inspection.** All participants for the **Regional Equestrian League** are required to present their horses for veterinary Inspection (Trotting Parade) on 30 Oct 2022 at 08.00 AM.in the competition grounds along with a copy of the Coggins & Glander Test report and EFI passports of the horses.
30. **Conduct Rules.**
- (a) The events of REL will be conducted & adjudged as per rules of EFI (Equestrian Federation of India).
 - (b) The events are judged by the panel of judges who are experts in the field of equestrian sports.
 - (c) The decision of the jury will be final.
31. **Appeal.** Any appeal shall be dealt with as per FEI GR 161.

32. Dress Code and Saddlery:-

i) Dress of riders and Saddlery of Horse: Dress code for participating riders and Saddlery of participating horses will be as per as per FEI/EFI guidelines for the particular events. Team incharges/coaches will ensure that saddlery of their horses is as per guidelines, cleaned and fitted properly.

33. Miscellaneous.

- (a) Should any questions arise not provided for, it must be referred to the organizing committee, whose decisions will be final.
- (b) Scheduling time and entries are subject to alteration at the discretion of the organizing committee.
