REGIONAL EQUESTRIAN LEAGUE PROSPECTUS

General

The Regional Equestrian League 2023 will be conducted from 07th OCT- 08th OCT 2023 and will be conducted as per the rules of the Equestrian Federation of India by Verdinand Equestrian Academy, Bijwasan.

1. Entry fees and stabling charges for riders participating in

2. Venue. All events will be held at Verdinand Equestrian Academy, Bijwasan.

3. Camp. All horses will be stabled at Verdinand Equestrian Academy. Stables will be allotted by the organizing committee to all teams depending on the number of horses per team. All horse handlers are permitted to stay along with the horse in temporary accommodation earmarked for the same. All teams are requested to share the number of horses / handlers per contingent, which are likely to come latest by 05th OCT 2023 with the show secretary via Email.

7.Self-containment. In addition to the above all teams must be self- contained in terms of tent age, equipment for camping and transport in order to be prepared for any unforeseen emergency.

6. **Ration /Fodder;** All teams should bring their own feed, hay, bedding, grass, etc. for their horse and should make their own provision for staff food.

Verdinand Equestrian Academy will not provide any assistance for the above unless special facilities are being provided for all teams.

7. **Coggins and Glanders Test;** All rules and instructions issued from the EFI on this subject will be strictly adhered to by all participating teams.

All teams must produce a valid negative EIA and Glanders status certificate on arrival with a validity advised by the governing authorities.

8. **Veterinary** Verdinand Equestrian Academy will have the right to examine all the horses participating in REL.

9. **Veterinary Assistance:** Mr. Rajesh Kumar is the official VET for all Equestrian Shows at Verdinand Equestrian Academy, Mobile- +919774964322. The charges will be borne by the horse owners.

10. **Medical cover.** The organizing committee shall not accept any liability for medical treatment given to a competitor on the venue or the consequences thereof. Each rider participating in the Regional Equestrian League will fill the Indemnity Bonds attached and submit the same along with entry form.

11. **Insurance.** The organizing committee recommends units/clubs/associations to take insurance policies for competitors, personnel, grooms and horses for their transportation to Verdinand Equestrian Academy and during the conduct of the events. The organizing committee will assume no responsibility for any accident or illness due to the fall of any horse, competitors, groom/any other member of the team.
12. **Responsibility.** The organizing committee accepts no responsibility for any loss, damage or injury to any animal or any other property or the exhibitors themselves.
13. **Clearance Certificate.** Horse owners are required to obtain clearance certificates from the OC during work hours. All concerned accounts need to be cleared before they can obtain the same. No horses/Person will be allowed to leave by the CampIn-charge without the clearance certificate.

16. The Regional Equestrian League 2023 will be conducted from 07th OCT- 08th OCT 2023 as per l a t e s t EFI REL Guidelines 2023.

17. **Schedule of Tentative Events for REL.** Refer attached schedule.

18. **Entries.**

(a) All entries should be on proper Entry Form as attached for the Regional Equestrian League and should be completed in all respects. Entries not on the prescribed entry form will not be considered.

(b) **Entry Fee:** INR 1000/-

(c) **Closing date for Entries** All entries for the Regional Equestrian League will close by OCT 5th 2023 at 1700 Hours. Entries received thereafter will not be accepted under any circumstances.

(d) **Description and Registration of Horses:** All entries must give the description, EFI Registration/Passport/Show Number, name and year of birth of the horse concerned.

19. **EFI Horses Passport.**

As per EFI rules all horses participating in the Regional Equestrian League Events must have a valid EFI passport in original. Entries will not be accepted Without the EFI Registration/Passport/Show Number of the horse.

20. **EFI Rider Registration.**

(a) As per EFI rulings all Riders participating in the EFI Events have to be registered with the EFI.

(b) Entries will not be accepted without Valid/RENEWED/ACTIVE EFI registration number.

(c) All the riders participating in the EFI recognized events should be in possession of the Renewed EFI identity number in 2023.

(d) NRI/OCICardHolders.OCICardHolders/NRIs/Foreigners shall be given Rider ID but they cannot participate in RELs and JNEC which shall be only for Indian Citizens. NRI/OCI Card Holders/Foreigners would be allowed to participate in REL/NECashCentry only.

21. Withdrawal,Change,TransferorSubstitutions of Entry.

(a) **Withdrawal;** The entry fee of a horse will not be refunded if the horse does not participate in the class.

(b) **Transfer and Substitutions.** A horse can not be transferred from one class to another without paying an additional entry fee for the class to which is transferred.A horse once entered in any event can not be substituted by another horse for any reason what so ever.

(c) **Change of Riders;** Riders cannot be changed unless the Jury accepts that there are sufficient reasons for change of riders. All changes will be treated as Fresh Entries. Once an event has started, being judged, no change in rider/horse will be accepted.

(d) **Technical specification of events;** the events will broadly follow the technical guidelines of FEI and EFI as per relevant discipline.

22. **Cancellation or reschedule;** The Organizing committee may cancel or reschedule any class which has less than four entries or for any reason in consultation with EFI. In that case, the entry fee will be refunded.

23. **Reporting for Each Class;** All horses will report to the collecting ring Steward, half an hour before the time of judging of the class. Any entry not reporting in time will be eliminated unless the exhibitors show good cause for the delay. The Ring Steward has full authority to take disciplinary action.

24. **Show Number.** All horses will display the EFI Registration Number on the bridle during competition and veterinary inspection and whenever take out of the stable under the saddle.
25. **Abuse/Cruelty to horses.** As per EFI and relevant FEI rules per discipline.
26. **Rosettes;** A horse will wear no rosettes during judging.
27. **Elimination / Disqualification** The judges are empowered to disqualify the competitors at any stage of the competition for rough handling, or any type of cruelty to animals. Rapping will be severely penalized. Refer to relevant FEI rules.
28. **Whips/spurs;** As per EFI and relevant FEI rules per discipline.
29. **Dresscode;** As per EFI guidelines.
30. **Appeal;** Any appeal shall be dealt as per FEIGR161.
31. **EFI Registration of Horses.**
- (a) As per EFI rules all horses participating in the Regional Equestrian League (REL) for JNEC-2023 have to be in possession of EFI passport.
 - (b) No entry will be accepted without valid EFI Horse Passport which has been timely renewed.
 - (c) Participating horse must be registered with an EFI affiliated club or the owner has to be an individual / life member of EFI. The same shall be checked by OC and cases found in violation will not be permitted to participate in the REL. Also, a list of same will be brought to the notice of EFI as soon as possible.
 - (d) Horses should be in compliance vaccinations as per FEI/EFI vet rules & Regulation.
32. **Registration of riders with EFI.**
- (e) As per EFI rules all Riders participating in the EFI Events have to be registered with the EFI.
 - (f) Entries will not be accepted without **Valid /Renewed/** EFI registration number.
 - (g) Participating rider must be a life/ individual member of EFI or he/her should be a member of registered club of EFI. The same shall be checked by OC and such cases will not be permitted to participate in the REL. Also a list of same will be brought to the notice of EFI as soon as possible.
 - (h) In case an athlete is not in possession of valid/ renewed EFI Rider ID for the year 2023-24 before their participation in the said REL, result of said riders will not be considered towards their MER for JNEC.
