PROSPECTUS EFI SHOW JUMPING (CSN) EVENTS

1. General.

EFI Show Jumping (CSN1*/CSN3*/Grade II/ Grade III & JNEC Category (CSN) events will be organized by Amateur Riders Club Mumbai from 09 Feb to 13 Feb 2023 according to the FEI rules and Technical guidelines of Equestrian Federation of India (EFI) in vogue.

2. CATEGORIES

- (a) Show Jumping 1.40 m over two rounds
- (b) Show Jumping 1.50 m over two rounds
- (c) CSN Grade II Show Jumping (Indl Event only)
- (d) CSN Grade III Show Jumping (Indl Event only)
- (e) CSN Young Rider Show Jumping (Indl Event only)
- (f) CSN Junior Rider Show Jumping (Indl Event only)
- (g) CSN Children I show Jumping (Indl Event only)
- (h) CSN Children II Show Jumping (Indl Event only)

3. PROGRAMME

Schedule of Events - Attached at **Appendix 'A'**

4. ENTRIES

(a) All entries will be given on a proper Entry Form as given in **Appendix 'B'**. Entries not on the prescribed entry form or without entry fee will not be considered.

(b) Entry Fee:

- (i) Normal Entry: Rs.500/- (Entry fee will need to be paid for each category)
- (ii) Post Entry : Rs. 1,000/ -

(c) **Closing Date for Entries:** Entries will close **07 Feb 2023 by 12 noon.** Entries received thereafter will be regarded as **POST ENTRIES**. No entry will be accepted without an entry fee and after vet inspection. Post entries will be accepted till two hours before the vet inspection.

(d) Foreign Nationals & OCI card holders cannot participate in the subject Show Jumping event. It is the responsibility of OC to ensure this aspect by obtaining a copy of Indian Passport from all athletes alongwith entry form.

5. Score achieved by a horse-rider combination in EFI Show Jumping (CSN1*/CSN3*) competition shall be considered for indl/team selection for 19th Asian Games if rider request the EFI for the same as per para 4 and 30 of Selection Criteria (Version-V).

6. **REGISTRATION OF HORSES WITH EFI**

(a) As per EFI rulings, all horses participating in the EFI approved events have to be in possession of the EFI passport. No entry will be accepted without EFI Registration number. For further information pertaining to registration, contact EFI. Please register the horses participating in the event with the EFI prior to the event.

(b) Team captains are requested to ensure that their horses are all registered before entries for the Event. The registration Number has to be filled in the entry form as per EFI ruling.

(c) Entries will not be accepted without EFI registration number.

7. **EFI Rider Registration.**

(a) As per EFI rulings all Riders participating in the EFI Events have to be registered with the EFI.

(b) Entries will not be accepted without valid /RENEWED/ ACTIVE EFI registration number.

(c) All the riders, participating in the EFI recognized events should be in possession of Renewed EFI identity number in 2022-23.

8. **Withdrawal, Change, Transfer or Substitutions of Entry.**

(a) **Withdrawal.** The entry fee of a horse will not be refunded if the horse does not participate in the class.

(b) **Transfer and Substitutions.** A horse cannot be transferred from one class to another without paying an additional entry fee for the class to which is transferred. A horse once entered in any event cannot be substituted by another horse for any reason whatsoever.

(c) **Change of Riders:** Riders cannot be changed unless the Jury accepts that there are sufficient reasons for change of riders. All changes will be treated as Fresh Entries. Once an event has started, being judged, no change in rider / horse will be accepted.

9. **Reporting for Each Class.** All horses will report to the collecting ring Steward half an hour before the time of judging of the class. Any entry not reporting in time will be eliminated unless the exhibitor shows good cause for the delay. The Ring Steward has full authority to take disciplinary action.

10. **Show Number.** All horses will display the EFI Registration Number on the bridle during competition and veterinary inspection and whenever taken out of the stable under the saddle.

11. **Abuse/ Cruelty to horses.** As per relevant rules of EFI/FEI.

12. **Rosettes.** A horse will wear no rosettes during judging.

13. **Elimination / Disqualification.** The judges are empowered to disqualify the competitors at any stage of the competition for rough handling, or any type of cruelty to animals. Rapping will be severely penalized.

14. **Whips/spurs.** As per EFI and relevant FEI rules per discipline.

15. **Dress code.** As per EFI/FEI rules. When inspecting the course, dress must be neat and tidy. In any case, riding boots, white breeches, a white or lightly coloured plain shirt, white tie and Jacket must be worn. Service personnel will be in uniform. It is compulsory for anyone jumping a horse to wear a properly fastened hard hat with three-point retention harness including riders in uniform.

16. **Camping & Accommodation**

(a) Venue & stabling will be open on 20 Jan 2023 and close on 01 Mar 2023.

(b) All teams should come fully equipped with their own tentage for stabling and enough grain and fodder for the duration of the show.

(c) The Organizers will try to arrange for bedding straw and fodder to be made available for sale at retail prices.

(d) All teams that require stables must send their requirements on or before 17 Jan 2023 after which no stable orders will be accepted.

(e) No camp fee will be charged by the OC for horses participating in 19th Asian Games trials. For other events the following will be charged:-

(i) If the OC provides an area wherein the participants will build their own temporary shed, charges levied will be Rs 500/- per horse to take care of electricity, water and cleaning charges thereof.

OR

(ii) If the OC provides a temporary stable constructed by them, the charges levied will be Rs 2500/- per horse for the entire duration of the stay.

OR

(iii) If the OC provides a concrete stable, the charges levied will be Rs 500/- + gst per day per stable which shall include electricity and cartage

(f) The OC will ensure at all times the safety and security of the camp to avoid any mishap.

(g) All teams must inform the organizers of their total strength (personnel and animals) by the 17 Jan 2023, so that camp site so appropriate size can be allocated for all teams, both civilian and government.

(h) All teams must inform the organizers of the estimated time of arrival well in advance.

(i) All Army and Government units will be provided space to set up their own camps. All tentage and other stabling material to be brought by them.

(j) The organizers will provide one bulb and electrical connection for a fan. Fans to be brought by participants. Option to buy fans are given in contacts list in the end.

- (k) All bio-degradable waste including horse dung is to be put in to the pits provided.
- (l) No open fires are permitted on Amateur Riders' Club Riding School grounds.
- (m) Riding charges for practice Riding in all other grounds is free.

17. **Venue.** The event will be held at Amateur Rider's Club, Mumbai.

(Note: The venue will open on 20 Jan 2023 and close on 01 Mar 2023.)

(NOTE: Athletes, grooms, trainers, family, or any other person visiting Amateur Rider's Club, Mumbai will not be permitted to enter without the Covid 19 Self Declaration & Travel Declaration form as prescribed by EFI)

18. **Camp.** All horses will be stabled at Amateur Rider's Club, Mumbai. Stables will be allotted by the organizing committee to all teams depending on the number of horses per team. All horse handlers are permitted to stay along with the horses in temporary accommodation earmarked for the same. All teams are requested to share the number of horses/ handlers per contingent, which are likely to come latest by 17 Jan 2023 with the show secretary via E-mail/whatsapp.

19. **Self-containment.** In addition to the above all teams must be self-contained in terms of tentage, equipment for camping and transport in order to be prepared for any unforeseen emergency.

20. **Ration /Fodder;** All teams should bring their own feed, hay, bedding, grass, etc. for their horses and should make their own provision for staff food. Amateur Rider's Club, Mumbai will not provide any assistance for the above unless special facilities are being provided for all teams.

21. **Coggin's and Glanders Test: Medical Protocol requirements for all horses issued by Amateur Riders' Club / RWITC Premises:** - Every horse should be accompanied by the following valid Veterinary Documents:-

- (a) Identification Certificate or Passport along with vaccination record.
- (b) All rules and instructions issued from the EFI and Remount Veterinary Directorate, Army Headquarters on the subject will be strictly adhered to by all concerned. All horses must produce a valid negative EIA and Glander status (CFT or Mallein) certificate on arrival in Mumbai. Coggins and glanders negative certificate with a validity of a minimum of 15 days on arrival and exit of horses from the camp is mandatory, (Glanders validity 30 days, EIA validity 120days).
- (c) Every horse must be duly vaccinated with the Calvanza /innovator fluvac innovator vaccine. For horses who are being vaccinated for the 1st time, 3 dosages for Clavanza and 2 dosages for fluvac with a gap of 21 days between each dose is required. Horses already vaccinated will require an annual booster dose.
- (d) Proof of Pneumobort – K Vaccination (only for horses coming from within Maharashtra itself) Those horses got fluvac innovator vaccine do not require pneumobort

(e) Health Certificate of the horse (Authorized Vets for Certifying: State Veterinary Officer active, Army Veterinary Office active, Panel Vet (RWITC) Registered).

(f) Declaration Letter from the owner (on his letterhead) stating where the horse was stabled in the last 60 days before proposed entry into ARC / Mahalaxmi Race Course, Mumbai.

22. **Veterinary commission** The Veterinary Commission detailed by Equestrian Federation of India will have the right to examine all the horses participating.

23. **Veterinary Assistance:** Dr. Pandurang Sawandkar is the official VET Mob – 9284249422 is. The charges will be borne by the horse owners.

24. **Farrier** All teams and riders are responsible to arrange their own farrier.

25. **Medical cover.** The organizing committee shall not accept any liability for medical treatment given to a competitor on the venue or the consequences thereof. Each rider participating in the EFI Show Jumping (CSN) events will fill the Indemnity Bond attached and submit the same along with entry form.

26. **Insurance.** The organizing committee recommends units/club/associations to take insurance policies for competitors, personnel, grooms and horses for their transportation to ARC Mumbai and during the conduct of the events. The organizing committee will assume no responsibility for any accident or illness due to fall of any horse, competitors, groom/ any other member of the team.

27. **Responsibility.** The organizing committee accepts no responsibility for any loss, damage or injury to any animal or any other property or the exhibitors themselves.

28. **Appeal.** Appeal may be lodged in writing by the team captain/competitors as per Article 122 of ITPF Rule 2022. A fee equivalent to 100USD should be deposited with the show secretary, ARC along with the objection. Money will be refunded if the objection is upheld.

29. **Compliance of NADA Rules** As per the rules in vogue, each participant (both human and equine) are liable for screening for doping at EFI approved events. In view of the above, athlete if approached by NADA to give sample for drug testing are mandatorily required to comply with the same. Any refusal may result in debarment of the athlete.

30. **Clearance Certificate.** Horse owners are required to obtain clearance certificate from the OC during work hours. All concerned accounts need to be cleared before they can obtain the same. No horses/ Person will be allowed to leave by the Camp In-charge without the clearance certificate.

Appendix I-

DECLARATION (INDEMNITY BOND)

1. I, _____ resident of _____ desirous to participate in the EFI Show Jumping (CSN) events at Amateur Rider's Club, Mumbai hereby undertake and agree: -

(a) That horse riding and all equestrian sports are inherently unpredictable and potentially dangerous.

(b) That only some basic provisions for medical treatment are made at the event venue and I am responsible for my safety equipment.

(c) That the Equestrian Centre has various unsupervised areas that may be generally risky.

(d) That in the event of any loss or injury to property or person including injury resulting in death I may suffer while participating, I or any other legal representatives shall not hold ARC responsible for the same or for any consequence thereof.

2. If any rights exist by operation of law, I hereby waive them and undertake not to initiate any action against ARC & other persons.

3. It is further declared that stamp duty payable on this undertaking shall be borne by me.
