FEI JUMPING CHILDREN CLASSIC'S (SILVER & BRONZE TOUR)-2023

General.

1. FEI Jumping Children Classic's (Silver & Bronze Tour)-2023 will be held at Verdinand Equestrian Academy, New Delhi from 24 – 27 Nov 2023.
2. Selection trial for Selection of Team India will be conducted on 24 Nov 2023.
3. Technical specification will be as per FEI Jumping Children Classic's Rule-2023 as attached at **Appendix A** and other relevant rule of FEI.
4. **Programme.** Tentative Programme of FEI Jumping Children Classic's (Silver & Bronze Tour) - 2023 are attached at Appendix '**B**'.
5. **Entries-**
 - a) All entries must be submitted on the prescribed Entry form given in Annexure 'C' and should be completed in all respects. Entries not in the prescribed entry form and not accompanied by the entry fee will not be considered. All entries for young riders, silver & bronze tour category riders must be accompanied by proof of age (birth certificate). All entries must be EFI horse passport number, description, EFI registration number & name of the horse & Rider's EFI I.D.
 - b) Entries must be sent to the **Equestrian Federation Of India** , Delhi Cantt. . To facilitate processing of the data please also email a copy of the entries to veahorseshow@gmail.com
 - c) Refer to article 12 of EFI Technical Guidelines for Horse Concourse entries.
 - d) **Entry Fee-** The entry fee will be as under:-
 - (i) Individual Events- Rs1000/- per entry.
 - (ii) No Entry will be accepted without the prescribed fee.
6. **Closing Date for Entries-** Entries will close by 12:00 hours on 22 Nov 2023 Entries received thereafter will be regarded as POST ENTRIES. However, post entries will be accepted up to one hour before the draw of lots for each event. No entries will be accepted thereafter. Post entry fee will be:-
 - (a) Individual Events Rs. 2000/- per entry.

7. **Payment-** All entries must be paid in DD or by Cheque or RTGS/NEFT in favor of

9. **EFI Horse Passport –**

(a) As per EFI rules all horses participating in the FEI Children's International Classics (Silver & Bronze) Tour 2023 have to be in possession of EFI passport.

(b) No entry will be accepted without EFI Registration number. For further information pertaining to registration, contact EFI. Please register the horses participating in the event with the EFI prior to the show.

(c) All the riders participating in the EFI recognized events should obtain EFI identity number.

10. **Withdrawal, Change, Transfer or Substitutions of Entry –**

(a) **Withdrawal**- The entry fee of a horse entered for any category will not be refunded if the horse does not participate in the class.

(b) **Transfer and Substitutions** – A horse cannot be transferred from one class to another without paying an additional entry fee for the class to which it is transferred. A horse once entered in any category cannot be substituted by another horse for any reason whatsoever.

(c) **Change of Rider** – Rider cannot be changed unless the jury accepts that there are sufficient reasons for change of rider. Once a class has started being judged, no change in rider will be accepted.

(d) All changes will be treated as post entries.

11. **Cancellation**- The Organizing Committee may cancel any class which has less than four entries or for any reason at their discretion. In that case, the entry fee will be refunded. However, the events where up gradation of horses is involved, those events will be held irrespective of number of entries.

6. The class will start once the draw of lots for the order of start has been held.

7. **Show Number** – All horses will display the EFI registration number on the bridle during the competition, veterinary inspection and whenever taken out from the stable.

8. **Rosette**- No rosette will be worn by a horse during judging.

9. **Elimination/Disqualification** – the judges are empowered to disqualify the competitors at any stage of the competition for rough handling, excessive brutality or any form of cruelty to animal. Rapping will be severely penalized.
10. **Whips/Spurs** – As per EFI rules on the subject.
11. **Dress Code**- When inspection at the course, dress must be neat and tidy. In any case, riding boots, white breeches, a white or light colored plain shirt, white tie and Jacket must be worn. Service personnel will be in uniform. It is compulsory for anyone jumping a horse to wear a properly fastened hard hat with three point retention harness including rider's uniform.
12. **Appeal** – Appeal may be lodged in writing by the team captain/competitors as per FEI GR 161. A fee equivalent to 150 CHF should be deposited with the Secretary, Verdinand Equestrian Academy along with the objection. Money will be refunded if the objection is upheld..
13. **Medical Cover**- VEA will provide first aid/ Medical attendance for riders at the venue. Verdinand Equestrian Academy will not accept any liability for medical treatment given to a rider at the venue or the consequential hospitalization. Each rider participating in the FEI Children's International Classics (Silver & Bronze) Tour 2023 will fill the indemnity Bond and submit the same along with entry form.
14. **Insurance** – The Organizer recommends that units/clubs/associations/schools to take insurance policies for competitors, personnel, grooms and horses for their transportation to Delhi and back. The Organizer, will not assume responsibility for any accident or illness of any horse, competitors, groom or any other member of the team.
15. **Responsibility** – The Organizer accepts no responsibility for any loss, damage or injury at any animal or any other property or the exhibitors themselves. Neither the Organizer nor the attending Doctor will be held responsible for any aid or other medical treatment provided.
16. **Eligibility of Rider** – Please ref Article 502 (EFI Technical Guidelines governing the FEI Children's International Classics (Silver & Bronze) Tour 2023)
17. **Eliminations**- Eliminations may be held for all events depending on the number of entries received.
18. **Reporting for each class** – The First Five riders in jumping must report to the Arena Steward at least 15 min before the scheduled start of that event. The Arena Steward has full authority to take appropriate action as per existing rules.
19. All events scheduled in the afternoon will continue under lights, whenever required.
20. **Accommodation** – All Participants are required to make own arrangement for their accommodation. In Case any assistance is required The Show Secretary Verdinand Equestrian Academy, Delhi may be contactless.
21. **Abuse/ cruelty to horses** – Refer to Article 13 of EFI Technical Guidelines 2007.

22. **Camp**- The VEA has permitted stabling of horses for all participants in Verdinand Equestrian Academy for the duration of the event. Permission to stable horses during the above period is subject to certain conditions as laid down in Annexure 'B' to this prospectus. Pertaining to civilian employees of all contingents including Club members entering the VEA for temporary stabling will be strictly adhered to. No civilian employee of any contingent will be allowed to enter will be VEA without civil police verification. Camp will open on 22 Nov. 2023.

23. The Camp In charge will earmark the site for each contingent. The representation of the contingent will take over the site allotted to them from the Camp In charge on arrival & handover the same before departure in the same condition. Any damage to camp, accommodation or property will be the responsibility of the contingent. The teams should come self contained in all respects for camping of their personnel and animals. All teams will intimate the total strength of contingent in terms of men and horses positively by 22 Nov 2023 and intimate Extended Time of Arrival well in advance to Verdinand Equestrian Academy

24. **Logistics**– All teams coming to participate in the FEI Children's International Classics (Silver & Bronze) Tour 2023 must note that camping, cooks and transport, ration, horses stables will not be provided by Verdinand Equestrian Academy.

25. **Ration/Fodder**- Army contingents are advised to bring grain/ fodder to sustain their horses during their Stay in Delhi or they can ask for attachment from the local Supply Depot. Other contingents are advised to make their own arrangements.

26. **Coggins and Glander Test** – All rules and instructions issued from the EFI and Remount Veterinary Directorate, Army Headquarters on the subject will be strictly adhered to by all concerned. All horses must produce a valid negative EIA and Glander Status (CFT) certificate on arrival at Delhi as per EFI technical guidance. Coggins and glanders negative certificate with a validity of a minimum of 14 days from arrival and exit of horses from the camp is mandatory.

27. **Trotting Parade** – All participants are requested to present their horses for veterinary inspection (Trotting parade) at 0800 hrs 24 Nov 2023.

28. **Ground jury, Veterinary / technical delegate, Appeal Committee and insurance**- These are as per Equestrian Federation of India governing competitions.

29. **Spectators** – The Spectators or the supporters of the participants are not to interfere with the judges. The Arena Steward has the right to eliminate any participant who has outside help. Once the event has commenced, all spectators and helpers are to clear the arena. The Judges decision will be final. Parents must not enter the arena or dispute the decision or directly confront the judges.

30. **Prize Distribution** – Tentatively prizes will be distributed after each event on the same day.

31. **Fire Fighting Arrangement** – All contingents are requested to carry adequate portable fire fighting equipment.

32. **Veterinary Commission** – The Veterinary Commission detailed by the Equestrian Federation of India will have full rights to examine all the horses participating.

34. **Clearance Certificate** – All horse owners/riders are required to obtain a clearance certificate from the Show Office during working hours. All accounts concerned needed to be cleared before they can obtain the same. No horse will be allowed to leave unless a the clearance certificate is obtained.
