PROSPECTUS

1. **General.** The National Equestrian Championship (NEC) Tent Pegging 2022-2023 will be conducted from 01 Feb to 06 Feb 2023 according to the rules of the Equestrian Federation of India (EFI) and ITPF by Army Polo and Riding Centre at the Army Equestrian Centre (AEC), Delhi Cantt.

2. After completion of the NEC Tent Pegging, as per Article 421, Tent Pegging Technical Guidelines 2021, probables for Indian team will be selected. They will undergo a selection trial on borrowed horses for final selection of team. Selection Trial will be conducted wef 09 Feb to 10 Feb 2023 at Army Polo & Riding Centre, Delhi Cantt. Hence, the selected probables will not leave the venue after completion of the NEC Tent Pegging 2022-23 till 10 Feb 2023.

3. **Programme.** Programme for the NEC 2022-2023 Tent Pegging is attached at **Appendix 'A'**.

4. **Category.** The NEC 2022-2023 Tent Pegging events will be held in accordance with the EFI and ITPF Rules. The events will be held on the following category :-

(c)	Ring & Peg Tent Pegging - Lance
(d)	Lemon & Peg Tent Pegging - Sword
(e)	Team Tent Pegging - Lance

(g)	Paired Tent Pegging - Lance & Sword
(h)	Indian File - Lance & Sword

5. **Entries & Entry Fee.**

(a) Only the riders/athletes who qualified through REL will be allowed to enter/participate in the NEC Tent Pegging 2022-23.

(b) All entries will be on a proper Entry Form as attached at **Appendix 'B'** and should be completed in all respects and submitted to the APRC office. Entries not on the prescribed entry form or without entry fee will not be considered. The Organizing Committee is not responsible for any wrong entry. The fee will be as under :-

(c) **Entry Fee.**

Note :- Spare horses with individual rider/team will have to be trotted with trotting & vet check for National Championship.

(d) **Closing Date for Entries.** Entries will be closed by 27 Jan 2023. Entries received thereafter will be regarded as POST ENTRIES.

(e) **Payment.** The entry fee may pay by NEFT, cheque or by demand draft in favour of "Army Polo and Riding Centre". The Bank account details are as under :-

6. **EFI Horses Passport.** As per EFI rulings ALL horses participating in the NEC 2022-2023 Tent Pegging have to be in possession of EFI passport. Team captains are requested to ensure that their horses are all registered before entries for the Event. The registration No has to be filled in the entry form as per EFI ruling.

7. **EFI Riders ID Number.** As per latest EFI ruling all the riders participating in the NEC 2022-2023 Tent Pegging has to be EFI ID No. The EFI ID No has to be filled in the entry form. Entries will not be accepted without EFI ID number.

8. **Withdrawal, Change, Transfer or Substitutions of Entry.**

(a) **Withdrawal.** The Entry fee of a horse entered for any category will not be refunded if the horse does not participate in the class.

(b) **Transfer and Substitutions.** A horse cannot be transferred from one class to another without paying an additional entry fee for the class to which it is transferred. A horse/rider once entered in any category cannot be substituted by another horse for any reason except in a team event when during the course of event, if a horse is not fit due to vet reason only. The horse can be replaced with a spare horse that has already been trotted and not ridden by any rider during the national event.

(c) **Change of Riders.** Riders cannot be changed unless the Jury accepts that there are sufficient reasons for change of riders. Once a class has started being judged, no change of rider will be accepted.

9. **Eligibility of Horses & Riders.** As per EFI Rules.

10. **Technical Specifications of Events.** As per EFI Rules.

11. **Show Number.** All horses will display the EFI Registration Number on the bridleduring competition, veterinary inspection and whenever taken out of the stable under the saddle.

12. **Judging.** Decision of the ground jury will be final unless, altered on appeal under rules. No video timer etc will be accepted other than official timers and judges decision will be final.

13. **Appeal.** Appeal may be lodged in writing by the team captain/competitors as per Article 122 of ITPF Rule 2022. A fee equivalent to 100USD should be deposited with the, Show Secretary, Army Polo & Riding Centre at the time the complaint is filed. This fee will be refunded if the protest is upheld.

14. **Use of Whips/Spurs.** As per EFI rules/ITPF.

15. **Dress Code.** When presenting a horse for Vet Inspection, rider should be properly dressed. Service personnel will be in uniform. It is compulsory for anyone riding a horse to wear a well secured hard hat with three point retention harness. Dress Code for competition

will be as per EFI Guidelines for Tent Pegging.

16. **Elimination/Disqualification.** The judges are empowered to disqualify competitors at any stage of the competition/practice for rough handling, excessive brutality/abuse or any form of cruelty to animals or for any reasons which they feel is dangerous / justified. Rapping will be severely penalized.

17. **Camping.** Temporary stabling facility will be provided to participants for the duration of NEC 2022-2023 Tent Pegging at Army Equestrian Centre, Delhi Cantt. Rules and regulations for the temporary stabling facility are attached at **Appendix 'C'**.

18. **Covid-19.** In light of the Covid-19 pandemic, strict protocols and guidelines as promulgated by EFI/Govt of India/Higher Head Quarters must be followed in order to ensure a safe and successful conduct of the event. Valid Covid-19 vaccination certificate (at least 02 doses) must be produced by all member of Team/Clubs including riders/participants and their associates.

19. **Medical Cover.** The APRC will as usual provide doctor and ambulance for basic medical first aid cover for riders at the ground. The APRC/Govt of India (MoD)/Army/61 Cavalry or any member or officer or employee or other representative of the said organizations shall not accept any liability for medical treatment given to a rider/player on the ground or the consequences thereof. It will be the responsibility of the individual to give a written undertaking (Indemnity Bond) absolving the APRC/Govt of India (MoD)/ Army/61 Cavalry or any member or officer or employee or other representative of the said organizations of any responsibility in this regard. Specimen of the Indemnity Bond to be given by all playing members/rider is as per **Annexure 3 of Appendix 'C'** to this Prospectus. The APRC will only provide first aid emergency treatment as well as evacuation to the nearest hospital when necessary, though every possible available medical cover will be presented.

20. **Insurance Cover.** It is recommended that all players/individual take insurance against any injury sustained while participating in the events or practicing at the Army Equestrian Centre. It would be ideal for the ponies as well to be covered under some insurance policy. The APRC may be informed as regard the above while signing the medical declaration. The APRC excludes all liability for any injury and/or loss occasioned to any person and/or their property within the premises of Army Equestrian Centre, Delhi Cantt.

21. **Coggin's and Glanders Test.** All rules and instructions issued by the EFI and Remount Veterinary Directorate on the subject will be strictly adhered to by all concerned. Coggins and glanders negative certificate valid for a minimum of 15 days at the time of entry for participation.

22. **Veterinary Doctors.** The following vet doctors/ ambulance are available in case of an emergency.

23. **Veterinary Commission.** The Veterinary Commission detailed by the IHQ of MoD (Army), QMG's Branch along with representative of the Animal Husbandry Commissioner for the season will have full right to examine all the horses participating. It is advisable to have horses checked by the Veterinary Officer on duty before the event start.

24. **Arboriculture.** No Det/Camp will spoil or cut the environment. Immediate expulsion and action as per existing law will be enforced. **No warning will be issued.**

25. **Responsibility.** The APRC/Govt of India (MoD)/ Army/61 Cavalry or any member or officer or employee or other representative of the said organizations accepts no responsibility for any loss, damage or injury to any animal or any other property or the player/rider themselves.

25. **Compliance of NADA Rules** As per the rules in vogue, each participant (both human and equine) are liable for screening for doping at EFI approved events. In view of the above, athlete if approached by NADA to give sample for dope testing are mandatorily required to comply with the same. Any refusal may result in debarment of the athlete.

26. **Miscellaneous.** The AEC is a facility of the Army and no defence/para military contingents, private horse owners and the APRC members/riding facility (Temp) has any right to allow him/them to take claims over this land. OIC AEC reserves the rights to remove all horses, men and material without any notice.

27. **Final Decision.** The decision of the Organizing Committee after consultation with EFI will be final on all matters connected with the NEC 2022-2023 Tent Pegging which will be conducted from 01Feb to 06 Feb 2023.
