2 **SECY GEN:** The Court has directed that Dr. Quraishi would chair the meeting.

4 **COL S S AHLAWAT:** I don't think so.

6 **Dr. SY QURAISHI (OBSERVER):** It was as for that particular ...

8 **COL S S AHLAWAT:** Please read the protocol for them...

10 **COL JAGAT SINGH:** I have a copy of ...

14 **SECY GEN:** I don't think so.
15
16 **Dr. SY QURAISHI (OBSERVER):** So any one of you....[UNCLEAR]
17
18 **SECY GEN:** He is requested to chair the meeting as per article so and so...[UNCLEAR].

22 Heated discussion
23
24 **SECY GEN:** No Sir, it is not written Sir.
25
26 **SECY GEN:** It's my duty to apprise you. This is a wrong interpretation. This will be recorded.
27 **MAJ GEN DEEP AHLAWAT:** We have to follow the statutes.
28 **Dr. SY QURAISHI (OBSERVER):** Hold on, hold on. Who is the senior most in the group?
29
30 [UNCLEAR] heated discussion
31
32 **COL S S AHLAWAT:** Sir the VP (Tech)
33 **Dr. SY QURAISHI:** What is your name?
34 **COL JAGAT SINGH:** COL JAGAT SINGH
35 **Dr. SY QURAISHI:** Please Come

2 **COL S S AHLAWAT:** Is that okay with everyone?

3 **COL JAGAT SINGH:** I welcome you all EC members to this EC meeting. We also welcome
4 the court-appointed learned observer. We had the last meeting on 12th of July in which
5 General Gopal had stated and we had agreed on few points which were minuted. I don't know
6 where the EC is going wrong. The minutes never came up on the website or they were approved
7 by the President. Now as for Article 013 Para 2, I hereby invite Colonel Dewan to be a special
8 invitee for this EC meeting.

9 Secy Gen, can you invite Colonel Dewan?

10
11 **DR. SY QURAISHI (OBSERVER):** I'm glad mein executive decision-making
12 [UNCLEAR]...se bacha hua hun

13
14 **MAJ GEN DEEP AHLAWAT: :** Sir, but I think the second... [UNCLEAR]

15
16 **COLONEL SANDEEP DEWAN:** Morning Gentlemen.

17
18 **COL JAGAT SINGH:** All the members firmly decided in the last EC meeting that there will
19 be a gap of ten days between the EC and AGM.

20
21 **Col SS AHLAWAT:** Correct.

22
23 **COL JAGAT SINGH:** The statutes of EFI is very clear that Secy Gen is supposed to work
24 under guidance and direction of the EC, Vice President, President. There should be no doubt
25 in that. I don't know where the date was changed. Secy Gen , on his own, has informed EC
26 members. I spoke to Sir myself. He had a medical issue', he told me that. But the Secy Gen,
27 without consulting the EC members speaking directly to the learned Court observer and not
28 communicating with us. On the night he came Col PP Singh from France for attending the
29 [UNCLEAR] meeting and he writes an email on the 8th of August, sent the email ki I've been
30 instructed... I don't know where is the instruction coming from?

31
32 **COL S S AHLAWAT:** Where was the instruction from?

SECY GEN : Sir, first and foremost ...

COL JAGAT SINGH: I don't know, because he's supposed to work under the EC only. How can he take a separate decision?

SECY GEN: Sir, I replied adequately in my...

COL S S AHLAWAT: No there is no reply...

COL JAGAT SINGH: No reply. I have a statute here...Please tell us now where the instruction was coming from?

SECY GEN: So my lawyer told me that he has to be...

COL JAGAT SINGH: Which lawyer?

Heated discussion [UNCLEAR]

COL S S AHLAWAT: He has got his own lawyers...

COL JAGAT SINGH: You have got your own lawyers? Are you separate from the EC?

SECY GEN: No.

COL JAGAT SINGH: Your lawyers means which lawyers?

MAJ GEN DEEP AHLAWAT: : Your lawyer means the Federation lawyer?

SECY GEN: Yes, Federation lawyers. Sir, it's a small issue. Let's not get technical. Federation lawyer suggested. Dr. Gupta is aware of it. [UNCLEAR] I have communication to support whatever I am saying....On the fifth morning, I gave you... for the first I wrote 9th meeting at the whatever you decided EC members along with the approval of the President. On the fifth, I even told the time, place. I have not given him the place and time in the first email...1st August email and then on the fifth, later the evening when he came up saying I'll be available for some

1 reason, I applied itself [UNCLEAR] that Sir suggested 17th and I applied[UNCLEAR] some
2 minute come I replied to that I'm sorry, I do not give my consent.

3
4 **DR SANJAY GUPTA :** Did you tell the Honorable observer about the 10-days gap?

5
6 **SECY GEN:** There is no 10 day gap Sir.

7
8 **MAJ GEN DEEP AHLAWAT:** Para 7.2, it's very clear.

9
10 **SECY GEN:** Not 7.2 Sir

11
12 **MAJ GEN DEEP AHLAWAT::** In 7.2, It's in the minutes.

13
14 [UNCLEAR] heated discussion

15
16 **SECY GEN:** I do not give my consent to...

17
18 **COL JAGAT SINGH :** Don't give. Who are you?

19
20 **MAJ GEN DEEP AHLAWAT:** Who are you?

21
22 **COL S S AHLAWAT::** Have you seen your minutes, which you circulated?

23
24 **SECY GEN:** I haven't circulated any minutes .

25
26 **COL S S AHLAWAT::** Don't tell lies.

27
28 **SECY GEN:** Which minutes? I haven't circulated any meetings...

29
30 [UNCLEAR] heated discussion

31
32 **SECY GEN:** I only put up the video and the transcript.

33
34 **MAJ GEN DEEP AHLAWAT::** I will not give consent there...

35

1 **COL JAGAT SINGH:** Jaiveer, just tell me one thing. Is Secy Gen supposed to work in
2 direction of EC or not?

3
4 **SECY GEN:** Yes. I have to work as per the statutes.

5
6 **COL JAGAT SINGH:** You want me to read out the statutes...

7
8 **SECY GEN:** You don't have to read out... *Maine koi galti ki hi nahi ...*

9
10 [UNCLEAR] heated discussion between Col Jaiveer Singh and COL JAGAT SINGH

11
12 **SECY GEN:** I am not in defiance.

13
14 **COL S S AHLAWAT:** Then if we have not approved the minutes, why was it uploaded?

15
16 **SECY GEN:** Yes, because I felt ...

17
18 **MAJ GEN DEEP AHLAWAT:** You are nobody.

19
20 **SECY GEN:** No No Sir, I am everybody because ... you want me to read out this letter? I
21 should read out this letter to all of you,

22
23 *"1. Pl refer mails of Col Jagat Singh, VP(Tech) & honourable members on the
24 subject matter dt 08th July 2024.*

25 *2. I agree with the views & recommendations of VP(Tech) & members vide ibid
26 mails. I would also like to submit that we must have the EC meeting as sch on
27 the 12th July since majority of the members have planned & made their travel
28 & stay bookings & argns accordingly.*

29 *3. I would also like to draw attn of the EC on pending court cases & SECY GEN
30 is requested to make a detailed presentation on current status of all court cases
31 being contested in various honourable courts.*

32 *4. I would also like to recommend that the complete proceedings of EC meeting
33 should be recorded (audio and video) since there are incidences &
34 apprehensions of minutes being manipulated. Judgment of Honourable Justice
35 Ms Tara Ganju was one of the reason to appoint the AAC since the minutes of
36 Extraordinary General Body were not recorded properly.*

37 *5. Sir, we must conduct all the proceedings with absolute transparency,
38 therefore I strongly suggest that we must Video record all our proceedings. If
39 reqd, we can argn/hire a professional for the same."*

40
41 **COL S S AHLAWAT:** Correct.

42

SECY GEN: Sir, this is an allegation put on me and I in my wisdom, I've written in writing. I've given a copy to the observer. It's with the President. My mail of 2nd of August is very clear to the President that these minutes are not matching with the video of the recording. That's why you may like to advise me further. And fifth, he resigned... it's on record. Sir. I'm not cheating and lying. Sir.

Col SS Ahlawat :[UNCLEAR]

MAJ GEN DEEP AHLAWAT: What are the orders of Justice Ganju? Can you read out.....

SECY GEN: So those orders have been suspended by the way.....

MAJ GEN DEEP AHLAWAT: So the thing is we can have discussions. I think I can.

[UNCLEAR] heated discussion

SECY GEN: With due respect sir, please let me speak sir. I agree with this. We can go on. People have come from far and wide. You were interested in my email today which I replied. Let's discuss that and move on.

[UNCLEAR] heated discussion

SECY GEN: I will I reply.

COL JAGAT SINGH: What will you reply? You are here physically. You are part of the EC. Let's discuss.

MAJ GEN DEEP AHLAWAT: Sir...our opening address....[UNCLEAR]

We started with that..... and in that spirit, we stated there was no bias, no bias mind. Nothing...because we all met and that let's forget everything and a damage has been done to the sport and we will work for the sport. And on contrary, the behaviour of Secretary General was not up to the mark. He was not giving any importance to EC decisions taken. And now the President has resigned, so we cannot refer him. But it was very clear, he approved the minutes.

1 He asked me to share the video recording before approving the minutes. He is also sitting in
2 some capacity. If he has approved, let us, at least, give that much of credit. And by seeing his
3 position, we must at least uphold his merits.

4
5 **Dr SANJAY GUPTA:** Honourable learned observers Sir... We are not at the mercy of
6 anybody. It is at the white and grey numbers. We are here because of that order. So in letter
7 and spirit, we have to follow that order. We are not at mercy at anybody.... Secretary General
8 has a tunnel views, focused view that he has these kind of mandates to [UNCLEAR]. I mean
9 you become an extraordinary judicial member for anything...

10
11 **MAJ GEN DEEP AHLAWAT:** [UNCLEAR]

12
13
14 **SECY GEN:** No Sir. Not acceptable Sir vehemently denied I have justified that there was an
15 email ...[UNCLEAR]...heated discussion.

16
17 **MAJ GEN DEEP AHLAWAT:** You need not justify

18
19 **SECY GEN:** I have followed each and every order.

20
21 **COL JAGAT SINGH :** As for the Learned Observer, the EC has decided four things. First is
22 the calendar. Second is the technical guidelines. Third is the audit of the accounts. And fourth
23 is the budget. It's mentioned clearly in the statutes. Very clearly. If somebody wants to bypass
24 the EC and go straight away to the AGM, it's not possible. I mean Sir, we should request
25 learned observer to report to the.....

26
27 **Maj Gen Deep Ahlawt:** And for simple terms it is a mandate of the EC.....

28
29 **Dr SY Quraishi:** chaired by the general was very productive meeting good meeting.
30 And I complimented him. First time I see so much good discussions.

2 **COL S S AHLAWAT:** So much input had gone in. But there was no output.
3 Discussion in Hindi between
4 **Col SS AHLAWAT, Dr. SY QURAISHI (OBSERVER) :** *mein 6 saal se dekh raha hoon EC*
5 *choti si vo hai apas mein ladte rehte hain.....*
6 **SECY GEN:** *Koi rukawat nahi hain*
7
8 **COL JAGAT SINGH** EC can't pass this decision. We have not seen it.
9 **Dr SY Quraishi:***implementation mein kiya rukawat hai.*
10 **COL S S AHLAWAT:** *agar koi policy decision lena hain wo implement hee nahee hua.*
11 **SECY GEN:** *Sir inhone jo nirnaye liya Technical guidelinesrecording mein hai*
12 **Dr SY Quraishi:** By the way 09 ko meeting hue thi
13 **All Said:** *nahi hui thi sir*
14 **MAJ GEN DEEP AHLAWAT:** We **(Mix voices)** know... *AGM planned hai.. AGM hoga.*
15 But we have to rectify the accounts. If the accounts are put up..
16
17 [UNCLEAR]

19 **SECY GEN:** *Sir, accounts 21 tarik se website par hai..... logo ne dekh liye*
20 **SECY GEN:** Sir he will present if after 12th of July.
21
22 [UNCLEAR]
23
24 **COL JAGAT SINGH :** Is it a private fund?
25
26 Discussion in Hindi between COL JAGAT SINGH and SECY GEN
27 **COL JAGAT SINGH:** What about EC? Let us discuss.
28 **Col SS AHLAWAT:** There are so many complaints that have come up about
29 accounts...misuse of accounts..
30

1 **MAJ GEN DEEP AHLAWAT:** With the permission of Court Observer Dr Quraishi and
2 special invitee Colonel Sandeep Dewan, they should not be part of this discussion.....let him
3 hear and free him.

4
5 **COLONEL SANDEEP DEWAN:** With the permission of the special observer, I am Lt Col
6 Sandeep Dewan. I have written some two mails, detailed mails regarding the accounts. So I
7 just briefly read through my mail, Sir, I have written first. The first mail I wrote was addressed
8 to General Gopal as he was then in chair.

9 “Dear General, please refer to the account circulated for the year ending on the 31-3-2024. The
10 under-mentioned preliminary observations objections are raised. The expenditure for the
11 financial year is approximately 8.9 crores against 3.1 crores in the previous year.
12 Approximately 6.1 crores has been shown as expenses incurred on the Asian Games where
13 only approximately 5.2 crores have been reimbursed by the Government. Therefore, nearly
14 one crore has been spent by the federation over the amount sanctioned. It is observed that
15 approximately 14 lakhs, 7.26 lakhs, 4.29 lakhs, and 4.25 lakhs have been spent on conducting
16 various equestrian events. It is also observed that these events were conducted by various
17 organising committees with the EFI having a limited role. Payment to the EFI is entered as
18 approximately 12.65 lakhs.” In what context it was made, is not explained. These were general
19 observations, Sir, which I am making reading the accounts. I come to what I am getting to.

20 An absurd amount of approximately 14.5 lakhs has been mentioned as expenses on Athletes
21 Commission expenses with no explanatory note as to why this huge amount is required to be
22 spent on an election. Assistance to army units in the last two financial years is mentioned as
23 20 lakhs with no reason given as to why a national sports federation has to give assistance to
24 army units. This is also not explained.

25 Very large amounts have been reflected on AGM expenses; 10 lakhs on AGM expenses, legal
26 expenses 1.5 crores in two years. 80 lakhs in this year alone. Nearly 60 lakhs has been
27 mentioned on a women's tent pegging team with no explanation. That is why 60 lakhs needs
28 to be spent on a women's tent pegging team. 13.5 lakhs. On the ITPF World Cup. Then I had

1 written. "It is observed that the AGM notice by which the accounts have been circulated
2 contain no explanatory note or a letter from the President's desk as his customary whenever
3 the financial accounts are circulated of any society or a company or anything. It always
4 contains a letter from the President's desk.

5 Dear Sir, these are the accounts. This is what we have done in the year. Nothing. Just a blank
6 account statement filled in the most amateurish way, I have to say. It is therefore
7 requested...then I requested. It is therefore requested that an itemised breakdown of the major
8 expenses highlighted by me be provided as the earliest. It is also observed that the accounts in
9 their current form cannot be passed as numerous violations of the operating procedure and
10 lack of necessary sanctions are manifest. As per various provisions of the Society's Act, it is
11 extremely necessary to carry out a forensic audit. What I have deduced from these accounts is
12 there is definitely, all is not well. It needs an independent auditor, possibly a forensic auditor
13 to bring out... Definitely. It's pointing to some, some sort of a prima facie fraud is my opinion.

14
15 **Dr. SY QURAISHI (OBSERVER):** *Yeh aap ne General saab ko kab likha tha?*

16
17 **COLONEL SANDEEP DEWAN:** *Yeh humne likha tha sir on 23rd of July.* I will come to
18 that

19 **Dr. SY QURAISHI (OBSERVER):** So you got a reply?

20
21 **COLONEL SANDEEP DEWAN:** He has replied recently. Yes, I will read the reply also.
22 First, I will say what I have written. It is not out of context to mention here that during the
23 EGM conducted... The EGM which was conducted where you sir were also an observer. When
24 Justice Najmi Waziri was extraordinary...there also Colonel SS Salawat had raised a number
25 of important points pertaining to the misuse of funds and fraud which must be investigated
26 before these accounts can be passed. This is what I read. It is therefore requested that an
27 immediate forensic audit be carried out.

28 Then I will come to my second letter. Because I said, these were preliminary things. I then give
29 it another detailed letter. This I addressed to Colonel Jagat Singh, because by then General

1 Gopal had resigned. So I request this to Colonel Jagat Singh; being the next in line. "Dear
2 Colonel Jagat Singh, please refer to my trailing mail addressed to General Gopal. As it is
3 learned that General Gopal has resigned from the post of President of the EFI, I address this
4 mail to you in your capacity as the Vice President and next in line. Despite telling, two weeks
5 having passed since my mail, no clarification, itemised list etc. has been sent to me. This was
6 on the 5 August. Till then, I had not received a reply. In addition to the previous observations,
7 I also have the following queries. The statements of accounts is incomplete and untenable to
8 be presented and approved by the General Body in its present form. As per section 483 of the
9 Society's Act, an auditor's report as well as the report of the management committee, in this
10 case the EC, must be submitted for approval along with the balance sheet and [UNCLEAR].
11 This is what the Society's Act says. As I'm not saying it, societies Act, Companies Act. All the
12 acts say that an auditor's report should be present. There's no report of an auditor?
13 It's just a blank thing. So a statement of the income and expenditure accounts over a period of
14 last four years. I've done a bit of a study, Sir, where it says from 2021 to 2023 revealed that
15 there has been an alarming deficit of income over expenditure to the tune of over one crore
16 per annum.

17
18 **Col SS Ahlawat:** One crore?

19
20 **COLONEL SANDEEP DEWAN:** One crore per annum has been the deficit. In 2021, when
21 the present Secretary General Colonel Jaiveer Singh took over, he inherited a healthy, I think,
22 with a positive balance of 1.05 crores. He had a positive balance. Subsequently...this amount
23 in the very next financial year ...he had 1.5 crore in the positive. In the very next year, shows
24 an alarming trend of over expenditure to the tune of being in the red of more than one crore
25 per annum which has reduced the net worth of the federation in terms of FDs at a shocking
26 rate of one crore per annum. The FDs are going down.

27 FDs as on 31-3-22 were 5.76 crores. On 31-3 end of this financial year, it gone to 2.89 crore. I
28 asked him to give me an of the last five years FDs, he has not provided. The income and
29 expenditures accounts are submitted. 2021- income was 2,62,04,080 -there was a positive

1 balance of one crore, five lakhs. 2021 - the income is same 261 around but it goes into a
2 negative of 1.04 crores. 2023 - it goes into a negative 1.69 crores. 24 -it goes into a negative of
3 1.08 crores. Therefore, it is abundantly clear from the above, that the federation is fast sliding
4 towards complete bankruptcy due to misgovernance, dubious financial dealings, glaring
5 malpractices, and a complete non-adherence to the operating procedures and limits for
6 expenditure laid down. Sir what I am trying to say is there are limits of expenditures laid down.
7 Every functionary has to function within those limits. This present Secretary General is
8 functioning on his own, like a one-man army, not obeying any...

9 I have calculated since he has taken over, Rs. 21 crore have been spent by the Federation during
10 his tenure. 21 crores have been spent. I am not saying that all of them may be legal or illegal.
11 That has to be done by an independent auditor. I cannot say that. But the amount is staggering.
12 So 21 crores have been gone through. On a perusal of the expenditure in the balance sheet, it
13 is found that there is no mention. He keeps saying this. We have verbally heard that "I am
14 paying remunerations to Mr. Qureshi. I am paying remunerations to those who We said
15 that the remuneration being paid to Mr. XY, Mr. Qureshi, the court-appointed observer may
16 also please be intimated with the total amount paid to the said observer till date. Then I said,
17 what is the duration of this arrangement? And the necessity of incurring this expenditure may
18 also please be intimated.

19
20 **SECY GEN:** Sir, you know.

21
22 **COLONEL SANDEEP DEWAN:** As the Federation.....Please let me finish. After that you
23 can speak. It is. Has the Federation approached the honourable court for clarification on this
24 aspect? As it is clear, the petition cannot afford to incur this expense ad infinitum. It cannot
25 be for infinity. Then, I have observed various other things. I have observed that he has shown
26 here as receivables from the Government - 24 lakhs 95,000 is shown as receivables. He says
27 there are some show jumping sets. So even in this show jumping; sets are being bought, written
28 off. Bought, written off. Whereas all events are allotted to organisers. They use...

1 **MAJ GEN DEEP AHLAWAT:** There is an annual stock taking system.

2 **COLONEL SANDEEP DEWAN:** It not their

3 **MAJ GEN DEEP AHLAWAT:** *Federation mein hote hai hamesha esa nahi hai, stock*
4 *taking hota hai.*

5
6 **COLONEL SANDEEP DEWAN:** Sir what I'll do is I'll finish and then I'll read his reply. It
7 is observed that nearly five lakhs...five lakhs have been earmarked for jackets, t-shirts, et
8 cetera. Who are the recipients of the jackets have not been mentioned. I have asked those
9 details. Not been mentioned. At the end of the year, in the stock, they have 3 lakhs worth of
10 jackets are still present in the stock. Yet again 3 lakhs more is being bought. No stock taking
11 has been mentioned here.

12 Then, a very, very startling thing here is that under administrative expenses, a very large sum
13 of approximately 39 lakhs in the previous year and 10 lakhs in this year have been given to
14 some company to upload videos. No details are given. Whose company is it? Was tendering
15 done? How was it allotted? Who gave it? What is the cost of uploading a video? I have very
16 close friends and my own relatives also who are in the advertising business and I know what
17 it costs to make these videos. Nothing. There is no list given of how many videos were made.
18 What was the cost per video? Nothing. 15 lakhs have just been spent. So this is what I have
19 written that in view of the above and the points raised in my previous mail, it is once again
20 requested that an immediate forensic audit be conducted under the aegis of the Executive
21 Committee headed by you. And only after the EC is fully satisfied as to the genuineness of the
22 accounts, can these accounts be presented before the General Body for passing. In their
23 current form, it is not possible. This is my view. Now what do I do?

24 I get two bland replies from him where he's just gone through the motions. Firstly, there's a
25 famous legal maxim Sir you would know '*nemo durex n causa sua*' - Can a man be a judge his
26 own cause? If I'm asking this question put to the EC, the explanation has to be given to me by
27 the EC after having conducted a proper inquiry. He is jumping the gun when it's not even
28 addressed to him. Just giving a bland reply - for a simple reason which everyone of us can

1 understand and you just want to steamroll the accounts tomorrow. These accounts, in this
2 form, are exposing severe, severe prima facie fraud coming up in this account. I will now read
3 out what he has replied, wherein he has replied.
4 “Dear Sir, refer to your email dated the 23rd July. Initiated by Lieutenant Colonel Sandeep
5 Dewan. Refer to the mail dated... He has not even addressed me. He just generally addressed
6 I don't know who. Please refer the email dated the 23rd July initiated by Lieutenant Colonel
7 Sandeep Dewan, retired. Para-wise replied on the objection/ observation raised by Lt Colonel
8 Sandeep Dewan, the report of 23rd are as under. Now my first question is, before I go into
9 what he has written is - Did he have this authority of the EC to answer this? That is my first
10 question. I think he did not have that. So he's answered my query. The expenditure for the
11 financial year is approximately 8/9 crore against approximately 3/1 crores in the previous
12 year. He's answered that by saying the difference in expenses between the two financial years
13 is primarily because of conduct of training, exposure, and participation for the 2019 Asian
14 Games. Details are attached as appendix A. I will go through those details also.
15 Approximately. Next point is that 6.1 crores have been shown as expenses for the Asian Games.
16 Only 5.2 crores have been reimbursed by the Government. It was my question. His answer is
17 a sum of Rs. 1 crore was approved by the AGM 2022 vide serial number 19. So what he says is
18 that this difference was approved. Then I mentioned about the that it is observed that this
19 amount has been spent by various organising committees, with the EFI having a limited role.
20 This... His answer is very vague. The observation raised pertaining to expenses incurred during
21 conduct of various equestrian events are primarily due to financial obligations. I'm not asking
22 for the financial obligations. I am asking, “Do you need to spend these huge amounts when the
23 events are being organised by things like the ASE Centre, by so and so, by so and so”? You are
24 only going there and supervising in a supervisory capacity, paying for some judges and all - 14
25 lakhs 7.25 lakhs, No No No categoric answer has been given. Payment to the FEI is entered
26 12.65 lakhs. This he has given some receipt that he has paid this to them. In addition, large
27 sums have been spent on the JNEC. 15 lakhs he spent on the JNEC. 15 lakhs has been spent
28 on an event where, Sir, you have also been. You have been to the AAC centre where all the

1 infrastructure is available. This 15 lakhs also requires to be investigated. Subscriptions to FEL,
2 AEF is correct. An absurd amount... And my next point is an absurd amount of approximately
3 14.5 lakhs has been mentioned as expenses of the Athletes Commission. He very blandly states
4 now. It was wrongly shown as Athletes Commission expenses. Can you give such an answer?
5 You have circulated accounts to the whole membership audited by an auditor who you paid
6 good money to. And can you just say that was wrongly shown? If it is wrongly shown and the
7 AGM is going to be held tomorrow, has the membership been told that a wrong entry has been
8 made? Has the balance sheet been changed? Has the auditor been reprimanded? There are
9 actions which can be taken on the auditor as per the Financial Regulation Audit Act. Nothing.
10 Assistance to army units again, he's not gone into the spirit what I have asked. I have asked
11 that as a National Federation, how can you provide assistance to army units?
12 Under what law can we provide assistance to army units? That is not answered. He just
13 answered a vague answer - a sum of Rs. 4.5 lakhs was expended under the financial assistance
14 to army units in financial under the authority of Para. 4.5 of minutes of AGM of 2017, if you
15 please. 2017 some minutes has been used to justify giving money to army units.

16
17 **Col SS Ahlawat :** Very selective.....

18
19 **COLONEL SANDEEP DEWAN:** Very large amounts have been reflected on AGM
20 expenses. Nearly 10 lakhs here. Hence, also 9.5 lakhs has been spent on AGM. Basically go
21 through some of them. Now just see for the AGM, Sir, the AGM expenses for last AGM is
22 totally, you know, heads ...[UNCLEAR] 83,600 for stage decoration has been spent on the
23 on..... That EGM which was attended by very few people, I think so you were also an observer
24 there. 86,000. 83,600 for stage decoration. Was it somebody's marriage or something? I don't
25 know. That you decorated a stage with 83,000 worth of stuff and the same 83,000 is not there
26 in the AGM. Then if you have.... That is the... That is what you follow... That is the standard
27 you follow, then this 83,000, it should also be there in the AGM which was conducted for much
28 more people ...because no stage was decorated there. So what I am trying to say is it's very
29 clear that this is an account which has been made just to fill in the gaps. We spent so much

1 money. *Lagado kahin bhi*. That is the impression which comes from this account and this
2 account, I'm very sorry to say,. I'm saying it in the open forum, definitely smacks and there's
3 a prima facie case for conducting a forensic audit. And if something then emerges, then action
4 has to be taken as per the law, as per the Society's Act.

5 For example, there is total disregard for the money of the Federation in the same. In this AGM
6 itself, Sir, I will give you a notice. We received one. I live in Ooty. I received one notice dated
7 saying the AGM is being held on the 21st July for which a large amount of printing charges is
8 Rs. 58,075 for the last... I don't know what it is now. I'll check. It was last. ...Then the AGM is
9 postponed to 18th of August. Again I get another booklet which is [UNCLEAR]... material is
10 actually the same. That booklet, in this book, only ...the 21st July has been substituted for the
11 18th August. So there's no respect at all for the Federation's funds. This Federation which is
12 so deep in the red, there is no respect for any funds and how they are utilised. A simple email
13 could have been circulated for the 21st July 18th... 18th August.. No. Booklets were circulated
14 all over again. When large amounts are spent in this wanton manner then it does raise a
15 suspicion, which may be true, may not be true, that people are spending large amount because
16 the more you spend then we all have worked in Governments and we know what that means.
17 You spend more, so more kickbacks. That's the only thing I can make.

18 Then in the Athletes Commission expenses. Again here he is given expenses where he's... He's
19 given the expenses of the honourable observer. I have no issue with that.

20 **Dr SY QURAISHI:** *Observer ki jo honorarium ka zikar aa raha hai bar bar please spell out*
21 *inka kya milta hai aur kitni bar milta hain..... Muje kaha yaad hain.....mujhe bhi bata do.*

22 **COLONEL SANDEEP DEWAN:** *Athletes Commission mein* It's been mentioned. Sir, I
23 have the greatest regard for you. You may not remember, I even met you when you were Sports
24 Secretary. And we belong to the same college. I am also Stephanian . So I don't want to say...
25 Whatever I am bringing now... It should not be taken personally. It's only what I have
26 observed. The accounts are spoken and I am raising my.. You may find it right or wrong. See,
27 he's written here that 69,094 is for an air ticket to go to Bangalore. 200,000 is the
28 remuneration for this meeting. Then he's written...

Dr. SY QURAISHI (OBSERVER): 69000 is what?

COLONEL SANDEEP DEWAN: Air tickets from Delhi to Bangalore...

SECY GEN: This is April last year ? The remuneration has been

[UNCLEAR]

COLONEL SANDEEP DEWAN: This is....I will give the date. I will read it out. Payment to Elite Holidays... payment for air ticket charges booked for the Honourable Observer for Athletes Commission election. 69,094. Then 200,000 is the remuneration. Then in this again he is mixed up. He has brought out Justice Midha's thing in this. Because he realised, he made a mistake writing about Athletes Commission. So again filling in... Filling in the gaps has taken place where he given Justice Midha's remuneration as 500,000. Dr. SY Quraishi as 350,000. Mr Tapan Chakravarti as 200,000 and Akshay Chaudhary as 100,000. Total comes to 11 lakhs 50 thousand. For this. This also... I have gone through the order. The order says that this is for five meetings. Five meetings. Whereas as per the record which I have seen, I think only one or two meetings are taken place. So this is that.

Lt Col Sandeep Dewan: And so what I try to say sir is.

Dr. SY QURAISHI: *Wo jo five meetings the, wo to court ne stay kiye hue hai na.....nahi to wo paanch meeting ho gayi hoti.....*

COLONEL SANDEEP DEWAN: So my reading is that shouldn't the remuneration also be divided by five and given per meeting.....

Dr. SY QURAISHI: *Court order tha. Advance mein diye theaap wapas le lijiye*

COLONEL SANDEEP DEWAN: What ever you say, Sir..*jab bhi hoega* The future meeting will be

Dr. SY QURAISHI: [UNCLEAR] *mein _____ Executive Committee, court ne appoint kiya baki mujh pe chod diya ki aap teh karo..... mein vakilo/ judge ki tarah muhphad*

1 *ke bolne wale nahee hoon, mein ne inse kaha ki EC ke 50,000 and AGM ke 1 Lakh jab mere*
2 *se junior Wajiri bacha mere kalka usi ko 5 Lakh*

3 **(Mix voice)**

4 **COLONEL SANDEEP DEWAN:** Justice Waziri is my classmate.

5
6 **Dr. SY QURAISHI:** *Suniye Suniye, jab meine dekha judges ko 5 lakh milta hai to mere ko*
7 *ye chod kar chala jana chahiye..... mera jo pad that ..judges tomain retire hote*
8 *hain*

9
10 **COLONEL SANDEEP DEWAN:** You must be

11 **Dr. SY QURAISHI:** *mein election commission..... in do jo hain vo to hain aap ke time*
12 *mein.....*

13 **Lt Col Sandeep Dewan:** What he was saying was.

14 **Dr. SY QURAISHI:** *kya High Court ke judge mein to Supreme Court ka judge that ...*

15
16 **Dr. SY QURAISHI:** ...

17 **SECY GEN:** *Us ke baad meeting nahi huee,*

18
19 **COLONEL SANDEEP DEWAN:** Sir, one of the appendixes which he has given also is where
20 he has given details of money received for training. Of eventing probable Rs. 94,52000 These
21 are received from the Ministry of Youth Affairs and Sports. This is okay. Then everything has
22 been mentioned. And then very blandly it is written in the end, the army authorities provided
23 60 lakhs for training and exposure of their two personal training as probables. So this one
24 sentence is enough to justify the expense of 60 lakhs? No details have been given for 60 lakhs.
25 Just one sentence is enough to justify that. Because I received it from the army authority. 60
26 lakhs. Therefore, I don't need to give any justification of what has been said.

27
28 **Dr. SY QURAISHI:** We had a treasurer, who is the Treasurer?

29

1 **SECY GEN:** *Wo purane to chale gaye hai,,ham 3 bache..... he was VP(fin) treasurer,*
2 *reports to VP finance chala gaya he was after.....uske baad pehle EC mein decide hua*
3 *Moni Sir ko nominate kiya.*

4
5 **COLONEL SANDEEP DEWAN:** the accounts have also been wrongly signed as - with him
6 signing as the treasurer. When he is not the treasurer, the accounts he was the VP Finance. He
7 signed as a treasurer. That itself is the wrong signature. The accounts firstly don't have an
8 audit report, signed wrongly, have so many defects in it.
9 Until these are, how can these accounts be put up tomorrow? Sir, you please tell me how is it
10 even possible for these accounts in their present form..

11
12 **Dr. SANJAY GUPTA:** Sir they should not be put up...

13
14 **COLONEL SANDEEP DEWAN:** Now I'll give you another example. Like how ITPF have
15 been grossly suppressed. ITPF expenses. Where he has gone into great detail to justify small
16 amounts of 35,000 has been spent in buying ten packing megs, rings, clipboards, Reynolds
17 pen, something, something... Then another 16,000. He's gone into great detail to say he bought
18 32 kgs of *mausambis*, some green net and something else. But 9,41,712 is just quietly written.
19 I mean 16 thousand and 10 thousand have all been written that you bought this and bought
20 that. But nine lakhs is limited to nothing in that book.

21
22 **Col SS AHLAWAT:** Can we suggest a forensic audit?

23 **Dr SANJAY GUPTA:** Sir you have been the CEC...

24
25 **COLONEL SANDEEP DEWAN:** A forensic audit is absolutely necessary

26
27 **Dr SANJAY GUPTA:** And all your engineers are still the CEC. When you scrutinise the MLA
28 spending and PE spending. How much you would have disqualified under your able
29 leadership? Sir. Because I've been part of the IAS civil services. Sir, revenue loss is the biggest
30 loss...

1
2 **Dr. SY QURAISHI: [UNCLEAR]**

3
4 **COLONEL SANDEEP DEWAN:** Let me finish.

5
6 **Dr. SY QURAISHI:** Before you finish *mere naam aur to kuch nahi hai*
7 *Business classes mein jaunga, 40 Saal se business class se travel kar...*

8
9 **COLONEL SANDEEP DEWAN:** That's your right. That's your right

10
11 [UNCLEAR] Hindi conversation between Dr. SY QURAISHI and COL Sandeep Dewan.

12
13 **COLONEL SANDEEP DEWAN:** I wish he would have presented it in that office. But to be
14 silent about a thing unnecessary raises questions. He could have written in the account -.
15 Remuneration. He has not mentioned it in the account anywhere. Remuneration to Justice
16 Waziri [UNCLEAR], remuneration to so and so..... there are remuneration as per order of the
17 court.

18
19 **(Mix voice)**

20
21 **COLONEL SANDEEP DEWAN:** *Accounts mein kahin nahi likha.*

22 **SECY GEN:** *Sab hai...*it's there.

23
24 **COL JAGAT SINGH :** Show it...Show me the head.

25
26 **COLONEL SANDEEP DEWAN:** It has been camouflaged in big heads. Why not put a
27 special head? Why camouflage it in a head of 40 lakhs or 50 lakhs? That raises a doubt of
28 some....a suspicion of some *malafide* intent. When you do that, you should be direct, you
29 should write things properly.

30
31 **COL S S AHLAWAT:** You should be open about it....these are the expenses...

32
33 **COLONEL SANDEEP DEWAN:** You should be open.

1 **COL S S AHLAWAT:** These are the permissions taken and ...

2

3 **COLONEL SANDEEP DEWAN:** That's why right in the beginning, I said that this is not ...

4 People will try to turn it around and say, this is not an attack on anyone. I am only bringing
5 out accounting procedures.

6

7 **Dr. SY QURAISHI:** By the way, you are a Chartered Accountant?

8 **(Mix voices)**

9

10 **COL S S AHLAWAT:** He's a special invitee.

11

12 [UNCLEAR]

13

14 **LT COLONEL SANDEEP DEWAN:** No. I am not. I am only bringing out accounting
15 procedures and they invited me and I saw the accounts. I've been riding since the year 1980.

16

17 [UNCLEAR] **Dr. SY QURAISHI:** *Riding to ache cheej hai but ...*

18 **(Mix Voices)**

19

20 **LT COLONEL SANDEEP DEWAN:** You are an IAS officer? We are army officers. We are
21 also groomed to see accounts. We also know to see..

22

23 **Dr. SY QURAISHI:** [UNCLEAR]

24

25 **LT COLONEL SANDEEP DEWAN:** I left the army in 2008 as Lt. Colonel. My last posting,
26 I was in the IMA - Indian Military Academy was there, I was instructor. After that I started my
27 own..., I have my own farm where I breed houses and I train people.

28

29 **Dr. SY QURAISHI:** *Kahan pe?*

30 **LT COLONEL SANDEEP DEWAN:** in ooty.

31

32 [UNCLEAR]

33

1 **LT COLONEL SANDEEP DEWAN:** So what I want to bring out, Sir, is now, these
2 are general points of accounts. These are points of account, but they also are the general points
3 also.

4
5 **SECY GEN:** These the expenses of Athlete Commission.

6
7 **Dr. SY QURAISHI:** *Ek minute* You complete ...

8
9 **COLONEL SANDEEP DEWAN:** These are the points of accounts there are several points.

10 Now, Sir, you are also aware that there was a false statement made in the EGM which has been
11 taken note of by the Honourable High Court now. And there is an interlocutory application
12 also, which has been filed under section 340 of the CRPC which pertains to purging. This is an
13 offence where a person is individually liable and it's not the first time it's happened. We are
14 also defending a case of Colonel Dhaiya, who had committed a similar offence where he gave
15 a wrong report to the court. Perjury, now under section 195 of the CRPC... So you are aware
16 that this is a grave offence which affects the administration of justice and carries imprisonment
17 terms of up to seven years. So now, whether it is correct or wrong or whatever, it is now before
18 the Court, and this gentleman is named in that, in that section 340 complaint. Justice Tara
19 Ganju herself has said in her judgement that a wrong report was given to me about the EGM,
20 about the EGM and what it said. So this is very serious. Now, it is for this body to consider
21 whether a person who is accused of such an offence should continue as the Secretary General
22 during the pendency of this complaint, or because there are so many things which can happen,
23 its perjury..., can fiddle with evidence, you can do all kinds of things, if you are there.

24 So I would... This is my one thing. Second is that this gentleman.. now I am talking about other
25 things. He has caused grave harassment to the riders in every way he can because
26 unfortunately, he is viewing all riders through his prism of *ye hamari side ka hai ya dusri side*
27 *ka hai*. He is viewing riders like that. He is forcing people to join clubs, not accepting individual
28 entries. Where is it written that I should be a member of a club to participate? No, I don't
29 know. I am not there.

1
2 **(Mix Voices)**

3
4 **COLONEL SANDEEP DEWAN:** So there is so much harassment has been caused? I live in
5 South India. People have been forced to send their passports. He has been telling people, "Send
6 your passports to me. Getting them stamped by some club in Chandigarh... sending them back.
7 What are we doing? A normal rider - I was also not interested in the politics.

8
9 **MAJ GEN DEEP AHLAWAT:** This issue was discussed in the last EC...(Mixed Voices)

10
11 **SECY GEN:** This has been resolved.

12
13 **LT COLONEL SANDEEP DEWAN:** So I am also not interested in the politics of it. The
14 thing is that when it affects riders is when for a small thing like giving an entry or of getting
15 their horse registered, of getting their passport done, they face tremendous harassment from
16 this gentleman who forces them literally to run from pillar to post... Doesn't do their work till
17 they beg him and I don't know what all they do and then only he does their work. And this has
18 become a very bad thing which is happening, especially people who are in South India. I live
19 in South India. There are people in Coimbatore, in all these small places, mofussil towns and
20 things who are now being held ransom.

21
22 **COL S S AHLAWAT:** Some people have their own horses. They like to go and compete.

23
24 **[UNCLEAR] (Mixed Voices)**

25
26 **COLONEL SANDEEP DEWAN:** No, they are not accepting...

27
28 **[UNCLEAR] (Mixed Voices)**

29
30 **LT COLONEL SANDEEP DEWAN:** Sir, another thing I want to bring out is we are a
31 Federation who should be promoting. But this Federation has turned into a blood-sucking
32 organisation sucking the blood of the riders to raise these large sums of money to fight
33 litigation on things of their own making. Like for example, many years ago when his

predecessor was there, I had objected to a thing called 250. Now today Sir, do you know that if I have to go to compete and I say I, any rider who has to go to compete in Europe or anywhere, he takes it used to be 250 which I had objected greatly at that time. Now he made it 500 on his own, \$500 to just give a No Objection certificate for him to participate in events in Europe. We should promote... which federation...

(Mixed Voices)

COLONEL SANDEEP DEWAN: I would challenge any federation. There is no Federation in India that charges money. Rather they help them. He is charging money \$500 for them to go abroad to compete at their own expense. Everything paid for by them. *Yaha par payment jama kar ke jao*. To give us a two-line letter that we have no objection. That is 1.

Second is now import of horses. Also he started the same thing. Import of horses. The Federation needed to just give a NOC that we know so and so and... And we have no objection to import a horse that also he's now started charging 25 or 35 or I don't know what he started charging. These are unethical things Sir. It's not the money. And what are the what is and what is the.... What are the very caustic remarks you are given when you ask? They got big money. If they can afford to buy a horse, they can pay \$500 to us. Is that the way? Is that the way? Are these are to look at our riders? Are we just blood suckers sucking their blood or are we here to facilitate their performance and help them to do well?

What is this? It's a very... I would say at the moment, we are at rock bottom. We can't go any further. We hit rock bottom. And Sir, I think drastic changes are required. Otherwise there is no... That's my.

SECY GEN: Sir, I've given replies. We've covered everything. As regard forensic audit, there's no problem. There are certain statements which is made which are incorrect. Sir, regarding the behaviour and he is not... about the horses.. issues have been resolved.

MAJ GEN DEEP AHLAWAT: Minutes are still not uploaded.

SECY GEN: Lt Col Dewan is sir free to leave.

1
2 **MAJ GEN DEEP AHLAWAT:** Would you reply to his queries.

3
4 **SECY GEN:** I will again.. Sir, I have already put it in writing. I will not say anything more
5 than that.

6 **SECY GEN:** Let's finish with his points.

7 **COLONEL SANDEEP DEWAN:** My points are finished with this. My points are that the
8 accounts in their current form cannot be put up before the General Body tomorrow. That's the
9 last point. That is my last point. And if they are put up, it will be a grave and it will unnecessarily
10 open up the Federation to further litigation is my view. Remaining it's up to..

11
12 **Dr. SY QURAISHI:** *Inhone jo point diya 14 lakh, Athletes Commission iske point out diya*
13 *hua hai.*

14 **SECY GEN:** *Diya hua sab kuch.*

15
16 **MAJ GEN DEEP AHLAWAT:** *Dikha do.*

17
18 **COLONEL SANDEEP DEWAN:** I have shown.....I have gone through the details which
19 are very cursory written. I told you. See here it take out Appendix N **(Mixed voices)**

20 **MANY SPEAKERS:** Show him, show him.

21
22 **SECY GEN:** *Ye sara likha hua hai.*

23
24 **COLONEL SANDEEP DEWAN:** Appendix N which is forwarded to me. You may see. Most
25 of them have no explanation. The most large amount of 9,41,000 has no explanation. That's
26 all. Then here also, if you see, there's no explaining... the item.. itemization. There's no
27 explanation. It's just ...going through the motions ke Dewan Saab has asked and I have given
28 the answer.

29
30 **Dr. SANJAY GUPTA: (Not Clear)**

31
32 **COLONEL SANDEEP DEWAN:** How can he say his answer?

1
2 **Dr. SANJAY GUPTA: (Not Clear)**

3
4 **SECY GEN:** Sir, this was approved by... first... Sir *Aap khatam kardo... phir* then I can...

5
6 **SECY GEN:** If he is finished, he can leave..

7
8 **MAJ GEN DEEP AHLAWAT:** He is only here to give his [UNCLEAR] and then he will leave.

9
10 **SECY GEN:** I'm telling you. I have replied... If there is any additional information he wanted,
11 then...I would have given him that also.

12
13 **MAJ GEN DEEP AHLAWAT:** So you have finished your reply?

14
15 **SECY GEN:** This reply was approved General Gopal and concurred by VP (Fin)

16
17 **COL S S AHLAWAT:** Sir, he can't do things selectively....this is as per NSDCI-2011 lets do
18 this. Lets follow this. Now it doesn't suit me at so and so decision was taken 20 years back. So
19 let's go ahead...

20
21 **SECY GEN:** Sir this was the reply given to his observations.

22
23 **COL JAGAT SINGH:** Have you sent a copy to EC members?

24
25 **LT COLONEL SANDEEP DEWAN:** Yes/No.

26
27 **SECY GEN:** No. Sir, General Gopal. Okay. General Gopal had written in his I will show it to
28 you.....only to reply to him.

29
30 [UNCLEAR]

31 I'm sure only to reply to him. And after writing [UNCLEAR]...

32
33 **COLONEL SANDEEP DEWAN:** General Gopal is no more there defend himself.

34
35 [UNCLEAR]

1
2 **SECY GEN:** You can ask him...

3
4 **COLONEL SANDEEP DEWAN:** Why should I ask him?[UNCLEAR] Can a resigned
5 president dictate what the EC should do?

6
7 **SECY GEN:** He has written in his. No, that time he didn't resign. When he wrote that mail,
8 he had said...

9
10 **COLONEL SANDEEP DEWAN:** And your second mail? Your second mail is after he
11 resigned. 5th August mail...

12
13 **SECY GEN:** So there is nothing but what he rightly said. I had take the approval of VP
14 (Fin) [UNCLEAR] There is [UNCLEAR]. He has taken his approval ...

15
16 **COLONEL SANDEEP DEWAN:** He needs only VP's approval?

17
18 **MAJ GEN DEEP AHLAWAT:** Can you reply on behalf of the EC? Are you replying in your
19 personal capacity?

20
21 **SECY GEN:** I'm replying on behalf of the federation, But what you rightly said now is today's
22 new rule, it was not there earlier.

23
24 **COL JAGAT SINGH:** You are supposed to go with that side of EC only.

25
26 **COL SANDEEP DEWAN:** Now he has come to the crux of the matter where he is
27 differentiating between the Federation and the EC. He feels he is the Federation and EC is
28 somebody else.

29
30 **SECY GEN:** No sir, No sir.

31
32 **COL SANDEEP DEWAN:** You just said it...

33
34 **SECY GEN:** I don't agree to this. I don't agree. EC is part of the federation, whether they are...

1
2 **COL SANDEEP DEWAN:** Not part of the Federation, they are the.... [UNCLEAR]

3
4 **SECY GEN:** I know what EC is and I know what the Federation is. So please Sir.

5
6 **COL SANDEEP DEWAN:** We all know. I was there much before you by the way.

7
8 **DR. SY QURAISHI (OBSERVER):** *Aap batayeyeh aap...*

9
10 **COL JAGAT SINGH:** I think sir, we have heard, let the EC take a call now.

11
12 **MAJ GEN DEEP AHLAWAT:** Ahlawat sir, he's the acting treasurer, He's prepared to
13 [UNCLEAR].... If, he's prepared to than lets finish it off.

14
15 **COL SS AHLAWAT:** From my side, from my side. We need to go through a thorough, what
16 do you call it? Forensic Audit.

17
18 **MAJ GEN DEEP AHLAWAT:** Sir, but you have been to Federation 3-4 times. What are the
19 generic observations? So this necessitates...

20
21 **SECY GEN:** Just 1 second sir. Sir Lt Col Sandeep Dewan is finished he can leave.

22
23 **DR. SY QURAISHI (OBSERVER):** Colonel Sahab if you are done. You have made very
24 important point. They are going to be discussed and debated. Very interesting and useful
25 information. They were very interesting and useful information.

26
27 **COL SANDEEP DEWAN:** Obligated sir. Thank you very much. I once again say Sir; none of
28 my things are personally directed to anyone, least upon you.

29
30 **DR. SY QURAISHI (OBSERVER):** *Mujhe toh apne aap mein time hi nahin hai.*

31
32 **SANJAY GUPTA:** Just in case you're not running late. You can wait outside.

33
34 **COL SANDEEP DEWAN:** I'm outside.

1 **SANJAY GUPTA:** If we need, we can request you once more.

2
3 **Dr. SY QURAISHI (OBSERVER):** *Ab yeh nahin kahenge, bahar aa to dekhta hoon.*

4
5 **COL SANDEEP DEWAN:** Sir, *meri kya majal hai. Aap mere to...You are my college mate.*
6 My Senior. Senior, senior, not mate. I withdraw that.

7
8 **Dr. SY QURAISHI (OBSERVER):** *Army ki seniority of one day matters..*

9
10 **COL S S AHLAWAT:** Sir same day, IC no.

11
12 **Dr. SY QURAISHI (OBSERVER):** Thank you so much. Very...Very useful information.

13
14 **COL S S AHLAWAT:** So, whatever little I have seen so far, sanctions are missing. Sanctions,
15 sanctions are just amongst themselves, amongst two people. The thing has been broken. I
16 mean if there is an expenditure of say a judge, his accommodation thing is being paid
17 separately.

18
19 **MAJ GEN DEEP AHLAWAT:** Like you mean to say split it off.

20
21 **COL S S AHLAWAT:** Yes. Splitting of financial powers and since there was so many of these
22 objections...

23
24 **COL JAGAT SINGH:** What about if AGM approves the budget?

25
26 **COL S S AHLAWAT:** No question. Unless he fought it out also that there are lot of
27 complaints, there are lot of issues that need to be sorted out, only then, only then we should
28 be in a position to give our...

29
30 **Dr. SY QURAISHI (OBSERVER):** [UNCLEAR] *nahin hai, toh isme kya problem hai.*
31 [UNCLEAR] *ready nahin hai.*

32
33 **SECY GEN:** Nahin sir, Accounts *humko bhale paas karana hai*, accounts *har baar AGM*
34 *mein approve hote hi hote hain.*

1

2 **Dr. SY QURAISHI (OBSERVER):** Approve *hote hain...*

3

4 **SECY GEN:** *Yeh statutes pe nahin likha hoga.*

5

6 **Dr. SY QURAISHI (OBSERVER):** *Nahin, lekin agar EC ye kehti hai ki accounts se...*

7

8 **SECY GEN:** *Sir, humko apne time ko...*

9

10 **COL JAGAT SINGH :** *Yeh apne time ko... aapka kehna hai ki account [UNCLEAR] nahi*
11 *hai.*

12

13 **SECY GEN:** *Sir hum toh time se aaye hain. 12 July se aaye hain. 12 July ke baad hi denge.*

14

15 **MAJ GEN DEEP AHLAWAT:** *Nahi nahi aapne paanch, 6 din maange the beech mein. You*
16 *did not allow him initially. You said you have to come after six days after five days...*

17

18 **SECY GEN:** *Nahin nahin aisa kuch nahi hai. Based on the availability of each other I have*
19 *been showing him everything.*

20

21 **COL S S AHLAWAT:** *Sir [UNCLEAR] sent all my signature [UNCLEAR] to the bank to*
22 *acknowledge and operate the accounts and....Sir, this is all...*

23

24 **SECY GEN:** *He was to sign he was not there. He was travelling abroad. Moreover, sir, to get*
25 *a bigger like. He called, they called, I was not aware this special meeting. I can also say that.*
26 *I'm supposed to be aware.*

27

28 **COL JAGAT SINGH:** *Everyone was supposed to know...*

29

30 **SECY GEN:** *They invited fine. Sir you may be right but everything is coordinated by the*
31 *Secretary General. Not [UNCLEAR] No problem. Sir, with due respect to all of you, No*
32 *problem. Sir, now I feel we need to put up everything tomorrow, whatever the discussion.*

33

34 **COL JAGAT SINGH:** *Why?*

1
2 **SECY GEN:** Sir we need to put up everything tomorrowAGM is a bigger house. Just
3 look at it Sir, five people saying and there'll be hundred people there tomorrow. This going to
4 be a difference?.....the majority.... You say you say

5
6 **MAJ GEN DEEP AHLAWAT:** So you're saying so you think they I will be aware of these
7 things?

8
9 **SECY GEN:** *Sir aap bolo na, aap bata na, aap bata na?*

10
11 **MAJ GEN DEEP AHLAWAT:** And in one hour the people will understand, whatever this
12 is.

13
14 **SECY GEN:** *Sir, itna time lagta hai, roz to nahi hum maangte ye....*

15
16 **MAJ GEN DEEP AHLAWAT:** As per Schedules, It has to be through EC, It has to be
17 through EC.

18
19 **SECY GEN:** Sir, how can you... Sir, how can you continue through EC *batao, dikhao,*
20 *dikhao...chalo.*

21
22 **COL S S AHLAWAT:** Also, you are supposed to keep your accounts ready to be seen by
23 anybody.

24
25 **SECY GEN:** I kept it...

26
27 **COL S S AHLAWAT:** Listen, I went there yesterday only. I'll tell you....

28
29 **SECY GEN:** [UNCLEAR] Sir, I was not there yesterday.

30
31 **COL S S AHLAWAT:** So, you are supposed to keep them.....

32
33 **SECY GEN:** *Aap mereko batayenge nahin.....aap mera call record dekh lo....*

34
35 **COL S S AHLAWAT:** *Aap mera bhi dekh lo.....*So the thing is...

- 1
2 **COL JAGAT SINGH:** Can also visit them without [UNCLEAR]
- 3
4 **SECY GEN:** Sir, *woh* easy to common [UNCLEAR].....
- 5
6 **SANJAY GUPTA:** [UNCLEAR] under no circumstances...under no circumstances
- 7
8 **MAJ GEN DEEP AHLAWAT:** [UNCLEAR]*yeh dekh ke present ho gaya ab chalo*
9 *aage....Jaiveer, Jaiveer. Sir, he functions.....*
- 10
11 **SECY GEN:** Sir, It is nowhere written about the approval....
- 12
13 **MAJ GEN DEEP AHLAWAT:** It's very difficult to comprehend those procedures.
- 14
15 **COL JAGAT SINGH:** It is in here. We are reading everyday....
- 16
17 **MAJ GEN DEEP AHLAWAT:** [UNCLEAR] *teen char saal ke liye* [UNCLEAR])
- 18
19 **SECY GEN:** Sir, *aisi baat nahin hai.. Sir aapko....*
- 20
21 **MAJ GEN DEEP AHLAWAT:** *Sab ki respect karo. Sir, sab ki respect karo....*
- 22
23 **SECY GEN:** Tell the Vice President.....Sir, is this justice [UNCLEAR]?
- 24
25 **COL JAGAT SINGH:** What he's trying to say is.....Also tell him in the Annual General
26 Meeting, what is he...
- 27
28 **SECY GEN:** I'm in the General Body
- 29
30 **COL JAGAT SINGH:** *Baad mein* give him any reason no...
- 31
32 **SECY GEN:** *Bol toh raha hoon...*
- 33
34 **COL JAGAT SINGH:** *Yeh kahan likha hai...*
- 35
36 **SECY GEN:** No, no...I think....Sir; there is a biased against me.

1
2 **COL JAGAT SINGH:** We are not biased...[UNCLEAR]

3
4 **SECY GEN:** Sir, *bol hi nahin rahan hoon.*

5
6 **COL JAGAT SINGH:** In the coming months Sir, funding ourselves from the government,
7 we are very clear on this EC will not support you on this matter.

8
9 **SECY GEN:** *Mein toh bol hi rahan hoon* [UNCLEAR 03:05:35]. This is what the judge is going
10 to say.

11
12 **COL JAGAT SINGH:** No, no.

13
14 **SANJAY GUPTA:** Everybody would be underneath the scanner, if it goes without approval
15 once again, everybody will be underneath the scanner.

16
17 **SECY GEN:** No, *humne sign kiya hua hai* 12th July we are taking the responsibility. How is
18 the EC responsible?

19
20 **COL JAGAT SINGH:** Your part of EC only.

21
22 **MAJ GEN DEEP AHLAWAT:** Jaiveer, we have to verify. There's nothing much.

23
24 **SECY GEN:** *Mujhe kisi baat ka darr nahi hai.*

25
26 **MAJ GEN DEEP AHLAWAT:** We have cushion till 30th September. We can conduct the
27 AGM till 30th September.

28
29 **SANJAY GUPTA:** And even after that, after paying some fine.

30
31 **SECY GEN:** Sir, *abhi aapne 2 saal ke liye ek saath ke liye bola hua hai. Mein toh pehle ye hi*
32 *bol raha tha. Ek ab karwate hain aur 3-4 mahine ke baad dusra karwate hain. Aap ne bola*
33 *dono ekathe kardo.*

1 **MAJ GEN DEEP AHLAWAT:** Let us verify the issue. There is no harm. And if you go
2 through the merits. It was very categorically mentioned that, that is why the ten days' time was
3 given between EC and the AGM, so that these things can be resolved [UNCLEAR] and
4 gracefully put up next.

5
6 **SECY GEN:** Sir, I'll tell you.

7
8 **MAJ GEN DEEP AHLAWAT:** *Usme aur ek cheez likha hu hai* AGM will be held on 18th
9 provided accounts are clear.

10
11 **SECY GEN:** Sir, there is a dispute in that. Let us not go that way. *Iss para ka matlab ye tha*
12 *ki pehle old statutes mein tha ki 30 April tak points dene the.* No logic. *Padh raha hoon mein.*
13 *Jo aap bol rahe ho 10 din pehle EC, woh nahi likha hua. Sir aap logo aaj ki date mein EC*
14 *decisions sabh mails pe le rahe ho.*

15
16 **COL JAGAT SINGH:** He is not believing the merits only....

17
18 **COL S S AHLAWAT:** He's not ready to [UNCLEAR].

19
20 **Dr. SY QURAISHI (OBSERVER):** *Ek baar wo para pad kar sune dena.*

21
22 **SECY GEN:** Sir, *dekhiye...Para 10 mein [UNCLEAR] kehta hai, "to decide on items*
23 *[UNCLEAR] on request of members."* *Iska further define kiya hai uska Article 10 "Points to*
24 *be include in agenda for Ordinary General Assembly must be sent to Secretary General ten*
25 *days prior to the date of meeting. In order to enable the Secretariate to include the same. The*
26 *Secretary will ensure that all such points are put up to the Executive Committee for discussion*
27 *and deliberation. The Executive Committee may thereafter decide to include or exclude the*
28 *point in the agenda of the General Assembly. The member concerned in any case would be*
29 *informed of the outcome by the General" ...*

30
31 **MAJ GEN DEEP AHLAWAT:** *Toh chaliye.*

32

1 **SECY GEN:** So it is not saying that PC. Sir *aap log bahut decisions le rahe ho*. Emails pe
2 decision *le rahe ho...*

3
4 **MAJ GEN DEEP AHLAWAT:** *Theek tho hai. Acha dusri baat kal AGM hai*. Where are the
5 agenda points of AGM.

6
7 **SECY GEN:** Sir, agenda points of AGM also *meine aapko circulate kiya hua hai*. Sir website
8 *pe hai*. Postal *bhi bheja hua hai* *meine*.

9
10 **Dr. SY QURAISHI (OBSERVER):** *Abhi jo aapne padha tha, isliye* they are saying, EC has
11 to clear this.

12
13 **(MIX VOICES UNCLEAR)**

14 **SECY GEN:** No *koi* points member's *hai ne liya hai...*

15
16 **Dr. SY QURAISHI (OBSERVER):** [UNCLEAR] Clear or not clear, *yeh pada aapne*. So if
17 EC not clearing it today than when are you....

18
19 **Dr. SY QURAISHI (OBSERVER):** Points for member's *hai*. Points to be...

20
21 **MAJ GEN DEEP AHLAWAT:** He is a member. He has given his points. Dewan is a member,
22 he has given his points.

23
24 **COL S S AHLAWAT:** He has always been giving his points.

25
26 **SECY GEN:** Sir, traditional *toh bahut sari cheezein hain*.

27
28 **SANJAY GUPTA:** [UNCLEAR] Sir, the Lordships said that the AGM should not take place.

29
30 **SECY GEN:** AGM should take place.

31
32 **SANJAY GUPTA:** No, It should not take place.

33

1 **Dr. SY QURAISHI (OBSERVER):** AGM *ke liye* [UNCLEAR] *Mere paas* [UNCLEAR].
2 *Postpone nahi honi chahiye. Postpone nahi honi chahiye. Toh unko bata dijiye saari baatein,*
3 *aisa nahin* [UNCLEAR]

4
5 **MAJ GEN DEEP AHLAWAT:** We clarify one thing, Sir *jiske liye email aaya hai, unka*
6 *selection criteria and technical guidelines or all the calendar and all, who toh AGM ka purview*
7 *hi nahin hai. AGM ka purview yeh EC ka purview hai* [UNCLEAR].

8
9 **COL S S AHLAWAT:** [UNCLEAR]

10
11 **Dr. SY QURAISHI (OBSERVER):** AGM *Woh kal ke liye scheduled hai, usko postpone*
12 *karne* [UNCLEAR]. *Toh AGM unko sare fact bata dijiye.*

13
14 **SECY GEN:** Then let the AGM decide. [UNCLEAR] Sir, *wahan woh bhi to bol sakte hain ke*
15 *accounts cancel kar agli baar phir se maat karo.*

16
17 **COL S S AHLAWAT:** Sir this is a plan.....**(Mix voices)** Several people will come *accha*
18 *bhai thoda sa, I'll give point 'a' haath raise karega, another hundred will raise their points,*
19 *without knowing what is happening... That is how*
20 *they have been bulldozing their way through. Sir.*

21
22 **MAJ GEN DEEP AHLAWAT:** It will not happen like that...

23
24 **SANJAY GUPTA:** Unless the matter is start [UNCLEAR] towards the matter has gone to the
25 *Economic Offences Wing also. This accounts matter has also gone to EOW, whenever they*
26 *register, whenever they say, So, everybody again would be in scanner.*

27
28 **COL S S AHLAWAT:** Right, I'm not for it...

29
30 **SANJAY GUPTA:** In Delhi, however the matter is

31

1 **HARISH KHOKHAR:** Sir, I think it serves all, I mean all the problem that you raise by
2 executives goes to EOW, then I don't think there's a bigger body than EOW to cross check the
3 accounts so if anybody has any doubts...

4
5 **SECY GEN:** We will go to the EOW.

6
7 **HARISH KHOKHAR:** It will automatically get sorted out, and if it has already gone to the
8 EOW, so there is no need to worry about it. Sir, it is one of the biggest investigative body that
9 we have in the country.

10
11 **SECY GEN:** *Yeh woh hi toh keh rahe hain.* Exactly, sir, *pehle General Body se puch lete hain,*
12 *baad mein....*

13 **COL JAGAT SINGH-** *General Body se Kyun puchna.....*

14 **(Mixed Voices)**

15
16 **Dr. SY QURAISHI (OBSERVER):** Hold on, *abhi the Economic Offences Wing mein agar*
17 *chala gaya hai, woh bhi forensic audit hi karenge. Toh....*

18
19 **MAJ GEN DEEP AHLAWAT:** There is another false [UNCLEAR]

20
21 **COL JAGAT SINGH:** Yeh information kisne bataya?

22
23 **HARISH KHOKHAR:** Sir, in the same time I would also like to add one thing....

24
25 **Dr. SY QURAISHI (OBSERVER):** Ek second *rukiye* Forensic audit *maine Hockey India*
26 *ka karaya tha Yeh karaya tha...27 Lakh rupaiye* [UNCLEAR], Off course findings were
27 explosive, who sealed cover *mein* Supreme Court *mein padi hui hain, hamare term katham*
28 *hone ke baad bhi* Supreme Court *ne, humne yeh stand liya ke saab isme bahut kuch dynamite*
29 *hai, isko close down maat kijiye.*[UNCLEAR] *Lekin 27 ke 27 lakh apne jayenge, toh uske bajay*
30 *Economic Offence Wing, ussi team ko jo hai....*

31

1 **COL S S AHLAWAT:** Economic Offence Wing will take a long time; I don't know who has
2 said it?

3
4 **Dr. SY QURAISHI (OBSERVER):** 27 lakh rupaiye dene ko tayar hai.

5
6 **COL S S AHLAWAT:** 27 lakh, *yeh toh* 35 lakh to sirf TV le liye karch kar raha hai, aap
7 dekhiye accounts mein. I'm only saying what he has said for next accounts only for PR
8 Agencies that you spend 25 lakhs? *Yeh toh kuch bhi nahin hai*, sir. I mean this is ridiculous.

9
10 **SECY GEN:** [UNCLEAR] sheet *nahin hoti, bataye sab ko*.

11
12 **COL JAGAT SINGH:** Now, quorum for the house, one more point for the EC finance. I was
13 seeing the AGM notice in which you have given the estimate [UNCLEAR] house, the income I
14 could see is about 3 crores of the Federation and you are showing the bus budget estimate for
15 5.75 something. Where do you plan to get that money?

16
17 **HARISH KHOKHAR:** Sir, **must** be from government sources

18
19 **COL JAGAT SINGH:** Which Government sources?

20
21 **HARISH KHOKHAR:** 3 crores, there are only two types of income the federation has.

22
23 **COL JAGAT SINGH:** I know everything.

24
25 **HARISH KHOKHAR:** One is from the Government authorities, second is from All
26 [UNCLEAR].

27
28 **COL JAGAT SINGH:** That is for the 3 crores, where do you plan get the other balance...

29
30 **HARISH KHOKHAR:** No, sir *dono ko milakar.....aisa hai he toh* I don't think I will vote,
31 I'm no one to break their lease. In fact I'm the first one against it and I said that *thoda sa fees*
32 *bada ke*, we should retain the athlete, we should not break him. Also [UNCLEAR] *ko jawab*
33 *diya tha*, Dewan sir ka...nobody is trying to understand it. Logic *yeh nahin karcha jada hua*

1 *das salon mein, as per cumulative cost were in 4 years, uske budget hai sir. Do salon mein*
2 *trials karaye gaye. Jab trials kareye gaye, foreign jury zaada ayee, uske travel expense uske*
3 *vajeh se kayi zaada hua.*

4
5 **COL JAGAT SINGH:** AGM ne budget *diya tha aapko, aapne true karaya AGM se, 80*
6 *percent, 90 percent kharcha kaise bada rahe ho...*

7
8 **COL S S AHLAWAT:** It is very whimsical....

9
10 **HARISH KHOKHAR:** It was not in our hands, Trials were done twice. That was not in our
11 hands. Twice sir, *do baar*

12
13 **COL JAGAT SINGH:** *Saab kuch likha hua tha...*

14
15 **MAJ GEN DEEP AHLAWAT:** Expenditure income is 1.80 lakhs, *matlab* it has 80% more
16 than doubled.

17
18 **COL JAGAT SINGH:** AGM *mein* very clearly said in the schedules, you can't cross the
19 [UNCLEAR]. AGM *ne paas kiya hua hai.*

20
21 **SECY GEN:** *Nahin*, in the AGM in the role of VP (Finance) sir you can.

22
23 **COL JAGAT SINGH:** *Kahan likha hai?* And [UNCLEAR] have you informed the AGM that
24 you are breaking the FD's.

25
26 **HARISH KHOKHAR:** FD'S *toh pichli baar saab ko[UNCLEAR].*

27
28 **COL JAGAT SINGH:** *Nahin, nahin kisko bataya.*

29
30 **SECY GEN:** *Pehle toh EC [UNCLEAR] mein kum.*

31
32 **HARISH KHOKHAR:** *Nahin nahin..AGM mein[UNCLEAR] ko bolo ge tab aayega*

33
34 **COL JAGAT SINGH:** *Nahin nahin..*

1
2 **SECY GEN:** *Aata hain, FD's ka aata hai.*

3
4 **MAJ GEN DEEP AHLAWAT:** They were office bearers also, we were later taken into
5 confidence, he is the elected, he was just saying no ...they were two of them, you scratch my
6 back. I scratch your back....*chalo.*

7
8 **HARISH KHOKHAR:** You can not to say that...without

9
10 **MAJ GEN DEEP AHLAWAT:** Why, why he was not consulted, you give me justification.

11
12 **HARISH KHOKHAR:** Sir, 1) I was not in the office 2)It was never the thing that you scratch
13 my back and I mean we had lot of defence....this was delegated...

14
15 **MAJ GEN DEEP AHLAWAT:** You should have said there are office bearers, we should also
16 consult him.

17
18 **SECY GEN:** Deep Sir, *aapne* when we started like today morning also he said last time also
19 time, he met the President also, we will not, he said let bygones, be bygones.

20
21 **MAJ GEN DEEP AHLAWAT:** *Nahin nahin yeh tune shuru kiya hai*, you are not up to date
22 with the minutes. You started this.

23
24 **SECY GEN:** Sir, *mein toh ke raha hoon, aap* threatening letter *diya rahe hai yahah pe...*

25
26 **MAJ GEN DEEP AHLAWAT:** You are vacant on June, 1 St of August without asking Vice
27 President on**(Mixed Voices)**

28
29 **SECY GEN:** And I have already told you, put all this in writing, we want all of this in writing.

30
31 **COL S S AHLAWAT:** You are supposed to explain it us, please explain.

32
33 **SECY GEN:** There is nothing to explain.

34
35 **COL JAGAT SINGH:** Don't be smart here...

SECY GEN: Smart *nahin hoon* sir. Don't say that.

MAJ GEN DEEP AHLAWAT: He has not allowed SANJAY GUPTA to go for out of court settlements.

SANJAY GUPTA: I spoke to the concerned lawyers.

MAJ GEN DEEP AHLAWAT: To reduce the budget.

SECY GEN: Sorry.

Dr. SY QURAISHI (OBSERVER): *Yeh hai.*

SANJAY GUPTA: He said speak to the Secretary General, we will not do it, they have done nothing to it, because he's not spending money on of his own pocket, he's enjoying the money of the Federation.

COL S S AHLAWAT: Sir, 50,000 for appearance, *woh kya kehte hain...* appearing, 50,000 it is going through the papers, they are charging as if *ke chalo ghar banana hai leke. Is hisab se.*

MAJ GEN DEEP AHLAWAT: They have 3 cases ready for out of court settlement, but they are silent. You can ask.

SECY GEN: *Ek toh usme se aapka hai...*

MAJ GEN DEEP AHLAWAT: He was appointed, head of legal team to negotiate for fixing of remunerations, SOPs, he was...[UNCLEAR]

SANJAY GUPTA: Given two letters...

MAJ GEN DEEP AHLAWAT: He has given two letters.

SANJAY GUPTA: No reply.

1
2 **SECY GEN:** Nahin sir. I replied all the information is available on the website. Sir *aapne....*

3
4 **COL JAGAT SINGH:** Why are we sitting here then? If you say ki...If it's available on the
5 website.

6
7 **COL S S AHLAWAT:** It's available on the website....

8
9 **SECY GEN:** You are at my office, earlier I went to your office, *mein aap ke pass aya tha..*

10
11 **SANJAY GUPTA:** Not for the EC members, that's' maybe for the other Life Members. Not
12 for the EC members writing. No...

13
14 **SECY GEN:** Sir, *yeh kya hai...*

15
16 **MAJ GEN DEEP AHLAWAT:** The decisions were never taken forward we are out of sheer
17 compulsion that we have to take such decision now.

18
19 **COL S S AHLAWAT:** Therefore this is on us to take [UNCLEAR]

20
21 **MAJ GEN DEEP AHLAWAT:** You should not make mockery of yourself.

22
23 **SECY GEN:** We should come to the point that. There are only two points that have come.
24 This is membership of various clubs and life members

25
26 **COL JAGAT SINGH:** [UNCLEAR] people are asking for the ignorance email, have you
27 flashed that. Do you have that?

28
29 **SECY GEN:** Which ignorance email?

30
31 **COL JAGAT SINGH:** Naik saab asking for the ignorance email. We have another
32 copy...*Aaya hoga*. You want to show what you want to show, *likha hi nahi...*

33
34 **SECY GEN:** *Nahin, nahin* sir...*Mein yeh khatam karne ja raha tha*, then we will start..

- 1 **COL S S AHLAWAT:** Sir. You cannot take any new membership, as of there is a
- 2
- 3 **SECY GEN:** *Aap deal kar lo*, no problem. *Aacha* then there is the election of FEI, Group
- 4 'VIII', Chair there are two contestants Jack Huwang and Abid.
- 5
- 6 **COL JAGAT SINGH:** You should have sent an email to us, to discuss these points...
- 7
- 8 **SECY GEN:** *Aaj yeh[UNCLEAR] jabi mein yeh karonga....*
- 9
- 10 **MAJ GEN DEEP AHLAWAT:** *Batao, chalo batao*. With the permission of the Chair.
- 11
- 12 **SECY GEN:** Both are the members, *yeh jo aaye huain hai*. There is an election in FEI group
- 13 'VIII' chair, *usme hai apna, kya kehte hain, Abid hai* contestant, he is Deputy Secretary
- 14 General of AEF and one is Jack Huang. *Kisko vote dena hai, aap bata de...*
- 15

COL JAGAT SINGH: *Abhi nahin aayi ...*

SECY GEN: *27 July ko aayi thi...*

COL S S AHLAWAT: No Please don’t tell lies. He’s got the email...

MAJ GEN DEEP AHLAWAT: We have that resignation [UNCLEAR] say about 15-20 days

COL JAGAT SINGH: After one month...

COL S S AHLAWAT: One month plus...

SECY GEN: *Maine toh bataya tha.*

30 **SECY GEN:** One person was without three people in my office. I'm not hiding anything, he
31 gave me call he admonished me, I said I apologised to him and I immediately circulated his
32 email.

34 **COL S S AHLAWAT:** You did not circulate the [UNCLEAR].

SECY GEN: I didn't held back, No, Sorry that's the wrong thing, it's just an oversight, when he gave me call, then I got on to it and then I sent to all of you...

31 **COL TARSEM SINGH WARRAICH:** What he's saying that if he has the minutes, then why
32 is he saying that the feature is not there for the AGM, why there is no clarity?

33
34 **SECY GEN:** Sir, the minutes are there...

1
2 **MAJ GEN DEEP AHLAWAT:** Sir, if the minutes are there...

3
4 **COL TARSEM SINGH WARRAICH:** Sir, if the minutes are there and you're getting to
5 know what is happening in the EC, then you are aware of what is happening, so why you made
6 a statement to the EC that athletes are not aware of the happening of the EC. What is
7 happening in EC is on your phone...

8
9 **CHAIR PERSON ATHLETES COMMISSION:** Sir, I'm not [UNCLEAR] I got enquiries
10 from the EC...

11
12 **COL TARSEM SINGH WARRAICH:** No, but why they are not going to the athletes. So the
13 larger platform of the federation...

14
15 **MAJ GEN DEEP AHLAWAT:** You should have shared...

16
17 **SECY GEN:** Let us have the AGM tomorrow, *yeh accounts wali cheeze nahin dalte hain*. Let
18 us clear the other things and we can another AGM after 3-4 months...

19
20 **COL JAGAT SINGH:** You have not submitted the report also....

21
22 **SECY GEN:** There are lot of issues there...

23
24 **COL S S AHLAWAT:** What are the issues?

25
26 **MAJ GEN DEEP AHLAWAT:** Issues *batao kya hain?*

27
28 **COL JAGAT SINGH:** *Batao, aise kaise soch rahe ho?*

29
30 **SECY GEN:** *Sir, mein soch nahin rahan...*

31
32 **MAJ GEN DEEP AHLAWAT:** If we have to decide, listen. If we have to decide whether we
33 go for the AGM or not, let us discuss the agendas now...So you are agreeing to ...
34

1 **SECY GEN:** Sir, the agenda is very simple...the agenda is passing of the previous AGM

2 Minutes

3

4 **COL S S AHLAWAT:** Previous what...

5

6 **SECY GEN:** AGM minutes, *jo routine hoti hai, jo standard procedure...*

7

8 **MAJ GEN DEEP AHLAWAT:** *Woh jo minutes nahin jo [UNCLEAR] mein hai, woh*

9 *minutes toh nahin pass ho rahe...*

10

11 **SECY GEN:** *Nahin... nahin ...jo court main hai...*

12

13 **MAJ GEN DEEP AHLAWAT:** *Jo court mein hai, dekh lena kahin galti se bhi...*

14

15 **SECY GEN:** *Main bata raha hoon, dusra it is station of Asian Games matters,*

16

17 **MAJ GEN DEEP AHLAWAT:** Done....

18

19 **SECY GEN:** Third is *yeh accounts, nahin, nahin,*

20

21 **COL TARSEM SINGH WARRAICH:** What about Asian Matter's, how many are there....

22

23 **SECY GEN:** Six.

24

25 **MAJ GEN DEEP AHLAWAT:** You got this information from out?

26

27 **SECY GEN:** Yes, sir, yes sir... I'm continuing, sir now we come to Agenda, *nahin* Agenda 3,

28 It's my report.

29

30 **COL S S AHLAWAT:** What's your report?

31

32 **COL JAGAT SINGH:** Your report ...?

33

34 **MAJ GEN DEEP AHLAWAT:** Your report you have to put up to us?

35

1 **SECY GEN:** Are sir, EC *niyams se, aam games ke results, yeh, woh... phalana....* Sir, If you
2 want *maine abhi put up nahin kiya...aap bologe toh mein jaa kar karunga...sunoh..* next is let
3 me finish, Agenda No - 4 is audit report of last year *theek hai, nahin karte*, budget report for
4 next year regenerate *nahi karte* and Agenda No -6 is points of minutes...

5
6 **COL S S AHLAWAT:** What about the technical guidelines, the selection criteria and all that
7 will not be discussed.

8
9 **SECY GEN:** That, *agar koi raise karenge toh bolenge.*

10
11 **COL S S AHLAWAT:** [UNCLEAR] point raise *karvayega aap ke point se.*

12
13 **SECY GEN:** *Arrey sir nahin dala*, but going to raise...

14
15 **COL S S AHLAWAT:** *Aur uska answer given that It is with the EC...*

16
17 **SECY GEN:** Sir, *Aap log jawab de dena, Sir honge, aap honge, aap honge, aap jawab de*
18 *dena ...main chup rahunga. Maine thodi na bolna hai.*

19
20 **Dr. SY QURAISHI (OBSERVER):** *Woh Koi raise kar de, toh woh answer is EC has*
21 *decided.*

22
23 **SANJAY GUPTA:** My Lord we'll seek your indulgence, there's something important being
24 discussed here and if anything goes out of this domain, we will request Your Lordship to have
25 to come into the picture.

26
27 **Dr. SY QURAISHI (OBSERVER):** Your Lordship *toh* Chief Justice [UNCLEAR] *yeh toh*
28 British [UNCLEAR], but they are very happy to be called Lordships [UNCLEAR] Lordships
29 *lagega to aap ke khilaaf judgement dena...*

30
31 **SANJAY GUPTA:** *Woh baat hai*, sir, Learned Observer you will have to protect our interests.

32

1 **SECY GEN:** Sir, Agenda No-4 *hata diya*, Agenda No-5 *hata diya*. Mein jo likhunga report,
2 *Kya... yeh hi hai,maine aap ko bata raha hoon. Yeh point hata diya, membership wala, aapne*
3 *mana kar diya na sir, aapne kahan nahin leni..anything you have to say, aapko woh court ka*
4 *order hai. Court ne definitely bola that, but any way, theek hai hata diya.Aur iske alawa kuch*
5 *hai hi nahin.*

6
7 **MAJ GEN DEEP AHLAWAT:** That means accounts are not being...

8
9 **COL S S AHLAWAT:** Only for a certain tenure of the athletes and here's the report, *kya hai*
10 *report main teen char points...*

11
12 **SECY GEN:** *Suno, resigns hai basically, who aapko jate samay de dunga.*

13
14 **COL S S AHLAWAT:** *Acha resigns ho gaya, aur...*

15
16 **SECY GEN:** Aur, I don't remember of the cusp, *yeh jo cheese aap ki mention hai, aur koi bhi*
17 *nahin hai usme. Don't worry.*

18
19 **MAJ GEN DEEP AHLAWAT:** Sir...

20
21 **Dr. SY QURAISHI (OBSERVER):** *Aap ke paas computer hoga, woh AGM mein jo agenda*
22 *items hai, who itna casual nahin ho sakta... Bataye woh kya hai..*

23
24 **SECY GEN:** Sir,[UNCLEAR] *ko bataya tha maine, pehla Agenda that is passing, jo har baar*
25 *ka hota hai,passing of the previous minutes,*

26
27 **Dr. SY QURAISHI (OBSERVER):** *Woh lekin, subject to...jo [UNCLEAR]sir ne*

28
29 **SECY GEN:** *Woh jo inki baat kar rahe hain, who EOGM ki thi sir, pichle saal AGM main jo*
30 *aap ne change kiya.*

31
32 **Dr. SY QURAISHI (OBSERVER):** *Acha woh hai...*

33

1 **SECY GEN:** *Haan. EOGM ki nahi main baat kar raha.* Done. Agenda no-2 is registration of
2 the athletes.

3
4 **Dr. SY QURAISHI (OBSERVER):** Which is the most important thing.

5
6 **SECY GEN:** Yes sir, yes sir.

7
8 **Dr. SY QURAISHI (OBSERVER):** And anyway I would welcome it, at least some happy
9 thing is happening. Everyone is fighting.

10
11 **MAJ GEN DEEP AHLAWAT:** Some positive energy.

12
13 **Dr. SY QURAISHI (OBSERVER):** Some positive energy.

14
15 **SECY GEN:** Sir, Agenda no-3 is my report, which I will send it to you, *yeh events mein yeh*
16 *hua hai, chota mota kuch aur hog,* I say it, but *agar aap kahoge, kuch bologe nahi dalna,*
17 *main nahin dalunga. Usko bhi curtail kar dunga.*

18
19 **Dr. SY QURAISHI (OBSERVER):** *Nahin, nahin Jaiveer, yeh EC mein jo AGM mein, aap*
20 *ki report saamne honi chahiye sab ki.*

21
22 **SECY GEN:** Sir, *pehle kabhi huyi nahin...*[UNCLEAR]It is a biased security call, sir, *main*
23 *bhej dunga.* Point noted sir, point noted.

24
25 **Dr. SY QURAISHI (OBSERVER):** [UNCLEAR]. there can't be no surprises for EC,
26 *suddenly app kuch bol rahe hain, aur suddenly kah diya.*

27
28 **SECY GEN:** *Main bhej dunga.*

29
30 **Dr. SY QURAISHI (OBSERVER):** [UNCLEAR]*aur sham tak inke jo observations hai,*
31 *unko nikal diya jaye.*

32
33 **SECY GEN:** Right. Done, done, sir, done. Now, *usske baad* sir, Agenda No -4-5 out.

34

1 **MAJ GEN DEEP AHLAWAT:** 4-5 which is?

2

3 **SECY GEN:** 4 is Audit Report, 5 is Budget...

4

5 **MAJ GEN DEEP AHLAWAT:** *Theek hai.*

6

7 **SECY GEN:** And 6 is point for members, *yeh bhi aapne kar diya, maine Nasr ko bata dunga,*
8 *tera yeh point turn down gaya EC se.*

9

10 **MAJ GEN DEEP AHLAWAT:** Point kyat ha?

11

12 **SECY GEN:** Okay, okay... Sir, court order *hai ek toh, main laya hoon court order EC ke*
13 *chakar mein, haan sun lo..*

14

15 **MAJ GEN DEEP AHLAWAT:** Warrant *kya hai...*

16

17 **SEC GEN :** *Usne basically nahin diya. It's just a brief..*

18

19 **MAJ GEN DEEP AHLAWAT:** On who? Who was it?

20

21 **SECY GEN:** Sir, he's a guy he got Nasr school in Hyderabad. So they formed a group of 15-20
22 Clubs jo memberships *bechenge, toh pichle saal jab humne AGM karna tha,jo sir ne chair*
23 *kiya tha,9 July ko AGM hua tha,to the 22 ka, aur uske pehle Rajasthan meant AGM nahin*
24 *hona chahiye, Court mein application lagiye.*We had the AGM, *usme 6.2 mein maam ne*
25 *kahan* "This court is therefore of the opinion that Agenda No-5, this pertains to new
26 membership should be deferred awaiting.

27

28 **MAJ GEN DEEP AHLAWAT:** [UNCLEAR] We are under litigation, stay on the new
29 memberships.

30

31 **SECY GEN:** Correct.

32

33 **COL S S AHLAWAT:** You know why, you know why? There are several reasons,

34

1 **SECY GEN:** *Arrey sun toh lo sir, padne toh do, uske baad bol dena, maine aapko galat toh*
2 *nahi bola, apne kahan theek hai, tab hogi baat.*

3
4 **SECY GEN:** *is it therefore directed by Agenda No-5 be defferd in the AGM dated 9 th July*
5 *23.” Theek hai. Iske alava do point’s aur hai, who bhi sir ka ek point hain, ki sir, jab yeh NQ’s*
6 *huwe the, pehle Aryans kehte the, toh hum, aap 10 NQ karo, hum ek Aryan ka incentive dete*
7 *the. [UNCLEAR] Sir, We have discussed.*

8
9 **COL S S AHLAWAT:** *We have discussed that. But, it will come later. It will come,*

10
11 **SECY GEN:** *Theek hai.*

12
13 **COL S S AHLAWAT:** *Once we do all the accounts.*

14
15 **SECY GEN:** *Acha dusra, nahin nahin sir, this is a policy decision, iska accounts se kya lena.*
16 *Aap ek toh keh rahe ho ke paise kam ho rahen hai.*

17
18 **MAJ GEN DEEP AHLAWAT:** *Jaiveer, we are revising not revising exactly, whatever good*
19 *part you are contemplating, we like that, but we want to go through, in manner through the*
20 *technical guidelines.*

21
22 **SECY GEN:** *Sir, woh aap log karte raho.*

23
24 **MAJ GEN DEEP AHLAWAT:** *We want to continue through National qualifier and the*
25 *[UNCLEAR]. Nothing is going to change much, but we must see.*

26
27 **SECY GEN:** *Jaideep sir, baat toh suno aap...*

28
29 **MAJ GEN DEEP AHLAWAT:** *Yeh approve nahin honge sir,*

30
31 **SECY GEN:** *Mein touch nahin kar raha, your approving your words, agar mein touch hi*
32 *nahin kara raha, toh phir usko kaise kahen? Ab meri baat suno dhyan se, Mera, sir kay yeh*

1 *hi sujhaav tha ki hum yeh corpus 50,000 ek baar 10 admi ka karo, lekin ek baar aap ko*
2 *incentive denge 50,000 ka.*

3
4 **MAJ GEN DEEP AHLAWAT:** It's a valid point.

5
6 **SECY GEN:** *Yeh band karo, sir ka point tha yeh, mein nahin keh raha, yeh mera point nahin*
7 *tha.*

8
9 **MAJ GEN DEEP AHLAWAT:** *Ek club ko ek baar*[UNCLEAR].

10
11 **SECY GEN:** *Who toh de rahe hain.*

12
13 **COL S S AHLAWAT:** But every time not giving it[UNCLEAR]

14
15 **SECY GEN:** *Nahin, nahin. Bony sir ek baarke liye aapne mana kiya tha.*

16
17 **MAJ GEN DEEP AHLAWAT:** *Woh galat hai.*

18
19 **MAJ GEN DEEP AHLAWAT:** *Ek baar toh dena chahiye*, you can call that promotion.

20
21 **SECY GEN:** *Nahin, nahin suno.*

22
23 **COL S S AHLAWAT:** Sir, [UNCLEAR]I'm no one to decide, I just gave a point.

24
25 **SECY GEN:** *Dusra* [UNCLEAR]..

26
27 **MAJ GEN DEEP AHLAWAT:** *Ek minute, isko deal karte hain*, it is a general promotion, If
28 *I'm doing three times, I will be given only once.*

29
30 **SECY GEN:** *Bas yeh hi point kaat diya maine, khatam ho gayi baat.* Acha, now Regional
31 *Group ka jo election hai who vote kisko dena hai?*

32
33 **SECY GEN:** Sir *aap de do.*

34
35 **COL TARSEM SINGH WARRAICH:** Who all are there?

SECY GEN: Abid and Jack Huwang.

MAJ GEN DEEP AHLAWAT: We will let you know.

SECY GEN: Certainly. *Acha yeh iska, puri baat nahin huyi thi ki*, incentive for the NQ's 50,000/- one time. *Unlogon ne yehi bola hai, apna yeh hi bola hai* regarding NQ.

COL S S AHLAWAT: *Wahi ... hai.*

SECY GEN: We will continue.

MAJ GEN DEEP AHLAWAT: Only one time?

10 **SECY GEN:** *Done hai, finished. Dusra kuch nahin hai.*
- 11
12 **COL TARSEM SINGH WARRAICH:** *Mail from the [UNCLEAR] association.*
- 13
14 **SECY GEN:** *Konsi? Yehi toh hai?*
- 15
16 **COL TARSEM SINGH WARRAICH:** *And let's discuss this.*
- 17
18 **SECY GEN:** *This I will put it in points under members lounge.*
- 19
20 **LT COL DP NANDA:** *[UNCLEAR] police ke log bhi hai, woh national unka*
21 *[UNCLEAR]national*
- 22
23 **SECY GEN:** *[UNCLEAR] Woh baad mein dekhte hain.*
- 24
25 **SECY GEN:** *No problem.*
- 26
27 *[UNCLEAR]*
- 28
29 **MAJ GEN DEEP AHLAWAT:** *[UNCLEAR] Ki usko baad mein karenge National Games*
30 *wale ko.*
- 31
32 **SECY GEN:** *Sir this is...yeh Punjab ka point.....*
- 33
34 **MAJ GEN DEEP AHLAWAT:** *But, but ek minute, but on that we have to take calls sooner*
35 *or later, because agar karna hai, toh matlab,it is, karne se hume koi threat nahin hai, suno,*

1 *karne se koi threat nahin hai agar karenge toh, magar jis cheez ko kuch.* I don't want to bring
2 out into the forum.

3
4 **SECY GEN:** *Aisi baat nahin hain.*

5
6 **MAJ GEN DEEP AHLAWAT:** But we must promote ek National Game, Khelo India, *mein*
7 **Equestrian** *nahin ho raha.* I met the DG. Sahi, he was asking.

8
9 **SECY GEN:** *Haan woh RVC ke node ke liye paise ke liye gaye*

10

11 **MAJ GEN DEEP AHLAWAT:** *Paise nahin,* he asked me. You have come for money I have
12 come here to give you something back. You have nothing in the SAI, you have no
13 infrastructure, no coaches, *mein toh aapko den aaya hoon, ulta bol ke aay usko.* Toh that time
14 also this point came up, *ke aap log kyun nahin kar rahe,* because it's a promotional incentives
15 *kar ke.*

17 **SECY GEN:** I personally have no problem, *pichli baar yeh decide hua tha, ki usko defer karte*

20 **MAJ GEN DEEP AHLAWAT:** *Ek minute, dekho* National Game [UNCLEAR] *hume* Khelo
21 India *mein pride hai* Sports Ministry *se, theek he, aur usse kisi ko woh nahi hai, matlab* there
22 will be no problem at all.

23

24 **COL JAGAT SINGH:** [UNCLEAR] *games hote hain.*

25

26 **SECY GEN:** School games *hote hain.* School Game Federation *bhi hai.*

27

28 **MAJ GEN DEEP AHLAWAT:** So *aap* National Games, *mein toh paise milte hain.*

29

30 **SECY GEN:** *Yeh point dalna hai ke nahin. Isspe kaam karna hai, point AGM mein nahin*
31 *dalna.*

32

33 **MAJ GEN DEEP AHLAWAT:** *Theek hai.*

- 1
2 **SECY GEN:** *Aap bolo kya karna hai.*
- 3
4 **MAJ GEN DEEP AHLAWAT:** *Batao sir, National Games mein dalna,dalna hai dalo.*
5 Rather than they ask you or they come through some top pressure.
- 6
7 **SECY GEN:** *Pichli baar humne AGM mein put up kiya tha.*
- 8
9 **LT COL DP NANDA:** *AGM mein put up kiya tha, [UNCLEAR], Committee to decide on this.*
10 That's under Khelo India Games.
- 11
12 **SECY GEN:** Under Khelo India National Game, we should go ahead. Mein kal AGM... *mein*
13 *daal raha hoon.*
- 14
15 **LT COL DP NANDA:** Mostly they will try and push it.
- 16
17 **MAJ GEN DEEP AHLAWAT:** *Kyunki*, they are creating infrastructure for police and
18 subsequently avenues will work for them.
- 19
20 **COL S S AHLAWAT:** It's a new infrastructure coming up. Very good.
- 21
22 **MAJ GEN DEEP AHLAWAT:** *Aur bataye* Sir.
- 23
24 **SECY GEN:** Colonel sir.
- 25
26 **COL TARSEM SINGH WARRAICH:** There are four points, first is [UNCLEAR].
- 27
28 **Dr. SY QURAISHI (OBSERVER):** Punjab Federation *ka hai...*
- 29 **SECY GEN: NEC Tent Pegging**
- 30
31 **COL TARSEM SINGH WARRAICH:** [UNCLEAR] earlier there used to be 8 medals for 8
32 events; we have reduced those matters to 6.
- 33
34 **MAJ GEN DEEP AHLAWAT:** Sir, *woh* National [UNCLEAR].
35

1 **SECY GEN:** *Woh sir aap log...*

2
3 **MAJ GEN DEEP AHLAWAT:** I'm just putting this across for him.

4
5 **SECY GEN:** *Haan theek hai.* Now we are deciding *kal yeh points toh* [UNCLEAR].

6
7 **COL TARSEM SINGH WARRAICH:** Just give me two minutes if I'm looking after
8 discipline, then I can
9 manage.

10
11 **SECY GEN:** Granted sir.

12
13 **COL TARSEM SINGH WARRAICH:** So I think we should revert back to the core system
14 of 8 medals for [UNCLEAR]. Than when we go for, there's some change in the International
15 Format of Equines, what my suggestion is, we should follow, in India we should follow our
16 own system for the national's. Where we select any team and we can prepare as per the
17 International Format, till we refrain back to the. So we shouldn't change everything according
18 to the IET, otherwise we will land up like hockey, the Europeans will start getting semi's
19 everything and we will start...

20
21 **SECY GEN:** ITPF Rules not to be followed, that you will decide, with sir. 4

22
23 **COL TARSEM SINGH WARRAICH:** In Nationals we should follow our own rules.

24
25 **SECY GEN:** This ...we will cover in Technical Guidelines.

26
27 **COL TARSEM SINGH WARRAICH:** The second was the issue of membership of the states
28 which were **increased** from 8,000 to 30,000.

29
30 **SECY GEN:** Increased.

31
32 **COL TARSEM SINGH WARRAICH:** Increased

33
34 **SECY GEN:** *Paise kam hai Federation ke paas.*

1
2 **COL TARSEM SINGH WARRAICH:** No, no, let's not.

3
4 **SECY GEN:** I'm just saying that this is done as per the General Body we have to take it to the
5 GENERAL BODY.

6
7 **COL TARSEM SINGH WARRAICH:** We have discussed the point in the last EC also.

8
9 **SECY GEN:** I know that but this is approved by the General Body. We have to take it to the
10 General Body.

11
12 **COL TARSEM SINGH WARRAICH:** And same is for the Individual Memberships. Than
13 ITPF guidelines.

14
15 **SECY GEN :** Individual membership? It's Rs.1000 each.

16
17 **COL TARSEM SINGH WARRAICH:** Yes want to reduce it from 1,000 to 3,000.

18
19 **SECY GEN:** You mean from 3 to 1.

20
21 **COL TARSEM SINGH WARRAICH:** 3 to 1.

22
23 **SECY GEN:** And the states, I'll put this point to the members that we can reconsider from 32
24 to whatever fixed.

25
26 **MAJ GEN DEEP AHLAWAT:** They have no source of income, if we decrease by 50% and
27 just inform the AGM tomorrow, some positive points we should take away. We should tell
28 them we are taking. *Kya burai hai usme?. Joh kaho dimag khol dete hain, 500*
29 *Euro.[UNCLEAR].*

30
31 **SECY GEN:** That is a very old this thing. We revived it after 2017.

32
33 **MAJ GEN DEEP AHLAWAT:** *Yeh cheez kisne...*

34
35 **SECY GEN:** 250 Euros fixed *hua tha 2007 mein. Pichle saal yeh baat hua tha.*

COL JAGAT SINGH: [UNCLEAR] *mere time mein...*

MAJ GEN DEEP AHLAWAT: That should come down, and why are we charging in dollars in India, why not in rupees *yaar*.

SECY GEN: Deep sir, *woh convert rupee mein hi hoga*.

MAJ GEN DEEP AHLAWAT: *Toh aap usko dollar kyun bolte ho, rupees bolo yaar. Why dollar?*

SECY GEN: 98-99 % paise western *desh country se aata hai, woh bhi club se aata hai*.

20 **MAJ GEN DEEP AHLAWAT:** Okay this is in regarding mandatory registration of
21 **riders** in registered club, is still going on. *Jo pichli baar humne waive off karat tha.*

22
23 **SECY GEN:** *Dono systems aap ne bola tha. Jab who bhi chale gaye [UNCLEAR] Maine roka*
24 *nahin.*

25
26 **MAJ GEN DEEP AHLAWAT:** *Abhi bhi de rahe hain...*

27
28 **SECY GEN:** *Kya.*

29
30 **MAJ GEN DEEP AHLAWAT:** [UNCLEAR]

31
32 **COL JAGAT SINGH:** [UNCLEAR] *kyun nahin rok.*

1 **SECY GEN:** *Sir, yeh bada sensitive sa subject hai [UNCLEAR] north wale bolenge central*
2 *wale [UNCLEAR] abhi ek system chal raha hai wohi chalne do...[UNCLEAR].*

3
4 **MAJ GEN DEEP AHLAWAT:** *dono system challenge...aap woh...*

5
6 **SECY GEN:** *Sir, aap sab ne jo bola tha wahi chal raha hai.*

7
8 **MAJ GEN DEEP AHLAWAT:** *Forensic audit, Are we going for forensic audit or not.*

9
10 **COL JAGAT SINGH:** *We will see.*

11
12 **MAJ GEN DEEP AHLAWAT:** *Who will identify the firm, it should get proper tender,*
13 *because the funds are not much we must negotiate and settle with the [UNCLEAR].*

14
15 **SANJAY GUPTA:** *Usko EC members mein se kisi ko committee bana do.uski committee*
16 *bana do*

17
18 **MAJ GEN DEEP AHLAWAT:** *Jaiveer, General Thakur's resignation was accepted. But it*
19 *as handled by you, you know that he was there for almost 20-25 years.*

20
21 **SECY GEN:** *27th July ko he was there [UNCLEAR]*

22
23 **MAJ GEN DEEP AHLAWAT:** *[UNCLEAR] bol dena usko...*

24
25 **SECY GEN:** *Bol diya usko.*

26
27 **MAJ GEN DEEP AHLAWAT:** *Bas theek hai, Iske aage kuch discuss nahin karenge,*
28 *National Games we are going ahead. Thats all.*

29
30 **SANJAY GUPTA:** *Ek Equestrian Federation ko green signal dhi jaye [UNCLEAR] set diya*
31 *jaye.*

32
33 **COL JAGAT SINGH:** *But the EC has to understand the whole case first.*

34 **(Not clear Mix Voices)**

1
2 **SANJAY GUPTA:** Salman *hai*, Salman is a very good person

3
4 **MAJ GEN DEEP AHLAWAT:** [UNCLEAR] let us watch.

5
6 **COL JAGAT SINGH:** Already 16th we have a case. *Kya hua* sir.

7
8 **LT COL DP NANDA :** [UNCLEAR] in the AGM people will be coming they are trying to open
9 new club in, their own state also.

10
11 **MAJ GEN DEEP AHLAWAT:** *Sun Nanda*

12
13 **LT COL DP NANDA:** I have requested Sir, I'm requesting because court order is going on
14 with the Rajasthan Association. But all of EC is, can we anywhere take out a roadway, when
15 this [UNCLEAR]

16
17 **COL S S AHLAWAT:** The issue is...ek second I know what he's saying. The issue is when you
18 are giving memberships to your clubs [UNCLEAR] voting pattern so that is what is
19 [UNCLEAR].

20
21 **SECY GEN:** We will take that on a war footing. *Suno suno* sir, *Deep sir what he's written is,*
22 *ki aap humko provisional membership de do, sir suno,* but our right to vote in the election
23 will be subject to the outcome of the Writ Petition.

24
25 **MAJ GEN DEEP AHLAWAT:** that matter is *subjudice*. There is no provision of provisional
26 membership.

27 **SECY GEN:** *Sir, aap bol rahe the, Learned Observer ko leke, woh pichle AGM ke liye tha,*
28 *waise hi yeh bhi jo order hai pichle AGM mein lena tha.*[UNCLEAR].

29
30 **COL S S AHLAWAT:** [UNCLEAR] Sir and all jab *uspe* discussion hua tha, than it went to
31 [UNCLEAR]

SECY GEN: The court is therefore of the opinion that [UNCLEAR] should be differed to [UNCLEAR] It has also directed the Agenda No-5 at the AGM dated 9th July.”

COL S S AHLAWAT: We are not touching it.

MAJ GEN DEEP AHLAWAT: *Ek baar court ko observe kar le, let us first time it is, waise baat hai.*

LT COL DP NANDA: I am requesting Committee can [UNCLEAR]

COL S S AHLAWAT: Don't go unnecessarily.....

Dr. SY QURAISHI (OBSERVER): And finally Sports Code *mein aapko* [UNCLEAR] *di gayi hai, jo uspe koi, us kami ko pura karne ke leye kya karna hota hai* and wait a minute, let me tell you overall *ek baar court apko*[UNCLEAR] *kyonki aap otherwise unlimited period ke liye chalte rahenge, uss assumption ko Rahul Mehra is fighting to the hilt. MAJ GEN DEEP AHLAWAT: last EC it was discussed, we put up a draft roadmap and we will honour this, discussion so that was decided last time.

SECY GEN: *I'm so sorry sir, Sir, aap ka point valid hai abhi jo hamari submissions ko election exemption petitions jo chalti hain aur unki teen din khtam ho gayi, aur Rahul Mehra ne wahan pe 8691 Writ petition sarkar file ki thi in the year 2020 main. Usme every fortnight hume uske chalte appendix K or L dena hai to maine apne appendix K aur L we are presenting in the court, after this exemption we are in complete compliance of the Sports Code , kaunsi usme 25 point hai, hare k cheez humne apne statutes mein dali hai, aap bhi the, sab the...Jagat sir ki presence me hum ne kiya tha*

Dr. SY QURAISHI (OBSERVER): Jo exemption usko bhi tukhraya gaya phir [UNCLEAR].

1 **SECY GEN:** *after his exemption[UNCLEAR] uske elava.*

2 **(Unclear Mix voices)**

3 **Dr. SY QURAISHI (OBSERVER):** *Rahul Mehra se meri baat hoti hain, he's my lawyer. By*
4 *the way he's challenged main Sarkar ko aur Ministry ko bakshne wala nahin hoon aur court*
5 *bhi isme will come down heavily ke, yeh exemption kya matlab hai. Yeh char panch logon ne*
6 *yeh exemption [UNCLEAR] all this will not work.*

7
8 **SECY GEN:** *Jo unhone kahan hai uske elava humne...*

9
10 **Dr. SY QURAISHI (OBSERVER):** *you are soon going to loose either him, toh iske liye*
11 *tayari kar le kea age ki compliance kya hai.*

12
13 **COL S S AHLAWAT:** *I have attended since I am Delhi based, I've attended all the hearings*
14 *and the last hearing he said was wonderful I mean he just started from how it happened in*
15 *1975 and then he said in short in line he said it that the Sports Code has to be followed.*

16
17 **Dr. SY QURAISHI (OBSERVER):** *Correct. He's my boy, he's a kid. [UNCLEAR] Supreme*
18 *Court ke order, main in logon Justice [UNCLEAR] former India Goal Keeper, unhone*
19 *constitution banaya tha, which is pending[UNCLEAR] baad mein Supreme Court ne uske*
20 *sare [UNCLEAR] we cannot go back on the Constitution **which I** drafted. [UNCLEAR] hume*
21 *use. [UNCLEAR]Supreme Court chief justice ko time nahin mil rahe [UNCLEAR]......*

22
23 **COL JAGAT SINGH:** *With your permission sir he's got lot of work...*

24
25 **SECY GEN:** *Mere pe dal do, mere pe dal do. Aap gum gham ke kaho jaldi karo, khana khaye*
26 *aur bhage..[UNCLEAR]*

27
28 **Dr. SY QURAISHI (OBSERVER):** *Main bata du bhaiya, main aapke saath lunch loonga*
29 *toh uska kitne paise dene padenge...[UNCLEAR]*

30
31 **MAJ GEN DEEP AHLAWAT:** *What are the problems in giving registration [UNCLEAR]?*

32

1 **COL JAIVEER SINGH:** *Sir, baat kare*

2
3 **MAJ GEN DEEP AHLAWAT:** *Kuch major issues hai?*

4
5 **SECY GEN:** *No sir, humne apne jo rules banaye hai, main samjha dunga, you have to spend*
6 *some time, aap wapas aao I'll show you everything.*

7
8 **COL TARSEM SINGH WARRAICH:** One other thing, Sir in ITPF competitions, that this
9 is competition, here in India we don't allow Tent Peggers to wear turbans.....

10
11 **Dr. SY QURAISHI (OBSERVER):** Why?

12
13 **COL TARSEM SINGH WARRAICH:** I don't know some people taken decision some time
14 back. I think for 10th time we can waive it off that.

15
16 **COL S S AHLAWAT:** Sir, because if you have been recognised by the world body, you had
17 to have safety gear.

18
19 **SECY GEN:** Turban thing they will not allow, no one is giving, even the ITPF said no
20 *[UNCLEAR]*

21
22 **COL TARSEM SINGH WARRAICH:** ITPF also said no... ITPF is holding competitions
23 with the ..

24
25 **SECY GEN:** *[UNCLEAR].....*

26
27 **COL S S AHLAWAT:** If they *[UNCLEAR]* the world body, they have to follow the
28 *[UNCLEAR]* ITPI, I'm talking about the ITPF.

29
30 **COL TARSEM SINGH WARRAICH:** ITPF doesn't want.

31
32 **MAJ GEN DEEP AHLAWAT:** Sit, he has lot of work,

33
34 **SECY GEN:** *[UNCLEAR] mere pe dal do sab, Vote of thanks.*
