1. **General**: - **EFI Dressage CDN** will be held with effect from **06<sup>th</sup> January 2025 to 09<sup>th</sup> January 2025** at Modi Equestrian Academy, Meerut under the aegis of EFI as per Technical Guidelines-2024, FEI's relevant rules & regulations. All participants are advised to go through the latest EFI's Technical Guidelines-2024, FEI rules, regulations and specifications, before the event, irrespective of the extract reproduced in this prospectus.
2. **Tentative Schedule**. Attached as **Appx 'A'**.
3. **Eligibility for Participation in Events** Horse and Rider to be a member of club/institution affiliated with EFI and or the Rider can be an Individual or Life member of EFI. Riders from any club registered with EFI can ride any horse of any other club provided that both the clubs are registered with EFI.
4. **Entry(s)**.
  - (a) Entry(s) must be sent to the EFI only by the registered club/institution member of which the respective rider is a member on prescribed entry form attachment as Appx D & E, along with fee deposition slip. The horse can be of same or different registered club/ institution member of EFI. The entry(s) will be forwarded to EFI by the club/institution member of the participating rider.
  - (b) A life/individual member of EFI can send their own entry(s) or of their dependent children upto the age of 21 years directly to EFI on the prescribed entry form attachment as **Appx D & E** along with fee deposition slip.
  - (c) All entry(s) must have EFI horse passport number, EFI registration number and name of the horse as well as rider's EFI I.D which should all be valid.
  - (d) No Entry will be accepted without the prescribed fee.
  - (e) In U-21 categories a rider can take part on any number of horses. In addition one rider can choose one senior category on the same/ different horse.
  - (f) A rider in senior category can choose any one category of their choice plus one higher category in the CDN. There is no limit on the number of horses a rider can complete in the various classes on CDN.
  - (g) Horses participating in CDI cannot participate in the CDN.
  - (h) Horses ridden by U21 categories can be ridden by seniors.
  - (j) A horse can only be ridden by one senior rider in any one senior grade + one grade. Refer to Art 3.1.
5. **Entry Fee**. The Entry fee will be as under: -

**Note:- Change of Horse Rider Combination** There will be no substitution of either the horse or rider post expiry of cut of date & time of late entry as stipulated in para 6 for both individual/team. However, a horse may be changed with prior approval of EFI on Veterinary Grounds in case the vet officials at the CDN- Dressage venue diagnose and issue a certificate (to be forwarded to EFI along with an application by the Club/Institution/Individual/Life member who had submitted the entry requesting substitution through Show Secy, of the OC for approval of EFI within a time gap of one hour of the vet inspection). Other than this no other reason will be entertained.

7. **Withdrawal of Entries** Any entry can be withdrawn by 23:59hrs, 03 January 2025 without attracting any loss of fee. No refund of fee will be allowed for entries withdrawn after cutoff date unless it must be withdrawn on Veterinary grounds and in such cases, a certificate from the Veterinary Officer will be required.
8. **Instructions for Entries**. No HC entry is permitted in CDN Dressage.
9. **Payment**. Entries must be paid through Bank transfer. Bank details for electronic payment are as under:

10. **Participation List of Individual**

(a) The Federation will forward to the OC a list of Horse Rider combinations based on entries in individual category received prior to horse inspection fixed on the date mentioned in the competition schedule pertaining to eligible combinations to participate in various categories as per their grading.

(b) The OC will thereafter arrange their horse inspection as per the schedule of Events attached as Appx A (1+4 days).

(c) Post horse inspection the OC will carry out draw of lots of horse found fit and prepare a start order of various competitions and publish the same through all available means of communication for info of all participating riders/stakeholders.



## 11. **REGISTRATION OF HORSES WITH EFI**

(a) All horses participating in the EFI approved events must be in possession of the EFI passport. No entry will be accepted without EFI Registration number. For further information pertaining to registration, contact EFI. Please register the horses participating in the event with the EFI prior to the event through respective club/individual/life/ institution members as applicable.

(b) Team captains are requested to ensure that their horses are all registered before entries for the Event. The registration number must be filled in the entry form as per EFI ruling.

(c) Entries will not be accepted without EFI registration number.

## 12. **EFI Rider Registration.**

(a) As per EFI rules all Riders, participating in the EFI must be registered with the EFI.

(b) Entries will not be accepted without **Valid** EFI registration number.

(c) Participating rider can be a life/ individual member of EFI and or he/her can be a member of registered club/institution of EFI. The same shall be checked by EFI and such cases will not be permitted to participate.

## 13. **Eligibility of Horses.** Riders are responsible for correct entry of his/her horse in relevant rules of EFI. **Riders are liable to be disqualified or penalized for incorrect entry of the horses, as per EFI regulations.**

## 14. **Technical Specifications.** As per EFI/ FEI Rules.

## 15. **Withdrawal, Change, Transfer or Substitutions of Entry.**

**Change of Riders.** Riders cannot be changed unless the Jury in consultation with EFI accepts that there are sufficient reasons for change of rider. All changes will be treated as Fresh Entries. Once an event has started, no change in rider / horse will be accepted.

## 16. **Reporting for Each Class.** All horses will report to the collecting ring Steward half an hour before the time of judging of the class. Any entry not reporting in time will be eliminated unless the exhibitor shows good cause for the delay. The Ring Steward has full authority to take disciplinary action.

## 17. **Abuse/ Cruelty to horses.** - As per relevant rules of EFI.

## 18. **Medals** Medals in each class will be presented only if there are four riders/ four team or more participants or else only rosettes will be presented.

## 19. **Rosettes.** - A horse will wear no rosettes during judging.

20. **Cancellation**- The Organizing Committee may cancel any class which has less than four entries or for any reason at their discretion. In that case, the entry fee will be refunded. However, the events where MER for NEC is involved is involved, those events will be held irrespective of number of entries.
21. **EFI's Code of Conduct**: - Any untoward altercation with Jury/Official/OC by the PR will result in Elimination/Disqualification of the rider and horse.
22. **Whips/spurs/Tack**. As per EFI rules of the discipline.
23. **Dress code**. When presenting a horse for vet inspection, rider should be attired in proper riding dress with boots on. Service personnel will be in uniform. It is compulsory for anyone riding a horse to wear a properly fastened hard hat with three-point retention harness. Dress Code for competition will be as per FEI Guidelines.
24. **Camping & Accommodation**
- (a) Venue & stabling will be open on 04<sup>th</sup> January 2025 and close on 10<sup>th</sup> January 2025.
  - (b) All teams should come fully equipped with their own tent age for stabling and enough grain and fodder for the duration of the show.
  - (c) The Organizers will try to arrange for bedding straw and fodder to be made available for sale at retail prices.
  - (d) All teams that require stables must send their requirements on or before 25<sup>th</sup> December 2024 after which no stable orders will be accepted.
  - (e) Camp fee will be charged by the OC as per following: -
    - (i) If the OC provides an area wherein the participants will build their own temporary shed, charges levied will be Rs 500/- per horse to take care of electricity, water, and cleaning charges thereof.
    - OR
    - (ii) Temp. stables @ Rs 2500/- per stable.
  - (f) The OC will always ensure the safety and security of the camp to avoid any mishap.
  - (g) All teams must inform the organizers of their total strength (personnel and animals) by the 25<sup>th</sup> December 2024, so that camp site so appropriate size can be allocated for all teams, both civilian and government.
  - (h) All teams must inform the organizers of the estimated time of arrival well in advance.
  - (j) All Army and Government units will be provided space to set up their own camps. All tent age and other stabling material to be brought by them.

- (k) The organizers will provide one bulb and electrical connection for a fan. Fans to be brought by participants. Option to buy fans are given in contacts list in the end.
- (l) All bio-degradable waste including horse dung is to be put in to the pits provided.
- (m) No open fires are permitted on Modi Equestrian Academy, Meerut grounds.
- (n) Riding charges for practice riding in all other grounds is free.

25. **Venue.** The event will be held at Modi Equestrian Academy, Meerut.

(Note: The camp will be open wef 03<sup>rd</sup> January 2025 and close on 10<sup>th</sup> January 2025.

26. **Self-containment.** In addition to the above all teams must be self-contained in terms of tentage, equipment for camping and transport to be prepared for any unforeseen emergency.

27. **Accommodation.** All Participants are required to make arrangement for their accommodation. In Case any assistance is required you may contact Organizing committee member on mobile phone No **+9199667746761**.

28. **Ration /Fodder:** - All teams should bring their own feed, hay, bedding, grass, etc. for their horses and should make their own provision for staff food. Modi Equestrian Academy, Meerut will not provide any assistance for the above unless special facilities are being provided for all teams.

29. **Coggin's and Glanders Test: Medical Protocol requirements for all horses to be Camp at Modi Equestrian Academy, Meerut Premises.** Every horse should be accompanied by the following valid Veterinary Documents: -

- (a) Identification Certificate or Passport along with vaccination record.
- (b) All rules and instructions issued from the EFI and Remount Veterinary Directorate, Army Headquarters on the subject will be strictly adhered to by all concerned. All horses must produce a valid negative EIA and Glander status (CFT or Mallein) certificate on arrival in Modi Equestrian Academy Main Gate. Coggins and glanders negative certificate with a validity of a minimum of 15 days on arrival and exit of horses from the camp is mandatory, (Glanders validity 30 days, EIA validity 120 days).
- (c) Every horse must be duly vaccinated with the Cal vanza /innovator fluvac innovator vaccine. For horses who are being vaccinated for the 1st time, 3 dosages for Clavanza and 2 dosages for fluvac with a gap of 21 days between each dose is required. Horses already vaccinated will require an annual booster dose.
- (d) Proof of Pneumobort – K Vaccination (only for horses coming from within Maharashtra itself) Those horses got fluvac innovator vaccine do not require pneumobort.
- (e) Health Certificate of the horse (Authorized Vets for Certifying: State Veterinary Officer active, Army Veterinary Office active.

(f) Declaration Letter from the owner (on his letterhead) stating where the horse was stabled in the last 60 days before proposed entry into Modi Equestrian Academy, Meerut.

30. **Veterinary commission** The Veterinary Commission detailed by Equestrian Federation of India will have the right to examine all the horses participating. Also, they will provide all vet related assistance to all horses as required.
31. **Farrier** - All teams and riders are responsible to arrange their own farrier.
32. **Medical cover.** The organizing committee shall not accept any liability for medical treatment given to a competitor on the venue or the consequences thereof. Each rider participating in the CDN- Dressage will fill the Indemnity Bond attached and submit the same along with entry form.
33. **Insurance.** The organizing committee recommends riders/club/associations to take insurance policies for competitors, personnel, grooms and horses for their transportation to Modi Equestrian Academy, Meerut and during the conduct of the events. The organizing committee will assume no responsibility for any accident or illness due to fall of any horse, competitors, groom/ any other member of the team.
34. **Responsibility.** The organizing committee accepts no responsibility for any loss, damage or injury to any animal or any other property or the exhibitors themselves.
35. **Judging.** Decision of the ground jury will be final unless, altered on appeal under rules.
36. **Appeal.** Appeal can be lodged by competitors as per FEI GR 161. A fee equivalent to 150 CHF in Indian currency should be deposited with the Show Secretary, Organizing Committee, Modi Equestrian Academy, Meerut along with the objection. Money will be refunded if the objection is upheld.
37. **Compliance of NADA Rules and FEI Equine Anti-Doping and Controlled Medication Regulation (EADCM).** As per the rules in vogue, each participant (both human and equine) liable for screening for doping at FEI approved events. In view of the above, athlete if approached by NADA to give sample for dope testing are mandatorily required to comply with the same. Any refusal may result in disqualification of the athlete.
38. **Clearance Certificate.** Horse owners are required to obtain clearance certificate from the OC during working hours. All concerned accounts need to be cleared before they can obtain the same. No horses/ Person will be allowed to leave by the Camp In-charge without the clearance certificate.

39. **Clarification/direction from FEI.** Issues not covered in prospectus/FEI-Technical Guidelines-2024 should be referred to FEI through OC for deliberation based on which an informed decision will be promulgated which will be binding on all parties.

**DECLARATION (INDEMNITY BOND)**

1. I, \_\_\_\_\_ resident of \_\_\_\_\_ desirous to participate in the CDN, Dressage events at Modi Equestrian Academy, Meerut hereby undertake and agree: -
- (a) That horse riding and all equestrian sports are inherently unpredictable and potentially dangerous.
  - (b) That only some basic provisions for medical treatment are made at the event venue and I am responsible for my safety equipment.
  - (c) That the Modi Equestrian Academy, Meerut has various unsupervised areas that may be generally risky.
