1. Further to this NF Email dated 05 August 2025.
2. It is submitted that Extra Ordinary General Assembly (EOGA) notice promulgated on 02 August 2025 based on EFI Statutes, EFI Rules & Regulations and same forwarded to you on 04 August 2025.
3. The Background stands as follows :-
 - (a) Dr S. Y. Quraishi, the Learned Observer appointed by Hon'ble High Court of Delhi had filed a status report in WP(C) 10342/2019 dated 17 July 2025.
 - (b) The holding of EOGA was requisitioned by members as per their rights and privileges stated at Para 2 Article 12 Chapter 3 of EFI statutes to discuss this report and other matters of the Federation.
 - (c) The undersigned only acted upon the directions of the members in terms of stipulated provisions of EFI Statutes stated above by promulgation of the notice.
 - (d) If seen carefully the agenda points stated in the EOGA notice are primarily the burning issues which need immediate decision by the General Body being the controlling authority of the federation in terms of para 2 article 08 Chapter 3 of EFI.
4. The EOGA is not a tool of any individual but the demand of the primary stakeholders. The Executive Committee (EC) are only Executive but not Stakeholders as in any Sports Federation.
5. The EOGA will be held in presence of Dr S. Y. Quraishi, the Learned Observer appointed by Hon'ble High Court of Delhi.
6. The matter stands clarified.
