POINTS	DECISIONS / DIRECTIONS
SECY GEN: Aaj ke iss 62nd AGM main aap sabka swagat hai Federation ke behalf pe. Pehle ye decide hua tha ki ye 2023 and 24 ka hoga phir ye kal decide hua ki ye sirf 2023 ka hoga ek saal ka aur 24 ka kuch mahine ke baad karenge. Mujhko kai members ne bataya ki General body ka ye status batayein ki kya hota hai? Toh Article VIII [UNCLEAR 06:22] yehi kehta hai General Body is stationed under statues as the Supreme Authority of the EFI aur dusra General Assembly shall be the controlling body of the Federation on the authority listed in it and decision of the same thing shall be binding on all the members. Main ye kehna chahunga, I have taken permission of the Observer. [UNCLEAR 07:51-08:06] (CROSS TALK AMONG MANY SPEAKERS) LT COL SANDEEP DEWAN: He is the president. LT GENERAL MKS YADAV: He is president alright. Unclear – Mixed voices LT GENERAL MKS YADAV: With permission of the Honourable Observer. Hold on one moment. Let me speak. Permission of the observer. He's president all right, but there's an observer. COL R PATTU: He is not an administrator. LT COL SANDEEP DEWAN: You cannot hijack the meeting.

LT GENERAL MKS YADAV: Main house se poochna chahunga (A vote of members present was called for and it took place through show of hands) COL R PATTU: This is absolutely pathetic LT COL Sandeep DEWAN: In the EC yesterday it was decided that the President is Col Jagat. LT GEN MKS YADAV: No LT COL SANDEEP DEWAN: How can you say? LT GENERAL MKS YADAV: No LT GENERAL MKS YADAV: The house has to agree..... AGM is the final authority. AGM is the Supreme body and the AGM has decided.	The house passed the resolution tabled by the Lt Gen MKS Yadav through a vote of majority Wherein Dr. SY Quraishi the Learned Observer appointed by Hon'ble High Court of Delhi was asked to chair the AGM and Mr Harish Khokhar VP (Fin) is nominated as acting President.

LT GENERAL MKS YADAV: You people are no one. [UNCLEAR 09:41-10:56](CROSS TALK AMONG MANY SPEAKERS) LT COL SANDEEP DEWAN: Large number of discrepancies have been found in the accounts. MAJ GEN SAMEER LANBA: When your turn comes please get up and speak. MR RS DUNDLOD: What happened to his turn? MAJ GEN SAMEER LANBA: You cannot do this. You cannot. (NOT AUDIBLE -MIX VOICES) MAJ GEN SAMEER LANBA: The issue is of the President.

The accounts in great detail were brought forward by me. I had written two emails about the accounts when I brought out how there's been.... SECY GEN: Sir, this is out of context. This is out of context. Let the AGM start first. This is out of context. He was invited. I was not aware. I'm the secretary general. I am not aware. This is out of context. He cannot speak. Please house bole. Yeh nahin bol sakte, ye galat hai iss meeting main. LT COL SANDEEP DEWAN: I hope the house is aware that the person who is the Secretary General has a section 340 CRPC complaint against him and he's got a criminal offence against him. Can such a person[UNCLEAR 13:41-14:10] The Chairperson Athletes Commission asked for the mike. VICE CHAIRPERSON ATHLETES COMMISSION: Sir, I am Major Ritika Dhaiya. I am Vice Chairperson Athletes Commission. Abhi forgery, criminal case wali baatein chal rahi hai subah hi mere paas ek FIR aayi hai sir and some girls have handed it over to me sir and it says that one of the EC members was involved in a case where molestation took place for girls. I think vo is case, is forum ka part nahin ho sakte hain till the time vo case chal raha hai because girls are not feeling safe. And if such case is going on, he cannot be the part sir. If he is proven not guilty toh he will continue. (copy attch as appx A) Lt COL SANDEEP DEWAN: Good point. Then both should be removed. LT COL SANDEEP DEWAN: He is an observer. He's supposed to observe. He cannot take over a meeting. That's very clear. He cannot chair a meeting. That is what the honourable High Court's orders also say. LT GENERAL MKS YADAV: No, Honourable High Court has decided that that crucial meeting on the 7th July 2023 would be chaired by the observer. LT COL SANDEEP DEWAN: No, it is. LT GENERAL MKS YADAV: It should be chaired by him. LT COL SANDEEP DEWAN: Of course not. The court orders don't say anything of the sort. MR RS DUNDLOD: Sir, I may remind you that order also says that if the observer is not happy with the situation or it's observing something which is not correct. He has to bring it to the notice of the court. So what is happening here if it's not correct. Let us resolve this and bring to the court and take a decision from the court. COL R PATTU: Let's cancel the meeting sir. Let's move to the court. MR RS DUNDLOD: It says so let the observer... COL R PATTU: Let this meeting be cancelled and let's move to the court. LT COL SANDEEP DEWAN: Let's go to the court. MR RS DUNDLOD: Agar ye koi sawal uthate hain Uska jawab hum bhi denge na. Ye jo bol rahe hain uska jawab de rahe hain hum. [UNCLEAR 17:47-18:41](too many speakers) LT COL KD MALIK Voting karao sir. We will vote for president. If you allow sir either you chair the meeting or we wait for the... (MIXED VOICES) LT COL SANDEEP DEWAN: Yes, yesterday we brought out in the meeting that a forensic audit has to be conducted which is decided yesterday. They are trying to avoid this forensic audit. We being an athlete, you have played. You being the EC member... LT COL SANEEP DEWAN: I am not a EC member MAJ ABHISHEK SINGH: Just listen to me once. We being there we wait for this meeting. Because the way federation is going because of you all fighting together. We are practising hard [UNCLEAR] Somebody is saying cancel the meeting doesn't make any sense. [UNCLEAR:20:56-21:05] LT COL KD MALIK: Sir the basic building block is the athlete sir. Athlete hai toh ye sab kuch hai sir. Athlete ki toh koi sun hi nahin raha [UNCLEAR:21:15-21:32] LT COL KD MALIK: Athletes ki koi sun hi nahi raha COL R PATTU: Sir, you are just a member like me. Who are you sir? I'll read out. Hereafter the President and vice president admin have tendered the resignation. However Lt. Gen SS Mishra and Lt. Gen MKS Yadav have been appointed as temporary President and Vice President. Keep quiet. SECY GEN: You can't tell me to keep quite. I'm being decent. Keep quiet. LT GEN MKS YADAV: What he is saying is absolutely right. I earned the rank of Lt. Gen by working hard. I have been the member for 22 years. Yes, the court removed you. Usne mujhe koi takleef nahee hai. but I was not made because of anything else. Ise kya fakrak pada. I continue to be a member.

SECY GEN: So we will break off for five minutes please. The House took a 5 minutes break. After break the House reassembled and meeting restarted. Let's not interrupt. <u>Sir, as per the High Court order the ambit of the EC was limited to compete in Olympics. This reinstated the EC is not a newly elected body rather an interim arrangement. Hence they don't have the same power as the regular elected EC. Post High Court order all decisions taken by EC should be put to the AGM for discussions and to be implemented only if approved.</u> DR SANJAY GUPTA: Please put this in the court of law not put it here. How can you interpret the order? (Heated arguments between Mr JS Toor supported by Chairperson Athletes Commission with Sanjay Gupta as Sanjay Gupta was interfering and preventing Mr Toor to speak.)

MR JS Toor: <u>Some of the EC members have conflict of interest because they are a part of the litigation in Rajasthan versus EFI. They can't be involved in any committee which deals with the litigation on exemption cases and also on other cases that have themselves standing against the EFI. No over arching decisions that impact the sport can be taken under the limited mandate. All decisions taken by the EC during this meeting on July 12th and August 17th other than related with Olympics to be set aside and expunged from the EFI records. No subcommittee can be formed at this stage.</u> LT COL SANDEEP DEWAN: Which court order says this sir? MR JS TOOR: Sir, the house is supreme. The house is supreme. Let the house answer that. You can't have a bunch of people..... MR RS DUNDLOD: The court is supreme. House is not higher than the court. MR JS TOOR: House is supreme. What will the court say? What has the house said? Because of the trauma that we went through as a whole contingent because our federation did not have our back. The whole federation means not the people who were in the seat but everybody constitutes the federation. They did not want to put their squabbles on the side and put their best foot forward to send the people forward. It is a pitiable state of affairs. Today we are here. We are here for our felicitation. We have been called for our felicitation. And people cannot stop squabbling over. There is a procedure. If you have a problem with anything that is done. There is a court of law. You cannot say today that you cannot go to a court of law. Everything that happens in this federation is before court. Everything is in the newspapers. There is enough bad infamy that this federation has drawn in the last two years. Every third day there is something in the press. So nobody should hide behind this excuse that we will not go to court or we will not have a police complaint. Or we will not do this because it will defame our federation. The federation can withstand being defamed. It will stand tall. We are all athletes are here we will make sure that this federation prospers.
